3 PERSONNEL MATTER - Don Taute, Personnel Director; Mike Thew, Chief Deputy County Attorney; Ron Fetters, Lancaster Manor Administrator

**MOTION:** Heier moved and Schorr seconded to enter Executive Session at 7:36 a.m. for discussion of a personnel matter. Schorr, Stevens, Workman and Heier voted aye. Motion carried.

Schorr exited the meeting.

**MOTION:** Stevens moved and Heier seconded to exit Executive Session at 7:52 a.m. Stevens, Workman and Heier voted aye. Schorr was absent from voting. Motion carried.

Schorr returned to the meeting at 7:53 a.m.

#### ADMINISTRATION OFFICER REPORT

A. Crime Commission Juvenile Enhancement Grant

Gwen Thorpe, Deputy Chief Administrative Officer, said the County applied for \$100,000 and was awarded \$28,000 instead. She said the budget will need to be adjusted to reflect the new amount (Exhibit B).

**MOTION:** Stevens moved and Heier seconded to authorize the Chair's signature on the revised budget summary. Schorr, Stevens, Workman and Heier voted aye. Motion carried.

#### **RETURNING TO ITEM 3**

Workman said Ron Fetters, Lancaster Manor Administrator, has submitted his resignation, effective November 30, 2008 (Exhibit C).

**MOTION:** Heier moved and Schorr seconded to accept the letter of resignation from Ron Fetters, Lancaster Manor Administrator. Heier, Workman, Stevens and Schorr voted aye. Motion carried.

The Board appointed Gwen Thorpe, Deputy Chief Administrative Officer, as interim director until a permanent replacement is found. Thorpe will apply for a provisional license from the State (a provisional license is good for 180 days and may be extended for 90 days).

Heier exited the meeting at 7:55 a.m.

C. Information Services Consultant Proposal (Julie Gable)

Gwen Thorpe, Deputy Chief Administrative Officer, said Julie Gable, Gable Consulting, has submitted a proposal for consulting services to aid Lancaster County with its Information Services (IS) assessment. She said the cost will be \$50,000, which equals the amount that was budgeted for the expense.

5 DESIGN SCHEDULE FOR CORRECTIONAL FACILITY - Greg Newport, The Clark Enersen Partners; Boyd Batterman, Ben Huck and Chuck Richter, Sampson Construction Company; Mike Thurber, Corrections Director

Greg Newport, The Clark Enersen Partners, said the design development phase is nearing the end and a formal presentation on the design will be given the first part of December.

The Board scheduled the presentation on Tuesday, December 2<sup>nd</sup>, immediately following the regular County Board of Commissioners Meeting.

Newport said the architects are working through estimates with Sampson Construction Company and said the design documents will be turned over to Sampson in January for pricing and bidding, if the Board is in agreement.

Boyd Battterman, Sampson Construction Company, said the delay will likely work to the County's advantage in terms of pricing.

Newport said the architects are also working with the District Energy Corporation (DEC) to coordinate with their site systems.

In response to a question from Schorr, Batterman said Chuck Richter will be the Senior Project Manager for the project and will report monthly to the Board.

Mike Thurber, Corrections Director, said Brad Johnson, Transition Coordinator, and Bob Jarrett, a Corrections' employee who provides oversight for the County on the project, will also be meeting with Richter on a regular basis. He said Jarrett will be on site once ground is broken.

In response to a question from Workman, Newport said pre-cast concrete cells are still favored, because they are load-bearing and will become part of the structure.

Richter said site-cast cells will be an option as part of the bidding process.

### **TAX EQUALIZATION AND REVIEW COMMISSION PROCEDURES** - Dan Nolte, County Clerk

Dan Nolte, County Clerk, said his office has received a number of calls from property owners regarding letters they received from the Tax Equalization and Review Commission (TERC) related to greenbelt appeals. He said property owners are confused as to whether they need to file a written response and suggested a letter of clarification, either from the County Clerk's Office or County Board of Equalization, would be beneficial.

Board consensus was to consult with their counsel on the matter, Bill Peters.

She also reported that Regions V and VI have hired a lobbyist and the State is putting out a Request for Proposals (RFP) for how to run the Integrated Care Coordination Units (ICCU's).

Tom Fox, Deputy County Attorney, noted purchasing requirements had been waived, due to the emergency nature of the repair.

6 REVIEW OF COUNTY SPECIAL PERMIT NO. 07033, SOIL MINING AT HIGHWAY 77 BETWEEN DAVEY AND BRANCHED OAK ROADS (ACCESS) - Tom Fox, Deputy County Attorney; Mike DeKalb, Planner

Tom Fox, Deputy County Attorney, noted that LeGrande Excavating (the contractor) had requested access to Branched Oak Road under a provision in the special permit (see October 30, 2008 Staff Meeting minutes). The provision conflicts with other language in the special permit that limits access from the site to Highway 77.

Mike DeKalb, Planner, said Greg Sanford, the landowner and holder of the special permit, has indicated he wants to proceed with what he has, relative to an amendment, and said Building and Safety has sent him a one-year renewal check-off. DeKalb said the intent of the request for access off Branched Oak Road was to avoid the time restrictions for access to Highway 77. He pointed out that the revised site plan only shows one access point and a general note states: access to the site shall be limited to Highway 77 and shall be prohibited between 7:30 and 8:30 a.m. and between 12:30 and 5:30 p.m.

Workman asked whether it is necessary to make the clarification.

DeKalb said he believes it is and said a public hearing is recommended to give all sides a chance to comment.

Eagan said the record reflects that it was the Board's intent to limit the access to Highway 77 and it was a clerical error that the conflicting language was picked up. He said he believes the correction could be handled as a regular item at a County Board of Commissioners Meeting.

Fox disagreed and said the Board needs to hold a public hearing, with proper notice.

## MOTION: Schorr moved and Stevens seconded to schedule correction of a clerical error relating to County Special Permit No. 07033 for public hearing and to notify the applicant. Stevens, Schorr and Workman voted aye. Heier was absent from voting. Motion carried.
