The location announcement of the Nebraska Open Meetings Act was given and the meeting was called to order at 5:00 p.m.

1) <u>MINUTES:</u> Approval of the minutes of the Board of Commissioners meeting held on Tuesday, September 13, 2011.

MOTION: Smoyer moved and Raybould seconded approval of the minutes. Raybould, Heier, Smoyer and Schorr voted aye. Hudkins was absent. Motion carried 4-0.

2) CLAIMS: Approval of all claims processed through Tuesday, September 20, 2011.

MOTION: Heier moved and Smoyer seconded approval of the claims. Raybould, Heier, Smoyer and Schorr voted aye. Hudkins was absent. Motion carried 4-0.

3) **NEW BUSINESS**:

A. A special events permit application for the Hickman viaduct grand opening at S. 68th Street on Sunday, October 2, 2011.

The Chair announced the item would be held until later in the meeting.

B. A resolution proclaiming Monday, September 26, 2011, as "Family Day – A Day to Eat Dinner with Your Children". (R-11-0068)

The Clerk read the resolution for the record.

MOTION: Smoyer moved and Raybould seconded approval of the resolution. Smoyer, Raybould, Heier and Schorr voted aye. Hudkins was absent. Motion carried 4-0.

C. A resolution for the issuance of tax sale certificates on delinquent parcels which were not sold for want of bids. (R-11-0069)

MOTION: Heier moved and Smoyer seconded approval of the resolution. Raybould, Heier, Smoyer and Schorr voted aye. Hudkins was absent. Motion carried 4-0.

D. A recommendation from the Purchasing Agent and the Public Building Commission to award a contract to Hy-Electric, Inc., in the amount of \$119,597.30, for the supply and installation of energy efficient light fixtures in the north City/County parking garage and the Corrections parking garage. (B-11-0031)

MOTION: Raybould moved and Smoyer seconded approval of the recommendation. Raybould, Heier, Smoyer and Schorr voted aye. Hudkins was absent. Motion carried 4-0.

E. A cooperative agreement with the US Department of the Interior US Geological Survey, in the amount of \$11,615, for joint funding of water resources investigations. The agreement is for the operation and computation of records for four gaging stations: Salt Creek at Roca, Little Salt Creek near Lincoln, Stevens Creek near Lincoln and Rock Creek near Ceresco. Term of the agreement is October 1, 2011, to September 30, 2012. (C-11-0520)

MOTION: Heier moved and Smoyer seconded approval of the agreement. Heier, Smoyer, Raybould and Schorr voted aye. Hudkins was absent. Motion carried 4-0.

F. A banquet agreement with The Lodge at Wilderness Ridge for the rental of a conference room on November 3, 2011. A minimum of \$500 will be spent on food and beverages and the cost will be divided between Lancaster, Douglas and Sarpy Counties. (C-11-0521)

MOTION: Heier moved and Raybould seconded approval of the agreement. Smoyer, Raybould, Heier and Schorr voted aye. Hudkins was absent. Motion carried 4-0.

G. An interlocal agreement with the Lincoln-Lancaster County Railroad Transportation Safety District to provide supplemental funding for the Hickman Viaduct; Project C55-S-401(6). The Railroad Transportation Safety District will provide the County up to \$40,000 in the event the project overruns the current contract amount. (C-11-0528)

MOTION: Heier moved and Smoyer seconded approval of the agreement. Raybould, Heier, Smoyer and Schorr voted aye. Hudkins was absent. Motion carried 4-0.

H. A contract between Teknion, LLC, Lancaster County and the City of Lincoln using cooperative purchasing for the annual requirements for Teknion Office Furniture. The County will pay for products in accordance with the Public Sourcing Solutions Master Agreement No. CNR01290. Term of the contract is March 1, 2011, to December 31, 2011. (C-11-0529)

MOTION: Raybould moved and Smoyer seconded approval of the contract. Raybould, Heier, Smoyer and Schorr voted aye. Hudkins was absent. Motion carried 4-0.

 A settlement agreement between the United States Fish and Wildlife Service and Lancaster County for the closing and vacation of a portion of NW 12th Street between W. Branched Oak Road and W. Raymond Road. (C-11-0530)

MOTION: Raybould moved and Heier seconded approval of the agreement. Heier, Smoyer, Raybould and Schorr voted aye. Hudkins was absent. Motion carried 4-0.

J. Acceptance of a grant award from the Nebraska Commission on Law Enforcement and Criminal Justice for Police Officers Working with Education Referrals (POWER). The County shall receive \$17,611. Term of the grant award is July 1, 2011, to June 30, 2012.

MOTION: Smoyer moved and Raybould seconded approval of the grant award. Smoyer, Raybould, Heier and Schorr voted aye. Hudkins was absent. Motion carried 4-0.

K. Acceptance of a grant award from the Nebraska Commission on Law Enforcement and Criminal Justice for the Lancaster County JABG Grant. The County shall receive \$78,703. Term of the grant award is July 1, 2011, to June 30, 2012.

MOTION: Raybould moved and Smoyer seconded approval of the grant award. Raybould, Heier, Smoyer and Schorr voted aye. Hudkins was absent. Motion carried 4-0.

L. Notice of quiet zone establishment for the Lincoln South Quiet Zone.

MOTION: Raybould moved and Smoyer seconded approval to send the notice.

Roger Figard, City Engineer, discussed the establishment of the Lincoln South Quiet Zone (Exhibit A) from 3rd and "D" Streets to 14th Street and Yankee Hill Road. Figard said the mayor has signed an executive order for notice of intent on crossings in the City of Lincoln, but the County Board must file a notice of intent for the crossing at 14th Street and Yankee Hill Road since it falls within the County's jurisdiction. He asked the County Board to authorize Deb Schorr to sign and send the notice of intent to the Federal Rail Authority and Burlington Northern Santa Fe railroad officials. He said her signature would certify that certain safety measures have been done to the best of her knowledge. On October 22, at 12:01 a.m., the horns will cease to blow through that portion of the track unless officials find something that does not comply. Figard said the Saltillo Road crossing is not yet being included in the quiet zone because a farm driveway west of the crossing needs to be relocated first; the owner asked that the relocation be delayed until after harvest.

Raybould said there have been concerns over the loud horns in this neighborhood.

Figard noted the quiet zone is established for normal locomotive horn operation. Any time there are workers in the right-of-way or anyone is trespassing in the crossing areas, a locomotive engineer is still required to blow the horn.

In response to Schorr's question, Figard said the crossings are raised medians with lights and gates and do not have wayside horns.

Smoyer thanked Figard for his work.

Schorr asked when work would continue on the Saltillo Road crossing. Heier thought harvesting would be done by mid November, depending on weather. Figard said the driveway would be physically relocated, another notice would be sent, and there would be a 30-day waiting period. He thought the crossing should be done by early spring.

Figard said the physical improvements and raised median have been done at 1st and "J" Streets, the crossing at 2nd and "J" Streets has been closed and the crossing at 3rd and "J" Streets as been physically closed but there are still some gates to install and agreements to finish.

ROLL CALL: Raybould, Heier, Smoyer and Schorr voted aye. Hudkins was absent. Motion carried 4-0.

M. Adoption of Lancaster County Legislative Priorities for the 2012 legislative session of the Nebraska Legislature.

MOTION: Smoyer moved and Raybould seconded approval of the grant award.

Bob Van Valkenburg asked the Board to delay voting on the priorities. He felt the process of applying for property tax exemptions should be reviewed and made a priority. Van Valkenburg said he would discuss this issue with the State Tax Commissioner and he would appreciate the Board's support.

Schorr said the legislative priorities were discussed at the Board's legislative retreat with senators, elected officials and department directors, as well as legislative consultants Gordon Kissel and Joe Kohout at the last staff meeting.

Raybould said the upcoming legislative session will be short, and the Board had a hard time selecting five priorities out of the many issues discussed. She discussed the difficulty in passing items through the Legislature.

Van Valkenburg said an item could make the docket if the County Board and the State Tax Commissioner push it. He felt people are being taxed inappropriately and the issue should be addressed.

Smoyer said the priority list is not a conclusive list. He stated there would be other future bills supported by the Board, but for now, the items listed are the top priorities.

ROLL CALL: Heier, Smoyer, Raybould and Schorr voted aye. Hudkins was absent. Motion carried 4-0.

RETURNING TO 3A:

Schorr said the application specifies the event date and time as Sunday, October 2, 2011, from 4:00 to 7:00 p.m., but Hawkins Construction Company suggested moving the date to Saturday, October 1 from 10:00 a.m. to 1:00 p.m. The bridge should be completed on Friday, September 30, and there is concern over having a ribbon cutting on an open bridge.

Ken Schroeder, County Surveyor, said it does not matter which day it occurs, as long as the conditions are met and Hawkins Construction Company has agreed to it. Schorr noted the conditions referred to are in a separation attachment dated September 16 from the County Engineer's department.

MOTION: Heier moved and Smoyer seconded approval of the special events permit.

Schorr asked that the approval be made tentative upon the change of date and time to October 1 from 10:00 a.m. to 1:00 p.m. and inclusion of the special conditions from the County Engineer's Office.

The maker and the seconder accepted the amendment to the motion.

ROLL CALL: Heier, Smoyer, Raybould and Schorr voted aye. Hudkins was absent. Motion carried 4-0.



Any organization failing to file on or before December 31 may file the statement on or before June 30 to maintain the tax exempt status of the property. Filing by this date millifies any previous action by the county board denying the exempt status. If a late filing is made, the assessor shall assess a penalty of 10 percent of the tax that would have been due had the statement not been filed or one hundred dollars. whichever is less, for each calendar month or fraction thereof for which the statement missed the December 31 deadline.

Filing by this date nullifies any previous action by the county board denying the exempt status. If a late filing is made, the assessor shall assess a penalty of 10 percent of the tax that would have been due had the statement not been filed or one hundred dollars, whichever is less, for each calendar month or fraction thereof for which the statement missed the December 31 deadline.
