The location announcement of the Nebraska Open Meetings Act was given and the meeting was called to order at 9:38 a.m.

1) **MINUTES: Approval of the minutes of the Board of Commissioners meeting held on Tuesday, December 20, 2011.**

**MOTION:** Smoyer moved and Raybould seconded approval of the minutes. Raybould, Smoyer and Schorr voted aye. Heier and Hudkins were absent. Motion carried 3-0.

2) **CLAIMS: Approval of all claims processed through Tuesday, January 10, 2012.**

**MOTION:** Smoyer moved and Raybould seconded approval of the claims. Raybould, Smoyer and Schorr voted aye. Heier and Hudkins were absent. Motion carried 3-0.

3) **SPECIAL PRESENTATION:**

**A. Presentation of the County Sheriff Employee Awards for outstanding service in 2011.**

Terry Wagner, County Sheriff, presented the awards.

- Melissa Straka (not present) received the Citizens Certificate of Merit for assisting in the apprehension of a fleeing suspect.
- Zachariah Brown, Ethan Childress and Derek Wagner (not present) received the Citizens Certificate of Merit for assistance in a boat fire and rescue at Branched Oak Lake.
- Deputy Michael Hansen received the Meritorious Service Award for assistance in a boat fire and rescue at Branched Oat Lake.
- Captain Gary Juilfs received the Exceptional Duty Award for his work on the Sheriff's Office 150<sup>th</sup> Anniversary Book.

## **SPECIAL PRESENTATION CONTINUED:**

- Deputy Billy Ziemer received the Exceptional Duty Award for hours spent coordinating various community functions, including the Special Olympics, the Trail Trec Community Ride and Region V Services.
- Deputy Bradley Sturdy received the Deputy Sheriff of the Year for Exceptional Duty Award for exceptional work on several cases while working as the Waverly deputy, including the recovery of a stolen ATV and two felony arrests.

### **4) OLD BUSINESS:**

- A. A political subdivision tort claim filed against Lancaster County Corrections by Gerald L. Andersen for lost property in the amount of \$500.**

Brittany Behrens, Deputy County Attorney, said no action would need to be taken since the claimant has withdrawn the tort claim. Lancaster County has provided him with a new oral stretch device to replace the missing one (Exhibit A).

### **5) NEW BUSINESS:**

- A. A resolution in the matter of County maintenance of the following roads in The Preserve at Cross Creek First Addition and The Preserve at Cross Creek Second Addition: Approximately 900 feet of South 64th Street, approximately 185 feet of Elderberry Court, approximately 825 feet of Winterberry Lane and approximately 810 feet of South 67th Street. (R-12-0001)**

Raybould thanked the County Engineer's Office for making sure the subdivision has fulfilled every obligation to qualify for County road maintenance.

**MOTION:** Raybould moved and Smoyer seconded approval of the resolution. Raybould, Smoyer and Schorr voted aye. Heier and Hudkins were absent. Motion carried 3-0.

- B. A utility relocation agreement between Lancaster County and Mid-America Pipeline Company of Greenwood in the amount of \$6,481 to relocate pipeline facilities for a grading project on Havelock Avenue from N. 162<sup>nd</sup> Street to N. 176<sup>th</sup> Street; Project C-55-J-403(2). (C-12-0001)**

**MOTION:** Smoyer moved and Raybould seconded approval of the agreement. Raybould, Smoyer and Schorr voted aye. Heier and Hudkins were absent. Motion carried 3-0.

- C. A utility relocation agreement between Lancaster County and Norris Public Power District in the amount of \$8,895.03 to relocate utility facilities to accommodate a bridge construction project on W. Sprague Road between SW 2<sup>nd</sup> Street and SW 14<sup>th</sup> Street; Project BR-3280(4) – Sprague East. (C-12-0002)**

**MOTION:** Smoyer moved and Raybould seconded approval of the agreement. Smoyer, Raybould and Schorr voted aye. Heier and Hudkins were absent. Motion carried 3-0.

**NEW BUSINESS CONTINUED:**

- D. **A utility relocation agreement between Lancaster County and Norris Public Power District in an estimated amount of \$115,004.50 to relocate power lines for a road rebuilding project on Denton Road from SW 12<sup>th</sup> Street to SW 56<sup>th</sup> Street; Project STPE-3305(9) – Denton East. (C-12-0003)**

**MOTION:** Raybould moved and Smoyer seconded approval of the agreement. Smoyer, Raybould and Schorr voted aye. Heier and Hudkins were absent. Motion carried 3-0.

- E. **Approval of sale and warranty deed of County property to the City of Hickman per County Contract C-07-0360 for a part of Lot 84, irregular tract in the Southeast Quarter of Section 33, Township 8 North, Range 7 East of the 6<sup>th</sup> Principal Meridian, Lancaster County, Nebraska.**

**MOTION:** Smoyer moved and Raybould seconded approval of the sale and warranty deed. Raybould, Smoyer and Schorr voted aye. Heier and Hudkins were absent. Motion carried 3-0.

- F. **Approval of sale and warranty deed of County property to the City of Hickman for a part of "Eastlawn Addition to the City of Hickman" located in the Northwest Quarter of Section 34, Township 8 North, Range 7 East of the 6<sup>th</sup> Principal Meridian, Lancaster County, Nebraska.**

**MOTION:** Smoyer moved and Raybould seconded approval of the sale and warranty deed. Raybould, Smoyer and Schorr voted aye. Heier and Hudkins were absent. Motion carried 3-0.

- G. **An amendment to a contract between Mid-Continent Safety, LLC, Lancaster County and the Lincoln-Lancaster County Public Building Commission for the annual supply of personal protective equipment and first aid supplies. The amendment provides for the replacement of a discontinued item as listed on Attachment A. (C-12-0004)**

**MOTION:** Raybould moved and Smoyer seconded approval of the amendment. Smoyer, Raybould and Schorr voted aye. Heier and Hudkins were absent. Motion carried 3-0.

- H. **An affiliation agreement with Forest Institute School of Professional Psychology for students who will collect assessment instruments and data at Lancaster County correctional facilities. Term of the agreement is November 1, 2011, to October 31, 2012. (C-12-0005)**

**MOTION:** Raybould moved and Smoyer seconded approval of the agreement. Smoyer, Raybould and Schorr voted aye. Heier and Hudkins were absent. Motion carried 3-0.

- I. **An amendment to County Contract C-05-0382 with CenterPointe for 9,000 square feet located in the Old Juvenile Attention Center at 2220 S. 10<sup>th</sup> Street. In consideration of the County's payment of \$18,578.38 for roof repair of the leased premises, CenterPointe agrees to a one-year extension of the lease term. The amendment extends the term of the lease to April 30, 2019. (C-12-0006)**

**MOTION:** Smoyer moved and Raybould seconded approval of the amendment. Raybould, Smoyer and Schorr voted aye. Heier and Hudkins were absent. Motion carried 3-0.

## **NEW BUSINESS CONTINUED:**

- J. **A laboratory services agreement between LabOne, Inc., d/b/a Quest Diagnostics, Inc., Lancaster County and the City of Lincoln for laboratory testing services provided to the Lincoln-Lancaster County Health Department. The County will pay for services in accordance with the fees in Attachment 1. Term of the agreement is August 25, 2011, to March 31, 2012. (C-12-0007)**

Judy Halstead, Lincoln-Lancaster County Health Department Director, said Quest Labs previously had been providing no-cost services to the Health Department. As of last spring, Quest reassessed their no-cost services and began invoicing. Halstead said she worked with the City and County Budget Officers to utilize some unexpended Health Department funds; as a result, the first \$20,000 is covered for the period of March to August 2011. In the meantime, Brittany Behrens, Deputy County Attorney, has worked on a billing agreement with Quest in which only the Medicaid cost would be charged for the period of August 25, 2011, to March 31, 2012. This will allow time for Purchasing to bid the services, and a new contract will be brought forth around April 1. Schorr asked if Medicaid could be an applicable cost in the new contract. Halstead said the bid would be for the best price possible.

**MOTION:** Smoyer moved and Raybould seconded approval of the agreement. Raybould, Smoyer and Schorr voted aye. Heier and Hudkins were absent. Motion carried 3-0.

- K. **An interlocal agreement between Sarpy County and Lancaster County to provide microfilming and scanning services. Sarpy County shall pay Lancaster County for microfilm imaging services at a rate of \$0.023 per image plus shipping costs. The term of the agreement is one year from the date of execution. (C-12-0008)**

**MOTION:** Smoyer moved and Raybould seconded approval of the agreement. Smoyer, Raybould and Schorr voted aye. Heier and Hudkins were absent. Motion carried 3-0.

- L. **A grant contract with Fresh Start, Inc., to provide funding in the amount of \$10,000 for Fresh Start's Shelter Program. Term of the grant contract is July 1, 2011, to June 30, 2012. (C-12-0009)**

**MOTION:** Smoyer moved and Raybould seconded approval of the contract. Smoyer, Raybould and Schorr voted aye. Heier and Hudkins were absent. Motion carried 3-0.

- M. **A grant contract with Lighthouse to provide funding in the amount of \$10,000 for Lighthouse's After School Program. Term of the agreement is July 1, 2011, to June 30, 2012. (C-12-0010)**

**MOTION:** Smoyer moved and Raybould seconded approval of the contract. Raybould, Smoyer and Schorr voted aye. Heier and Hudkins were absent. Motion carried 3-0.

- N. **An amendment to County Contract C-10-0438 between Feinstein Institute for Medical Research and Lancaster County, on behalf of the Community Mental Health Center, for the "Recovery After the Initial Schizophrenia Episode" (RAISE) project. The amendment changes the term of the agreement to September 21, 2011, to September 20, 2012, and sets the funding at \$23,102.12 for the new term. (C-12-0011)**

## **NEW BUSINESS CONTINUED:**

**MOTION:** Raybould moved and Smoyer seconded approval of the amendment. Raybould, Smoyer and Schorr voted aye. Heier and Hudkins were absent. Motion carried 3-0.

- O. **A subcontract between the Feinstein Institute for Medical Research and Lancaster County, on behalf of the Community Mental Health Center, in the amount of \$47,696.35, for products and services provided for the "Recovery After the Initial Schizophrenia Episode" (RAISE) project. Term of the agreement is September 21, 2011, to September 20, 2012. (C-12-0012)**

**MOTION:** Smoyer moved and Raybould seconded approval of the subcontract. Smoyer, Raybould and Schorr voted aye. Heier and Hudkins were absent. Motion carried 3-0.

- P. **An amendment to County Contract C-11-0030 between Ferrellgas, Lancaster County and the City of Lincoln for annual requirements of propane. The amendment renews the agreement for an additional one-year term from January 1, 2012 to December 31, 2012. (C-12-0026)**

**MOTION:** Smoyer moved and Raybould seconded approval of the amendment. Smoyer, Raybould and Schorr voted aye. Heier and Hudkins were absent. Motion carried 3-0.

- Q. **An amendment to County Contract C-11-0095 between Otte Oil & Propane, Lancaster County and the City of Lincoln for annual requirements of propane. The amendment renews the agreement for an additional one-year term from January 1, 2012 to December 31, 2012. (C-12-0027)**

**MOTION:** Smoyer moved and Raybould seconded approval of the amendment. Raybould, Smoyer and Schorr voted aye. Heier and Hudkins were absent. Motion carried 3-0.

- R. **An agreement with the Connecting Links to provide substance use evaluation services for Community Corrections. The County will pay up to \$125 per participant should the participant not pay within 30 days. Term of the contract is January 1, 2012 to June 30, 2013. (C-12-0028)**

Kim Etherton, Community Corrections Director, said this is a grant-related contract that also covers substance abuse evaluations in the jail as needed. She was concerned that one of the current providers would not be able to provide services within the next year, so she wanted another agreement in place.

Schorr inquired about the percentage of participants that do not pay the service fee within 30 days. Etherton said generally the fee is rolled into the accounts of drug court participants and is paid before graduation. The other participants are grant funded and do not pay.

**MOTION:** Raybould moved and Smoyer seconded approval of the agreement. Raybould, Smoyer and Schorr voted aye. Heier and Hudkins were absent. Motion carried 3-0.

- S. **A recommendation from the Purchasing Agent and the County Engineer to award a contract to CONTECH Construction Products, Inc., in the amount of \$25,977.77 for miscellaneous sizes of corrugated metal pipe for culverts. (B-12-0001)**

## **NEW BUSINESS CONTINUED:**

**MOTION:** Smoyer moved and Raybould seconded approval of the recommendation. Smoyer, Raybould and Schorr voted aye. Heier and Hudkins were absent. Motion carried 3-0.

- T. **A recommendation from the Purchasing Agent and the Request for Proposal (RFP) Selection Committee to award a contract to BVH Architects for space planning services at the current adult detention facility. Total cost of the service is not to exceed \$30,000. (B-12-0002)**

Bob Walla, Assistant Purchasing Director, said this is the preliminary design before going to a design architect and construction mode. He said a layout would be presented to the Board at the staff meeting on Thursday, January 12.

**MOTION:** Raybould moved and Smoyer seconded approval of the recommendation. Smoyer, Raybould and Schorr voted aye. Heier and Hudkins were absent. Motion carried 3-0.

- U. **A political subdivision tort claim filed against Lancaster County by Dukhan Mumin for an alleged warrantless search of his cell phone. Mr. Mumin is seeking compensatory and punitive damages in an undisclosed amount.**

Brittany Behrens said the County Attorney's Office has no additional information and recommended denial.

**MOTION:** Smoyer moved and Raybould seconded denial of the tort claim based on the County Attorney's recommendation. Raybould, Smoyer and Schorr voted aye. Heier and Hudkins were absent. Motion carried 3-0.

- V. **A political subdivision tort claim filed against Lancaster County by Dukhan Mumin for a child support order allegedly entered in violation of Nebraska statutes. Mr. Mumin is requesting the refund of all money plus interest collected pursuant to the child support order.**

Brittany Behrens said Mumin alleged he did not receive proper notice of his child support order. She provided a copy of the divorce decree ordering child support to Wesley Kitt (Dukhan Mumin), which noted Kitt (Mumin) was present at the hearing (Exhibit B).

**MOTION:** Smoyer moved and Raybould seconded denial of the tort claim based on the County Attorney's recommendation and the supporting documentation. Raybould, Smoyer and Schorr voted aye. Heier and Hudkins were absent. Motion carried 3-0.

- W. **The setting of the salary of Ashley Bohnet, Deputy Lancaster County Attorney, in the amount of \$56,000 per year, effective January 3, 2012.**

Doug Cyr, Deputy County Attorney, introduced Ashley Bohnet and explained she would be working on parental termination and law violation cases. Bohnet discussed her background and experience.

**MOTION:** Smoyer moved and Raybould seconded approval of the salary. Smoyer, Raybould and Schorr voted aye. Heier and Hudkins were absent. Motion carried 3-0.


