The Chair noted the location of the Open Meetings Act and opened the meeting at 8:30 a.m.

AGENDA ITEM

1 APPROVAL OF THE STAFF MEETING MINUTES OF THURSDAY, NOVEMBER 8, 2012

MOTION: Hudkins moved and Smoyer seconded approval of the minutes of the

November 8, 2012 Staff Meeting. Smoyer, Hudkins and Schorr voted aye. Heier and Raybould were absent from voting. Motion carried 3-0.

2 ADDITIONS TO THE AGENDA

- A. Confirmation of Long-Term Disability Rate (Exhibit A)
- B. Report on Community Mental Health Center (CMHC) Invitation to Negotiate (ITN) Consumer Meeting

MOTION: Hudkins moved and Smoyer seconded approval of the additions to the agenda. Hudkins, Smoyer and Schorr voted aye. Heier and Raybould were absent from voting. Motion carried 3-0.

3 INHERITANCE TAX PRESS RELEASE - Gordon Kissel and Joe Kohout, Kissel/E&S Associates (Legislative Consultants)

Schorr asked Gordon Kissel and Joe Kohout, Kissel/E&S Associates, whether they felt there would be value to issuing a press release or having a press conference on the inheritance tax issue early in the Legislative session. Kissel felt there would be and suggested the Board begin to pull together a coalition to get the message out on the importance of the inheritance tax revenue to counties as the Governor has indicated he intends to reintroduce legislation to eliminate the tax in the 2013 Session.

Smoyer felt Lancaster County should distance itself from Douglas County on this issue, explaining he disagrees with the Douglas County Board's decision to pledge \$5,000,000 (\$500,000 a year for 10 years) from inheritance tax revenue to help finance a \$323,000,000 cancer center for the University of Nebraska Medical Center (UNMC), which may have strengthened the Governor's position on the issue. Hudkins said there has been value over the years in having the three largest counties unified on issues. Kohout said UNMC has tremendous support in the Omaha community and there is some support within the Douglas County delegation for Douglas County using inheritance tax revenue to support it.

Board consensus was to ask Larry Dix, Nebraska Association of County Officials (NACO) Executive Director, to send copies of the Board's letter to the Governor on this issue (a copy is on file in the County Clerk's Office) to the new state senators. There was also consensus to hold an informal legislative breakfast with Douglas, Lancaster and Sarpy County State Senators and NACO representatives.

Kohout reported that he is working with Senator Coash and Liz Neeley, PhD., Objective Advantage, LLC, on the issue of assignment of counsel in abuse and neglect cases. He said a proposal for Nebraska Jail Standards to set the standards for staff secure juvenile detention facilities has also been drafted.

Hudkins inquired about a proposal for appointment of elected officials by the County Board, rather than election. Kohout said the Douglas County Board had a heated discussion on that issue at a recent meeting and said it may not make it onto their legislative agenda. **NOTE:** The topic is scheduled for discussion on the Tri-County Meeting agenda.

MOTION:

Hudkins moved and Smoyer seconded to handle the claim through the regular claims process. Hudkins, Smoyer and Schorr voted aye. Heier and Raybould were absent from voting. Motion carried 3-0.

The Board asked Eagan to check with the County Treasurer to make sure his employees are aware of the need for a business rider on their motor vehicle insurance if they are using their personal vehicles for travel as part of their job.

B. Appointments to the Lancaster County Extension Board (James J. Bauman, L. Ronald Fleecs, Luann Finke and Susan Lynn Sarver)

The Board scheduled the appointments on the November 20, 2012 County Board of Commissioners Meeting agenda.

C. Keno Prevention Fund Allocation Process

Schorr said she believes the allocation of funds from the Keno Prevention Fund have been reactive and would like to see a more proactive approach. She said she is concerned with recidivism at the Jail and said would like the Board to allow Kit Boesch, Human Services Administrator, and Brenda Fisher, Program Director, Corrections

Department, to explore options and to bring a recommendation back to the Board. Smoyer said he is supportive, provided it does tie the Board to future funding of a program. Schorr said she envisions a multi-pronged approach and tracking the recidivism rate to see which approach is most effective.

4 POTENTIAL LITIGATION - Doug Pillard, Design Division Head, County Engineering; Jim Shotkoski, Right-of-Way Division Head, County Engineering; Richard Grabow, Deputy County Attorney

MOTION: Smoyer moved and Hudkins seconded to enter Executive Session at 9:06 a.m. for the purpose of protecting the public interest with regards to potential litigation.

5 UNFUNDED MANDATES - Dennis Meyer, Budget and Fiscal Officer

Dennis Meyer, Budget and Fiscal Officer, presented a list of services that the County provides to the State of Nebraska (unfunded mandates) (Exhibit B). He referenced the first item on the list (collection of motor vehicles sales tax), noting the County collected \$29,238,776 in motor vehicles sales tax in Fiscal Year (FY) 2012 and only received \$1,800 in collection fees.

Board consensus was to provide copies of the list to the Gordon Kissel and Joe Kohout, Kissel/E&S Associates (Legislative Consultants; Larry Dix, Nebraska Association of County Officials (NACO) Executive Director; and the Douglas and Sarpy County Boards. There was also consensus to share the information with state senators and to have Meyer and two Commissioners brief the Chair of the Legislature's Appropriation Committee on this issue.



The Treasurer collects sales tax and remits to the State through the motor vehicles division. Collected \$29,238,776 in FY12 and collections fees kept by the county were \$1,800.

West O Building

Lancaster County provides 4,075 square feet to the State for Drivers License Examiners. This includes utilities and custodial services. The cost per sq/ft at West O is \$14.88.

Motor Vehicle Building

Lancaster County provides 1,651 square feet to the State. This includes utilities and custodial services. The cost per sq/ft is \$7.47.

Register of Deeds

The Register of Deeds does all of the work required to file land records yet is required to send a portion of the documentary stamp tax to the state to fund other programs. County keeps 22.22% and the State receives 77.78%. Based on \$2 million collected - state receives \$1,555,000. (76-903)

Election Commissioner

Billable costs for elections are not allowed to be billed to the state. Costs are passed down to other political subdivisions but not to the state. State costs would range from 50% to 60% of billable costs. Last primary billable costs were \$356,000.

County Court (BU 6280)

Lancaster County is required to remit certain court costs to the State. If those fees cannot be collected from defendants, the County must pay.
