**MOTION:** Raybould moved and Amundson seconded approval of the minutes. Schorr, Raybould, Amundson and Hudkins voted aye. Smoyer was absent. Motion carried 4-0.

#### 3) **PUBLIC HEARINGS:**

#### A. Corporate manager application for Michael Bolinger in connection with the Class B liquor license for Ely's Service, Inc., d/b/a Branched Oak Marina, 10001 W. Davey Road, Raymond. (See 4A for correlating item.)

The Chair opened the public hearing. Since no one appeared, Schorr suggested delaying action until Michael Bolinger could be present. Brittany Behrens, Deputy County Attorney, said a corporate manager liquor license application does not require the public hearing to be held open, but she recommended doing so if the Board waited to take action. The consensus was to hold open the public hearing and have the County Clerk's Office notify Michael Bolinger.

Folsom Street to S. 1<sup>st</sup> Street, then north along S. 1<sup>st</sup> Street to the existing cell tower site at 4200 S. 1<sup>st</sup> Street. There is no cost to Lancaster County. (C-13-0197)

 F. Amendment to County Contract C-13-0096 with the Lincoln Airport Authority for storage of Emergency Management equipment and supplies. The amendment adds Cedar County to the lease agreement, whereby reducing Lancaster County's rent to \$284 per month. (C-13-0198)

- Islamic Foundation of Lincoln recently sold the property.
- Lincoln Crisis Pregnancy Center has three applications, one holding the main building (111 Piazza Terrace) and two with empty lots (4225 O Street, 4235 O Street). The two empty lots will not be used for expansion as originally planned.
- Priestly Fraternity has 20 acres of pasture not used for religious purposes.

Janelle Soderling, Willard Community Center, and Michael Tavlin, The Smith Collection, appeared to answer questions.

**MOTION:** Schorr moved and Amundson seconded approval of the property tax exemption applications for the Center for Legal Immigration Assistance, Christ's Place Church, Diocesan Housing Ministries, El Centro de las Americas, Indian Hills Community Church, Light of the Gospel Church, Lincoln Crisis Pregnancy Center (111 Piazza Terrace), Madonna Rehabilitation Hospital, Nebraska Wesleyan University, Northern Lighthouse, Open Sky Policy Institute, Queen of Mercy Motherhouse, Region V Foundation, Salt Creek Wranglers, St. John's Lutheran Cemetery Association, St. Thomas Aquinas Church, The Smith Collection, Union College and Willard Community Center. Schorr, Raybould, Amundson and Hudkins voted aye. Smoyer was absent. Motion carried 4-0.

**MOTION:** Schorr moved and Raybould seconded denial of the property tax exemption applications for CenterPointe, Friedens Evangelical Lutheran Church, Islamic Foundation of Lincoln, Lincoln Crisis Pregnancy Center (4225 O Street, 4235 O Street) and Priestly Fraternity of St. Peter. Amundson, Schorr, Raybould and Hudkins voted aye. Smoyer was absent. Motion carried 4-0.

## 5) **PROPERTY TAX EXEMPTION REVIEWS:**

Christ's Place Church Faith Bible Church Glad Tidings Assembly of God Radix Inc Southpointe Christian Church

Scott Gaines said these applications were previously approved but have had a change in status since then. The changes are as follows:

- Christ's Place Church has a private daycare operator using part of the property. The recommendation is to change it from a full to partial exemption with 94% remaining exempt.
- Faith Bible Church has a house on the property that is now being used for religious purposes. He recommended a change from a partial to full exemption.
- Glad Tidings Assembly of God sold the property to Christ's Place (approved under Item 4).
- Radix, Inc., sold to a private entity so the property will now be taxable.
- Southpointe Christian Church built private storage units on the property. The recommendation is to change from a full to partial exemption of 55.35%.

**MOTION:** Schorr moved and Amundson seconded to change Christ's Place Church and SouthPointe Christian Church to a partial exemption, change Faith Bible Church to a full exemption, and remove the exemption from Glad Tidings Assembly of God and Radix, Inc. Schorr, Raybould, Amundson and Hudkins voted aye. Smoyer was absent. Motion carried 4-0.
