The location announcement of the Nebraska Open Meetings Act was given and the meeting was called to order at 10:30 a.m.

1) <u>MINUTES:</u> Approval of the minutes of the Board of Commissioners meeting held on Tuesday, July 9, 2013.

MOTION: Smoyer moved and Raybould seconded approval of the minutes. Schorr, Raybould, Amundson, Smoyer and Hudkins voted age. Motion carried 5-0.

2) CLAIMS: Approval of all claims processed through Tuesday, July 16, 2013.

MOTION: Raybould moved and Smoyer seconded approval of the claims. Raybould, Amundson, Smoyer, Schorr and Hudkins voted aye. Motion carried 5-0.

3) **SPECIAL PRESENTATION:**

A. Lancaster County Visitors Improvement Fund grant in the amount of \$10,000 to Star City BMX, Inc., for improvement of the BMX facility located at Oak Lake Park — Cheri Stanley, Star City BMX; Julie Lattimer, Visitor Promotion Committee Chair; Jeff Maul, Lincoln Convention & Visitors Bureau Executive Director. (See 4A for correlating item.)

Jeff Maul said this was the second request for Star City BMX, which would provide a more permanent solution for their needs. The first grant was used as a temporary fix of the track corners.

SPECIAL PRESENTATION CONTINUED:

Julie Lattimer said Star City BMX would like to asphalt the two remaining corners of the track. Since the corners are made of dirt, rain can cause delays or cancellations during repairs. She noted that the land is owned by the City and is included in their 20-year plan.

Cheri Stanley said Star City BMX is a non-profit volunteer organization. She discussed the events and the large number of people that participate. She felt asphalting the last two corners would help attract more national events, and therefore, more people to the City of Lincoln.

Josh Larson, Star City BMX rider and track operator, discussed his riding history and the amount of time he spends providing maintenance for the track.

4) **NEW BUSINESS**:

A. Lancaster County Visitors Improvement Fund grant contract in the amount of \$10,000 from Lancaster County to Star City BMX, Inc., for improvement of the BMX facility located at Oak Lake Park. The grant period is June 1, 2013, to October 31, 2013. (C-13-0313)

MOTION: Smoyer moved and Schorr seconded approval of the contract. Smoyer, Schorr, Raybould, Amundson and Hudkins voted aye. Motion carried 5-0.

Hudkins thanked the Lancaster Event Center staff for bringing the Junior National Simmental Show to Lincoln. He said there would be a bid to have the same event in three years.

B. Agreement with Aramark Uniform Services for Corrections clothing for guards and maintenance staff. The County will pay for products and services according to the line item pricing as listed in the contractor's proposal. Term of the agreement is four years from the date of execution. (C-13-0314)

MOTION: Raybould moved and Amundson seconded approval of the agreement. Schorr, Raybould, Amundson, Smoyer and Hudkins voted age. Motion carried 5-0.

C. Agreement with Alamar Uniforms for Corrections clothing for guards and maintenance staff. The County will pay for products and services according to the line item pricing as listed in the contractor's proposal. Term of the agreement is four years from the date of execution. (C-13-0315)

MOTION: Schorr moved and Smoyer seconded approval of the agreement. Raybould, Amundson, Smoyer, Schorr and Hudkins voted aye. Motion carried 5-0.

D. Agreement between Pepsi-Cola of Lincoln, Lancaster County and the Lincoln-Lancaster County Public Building Commission for vending services. The County will be paid 25.5% commission on cold beverage sales and 15.5% commission on snacks and hot beverages. The County and Public Building Commission will be paid a \$5,000 signing bonus. Term of the agreement is July 1, 2013, to June 30, 2017. (C-13-0316)

MOTION: Raybould moved and Smoyer seconded approval of the agreement. Amundson, Smoyer, Schorr, Raybould and Hudkins voted aye. Motion carried 5-0.

E. Agreement between Graybar Electric Company, Lancaster County, the City of Lincoln and the Lincoln-Lancaster County Public Building Commission for the annual requirements of electrical products. Pricing will be pursuant to the County of Los Angeles, California Contract MA-IS-1340234-1. The contract is effective upon execution by all parties through May 31, 2016. (C-13-0317)

MOTION: Smoyer moved and Schorr seconded approval of the agreement. Smoyer, Schorr, Raybould, Amundson and Hudkins voted aye. Motion carried 5-0.

F. Agreement between National Everything Wholesale, Lancaster County, the City of Lincoln and the Lincoln-Lancaster County Public Building Commission for the annual requirements of janitorial and sanitation supplies. The County will pay for products and services according to the City of Tucson Contract No. 100489. Term of the agreement is August 15, 2013 to August 1, 2014. (C-13-0318)

MOTION: Amundson moved and Raybould seconded approval of the agreement. Schorr, Raybould, Amundson, Smoyer and Hudkins voted aye. Motion carried 5-0.

G. Amendment to County Contract C-13-0033 with National Paper Company, Inc., for the annual supply and delivery of warewashing and laundry chemicals. The amendment renews the agreement for an additional one-year term from August 1, 2013, to July 31, 2014, and provides for the changes as listed in Attachments A and B. (C-13-0328)

MOTION: Schorr moved and Smoyer seconded approval of the amendment. Raybould, Amundson, Smoyer, Schorr and Hudkins voted aye. Motion carried 5-0.

H. Agreement between the Nebraska Air National Guard and Lancaster County, on behalf of the Lancaster County Sheriff, for use of the County Firearms Range for training and qualifications testing. Term of the agreement is one year from the date of execution. (C-13-0312)

Terry Wagner, County Sheriff, said agreements such as this are in place to allow use of the firearms range for its long-range rifle capabilities.

MOTION: Smoyer moved and Amundson seconded approval of the agreement. Amundson, Smoyer, Schorr, Raybould and Hudkins voted aye. Motion carried 5-0.

 Mini-grant contract application and award for a grant from the Nebraska Office of Highway Safety (NOHS) for the purchase of two radar units. NOHS will provide funding for 75% of the cost of each unit. (C-13-0329)

Terry Wagner said the radar units are \$1,800 each. NOHS has also provided funding for in-car cameras in the past.

MOTION: Raybould moved and Smoyer seconded approval of the contract application and award. Smoyer, Schorr, Raybould, Amundson and Hudkins voted aye. Motion carried 5-0.

J. Acceptance of a Deputy Sheriff Captains' temporary retirement buyout program application and agreement between the County of Lancaster, Nebraska, and Gordon K. Harrod, an employee of the Lancaster County Sheriff's Office. Mr. Harrod's resignation is effective September 9, 2013. (C-13-0330)

Terry Wagner said Deputy Harrod has been with the department for 31 years and will become eligible for retirement after he turns 55.

MOTION: Amundson moved and Schorr seconded approval of the application and agreement. Schorr, Raybould, Amundson, Smoyer and Hudkins voted age. Motion carried 5-0.

K. Interlocal agreement with the City of Waverly for roadway resurfacing on N. 148th Street from Amberly Road to US Highway 6. The County will pay approximately \$43,000 for the resurfacing of County right-of-way. (C-13-0319)

MOTION: Smoyer moved and Amundson seconded approval of the agreement. Raybould, Amundson, Smoyer, Schorr and Hudkins voted aye. Motion carried 5-0.

L. Agreement with Trans-Alarm for security system monitoring services at the Lancaster County Department of Motor Vehicles. The County will pay \$23 per month for the services provided. Term of the agreement is one year from the date of execution. (C-13-0320)

The Chair announced Item 4L would be held.

M. Agreement between Medical Staffing Network Healthcare, LLC, and Lancaster County, on behalf of the Community Mental Health Center/Crisis Center, for healthcare staffing services. The County shall pay for nursing services in accordance with the rate schedule as listed in Attachment A. Term of the agreement is July 1, 2013, to June 30, 2014. (C-13-0321)

MOTION: Schorr moved and Raybould seconded approval of the agreement. Smoyer, Schorr, Raybould, Amundson and Hudkins voted aye. Motion carried 5-0.

N. Contract between Cynthia Pilkington, PhD, and Lancaster County, on behalf of the Lancaster County Mental Health Center, for services of a qualified psychologist. The services will be provided at the rate of \$65 per hour for up to 320 hours per year. Term of the contract is July 1, 2013, to June 30, 2014. (C-13-0322)

MOTION: Amundson moved and Raybould seconded approval of the contract. Schorr, Raybould, Amundson, Smoyer and Hudkins voted aye. Motion carried 5-0.

Schorr questioned if there was a 30-day termination provision. Brittany Behrens, Deputy County Attorney, said the contracts pertaining to the Community Mental Health Center and/or the Crisis Center (Items 4M-4P) have a 30-day termination provision with the exception of Item 4P, which has a 60-day termination provision.

O. Contract between Mary Angela Apthorpe, MA, LADC, PLMHP, and Lancaster County, on behalf of the Lancaster County Mental Health Crisis Center, for certified alcohol and drug abuse counselor services. The services will be provided at the rate of \$25 per hour for up to 20 hours per week. Term of the contract is July 1, 2013, to June 30, 2014. (C-13-0323)

MOTION: Raybould moved and Amundson seconded approval of the contract. Raybould, Amundson, Smoyer, Schorr and Hudkins voted aye. Motion carried 5-0.

P. Amendment to County Contract C-12-0439 with Dr. Klaus Hartmann for the professional services of a psychiatrist to assist in the provision of psychiatric serves at the Community Mental Health Center on an as needed, on call basis. The amendment renews the agreement for an additional one-year term from August 1, 2013, to July 31, 2014. (C-13-0324)

MOTION: Raybould moved and Smoyer seconded approval of the amendment. Amundson, Smoyer, Schorr, Raybould and Hudkins voted aye. Motion carried 5-0.

Q. Agreement with Kapish North America Services, Inc., for professional TRIM telephonic consultation services. The County will pay at the rate of \$200 per hour, up to \$5,000 for the services. Term of the agreement is July 1, 2013, to June 30, 2014. (C-13-0325)

MOTION: Amundson moved and Raybould seconded approval of the agreement. Smoyer, Schorr, Raybould, Amundson and Hudkins voted age. Motion carried 5-0.

R. Grant contract with Friendship Home, Inc., in the amount of \$12,500 to provide funding for the Children in Shelter Project program. Term of the grant contract is July 1, 2013, to June 30, 2014. (C-13-0326)

MOTION: Amundson moved and Smoyer seconded approval of the contract. Schorr, Raybould, Amundson, Smoyer and Hudkins voted aye. Motion carried 5-0.

S. Acceptance of the Lancaster County – County Aid State Grant 13-CA-526 from the Nebraska Commission on Law Enforcement and Criminal Justice in the amount of \$199,726. The grant period is July 1, 2013, to June 30, 2014. (C-13-0327)

MOTION: Smoyer moved and Raybould seconded approval of the grant. Raybould, Amundson, Smoyer, Schorr and Hudkins voted aye. Motion carried 5-0.

T. Interlocal agreement with the State of Nebraska Probation Administration for electronic monitoring of up to 32 juveniles and two probation officers to supervise juveniles who are ordered by the separate Juvenile Court of Lancaster County to preadjudication or pre-disposition monitoring during home detention. The County will pay up to \$134,000 for the services. Term of the agreement is July 1, 2013, to June 30, 2014. (C-13-0331)

MOTION: Raybould moved and Amundson seconded approval of the agreement. Amundson, Smoyer, Schorr, Raybould and Hudkins voted aye. Motion carried 5-0.

U. Interlocal agreement with the Office of Probation of Administration in the amount of \$7,000 for electronic monitoring services as part of the operation of the Lancaster County Juvenile Drug Court. Term of the agreement is July 1, 2013, to June 30, 2014. (C-13-0332)

MOTION: Schorr moved and Smoyer seconded approval of the agreement. Smoyer, Schorr, Raybould, Amundson and Hudkins voted aye. Motion carried 5-0.

V. Execution of Business Elite Online Reporting Enrollment form for Wells Fargo Bank.

MOTION: Smoyer moved and Raybould seconded approval to execute the form. Schorr, Raybould, Amundson, Smoyer and Hudkins voted aye. Motion carried 5-0.
