The location announcement of the Nebraska Open Meetings Act was given and the meeting was called to order at 10:30 a.m.

MOTION: Smoyer moved and Raybould seconded approval of the minutes. Schorr, Raybould, Amundson, Smoyer and Hudkins voted aye. Motion carried 5-0.

MOTION: Raybould moved and Schorr seconded approval of the claims. Raybould, Amundson, Smoyer, Schorr and Hudkins voted aye. Motion carried 5-0.

A. Amusement license application from Kramer Bar & Grill to hold a street dance at 11365 W. Kramer Street on August 24, 2013. (See 4A, 4B and 4C for correlating items.)

The Chair opened the public hearing. Since no one appeared to testify, the Chair closed the public hearing.

Mike Roth, Kramer Bar & Grill, said the street dance, featuring the band Cactus Hill, would be the first one to be held in eleven years. Youth groups will be selling pop at the dance with some of those proceeds given back to the youth.

D. Amusement license renewal application from Community CROPS to hold a fundraiser event at 3130 N. 112th Street, Lincoln, on August 17, 2013.

Andrea Anthony, Community CROPS (Combining Resources Opportunities and People for Sustainability), said the annual fundraiser would feature twelve local vendors. It is the first event at their new farm site and has already sold around 200 tickets.

N. Agreement with the University of Nebraska, Board of Regents and the Lincoln Housing Authority for operation of the Nutrition Education Program to address the nutritional needs of certain limited income persons living in urban housing in Lancaster County. The County will pay \$24,074 for the services which will be provided by the University. The Housing Authority will pay \$10,519 for the services, combined with \$10,544 from the United States Department of Agriculture (USDA) Supplemental Nutrition Assistance Program. Term of the agreement is September 1, 2013, to August 31, 2014. (C-13-0384)

MOTION: Schorr moved and Raybould seconded approval of the agreement. Smoyer, Schorr, Raybould, Amundson and Hudkins voted aye. Motion carried 5-0.

O. Resolution in the matter of dissolution of the Ridgewood Road Improvement District. (R-13-0047)

MOTION: Raybould moved and Smoyer seconded approval of the resolution. Schorr, Raybould, Amundson, Smoyer and Hudkins voted aye. Motion carried 5-0.

P. Resolution authorizing the installation of a School Bus Stop Ahead sign on Olive Creek Road, 500 feet east of 17301 Olive Creek Road for westbound traffic in Lancaster County, Nebraska. (R-13-0048)

MOTION: Raybould moved and Smoyer seconded approval of the resolution. Raybould, Amundson, Smoyer, Schorr and Hudkins voted aye. Motion carried 5-0.

Q. Approval of a cost increase under County Contract C-13-0077 for power line facility relocation for a road grading project on S. 98th Street from Van Dorn Street to A Street; Project C55-KP-412(3). The original cost estimate was \$130,207 and the actual cost is \$144,164.

Brittany Behrens, Deputy County Attorney, said utility relocation agreements include a cost estimate and the County's share; anything in addition to the cost estimate must be approved by the County Board. In this instance, the utilities were more difficult and more costly than estimated to move. She said there was no corresponding documentation to sign for this item.

MOTION: Schorr moved and Amundson seconded approval of the cost increase. Amundson, Smoyer, Schorr, Raybould and Hudkins voted aye. Motion carried 5-0.

 R. Contract between Bauer Built Tire & Service, Lancaster County and the City of Lincoln for tires, tubes and tire repair services. Term of the contract is August 1, 2013, to July 31, 2014. (C-13-0378)

MOTION: Amundson moved and Raybould seconded approval of the contract. Smoyer, Schorr, Raybould, Amundson and Hudkins voted aye. Motion carried 5-0.

 S. Contract between Cross-Dillon Tire, Lancaster County and the City of Lincoln for tires, tubes and tire repair services. Term of the contract is August 1, 2013, to July 31, 2014. (C-13-0379)

MOTION: Raybould moved and Amundson seconded approval of the contract. Schorr, Raybould, Amundson, Smoyer and Hudkins voted aye. Motion carried 5-0.

T. Unit price contract between Gregg Electric Company, Lancaster County, the City of Lincoln and the Lincoln-Lancaster County Public Building Commission for emergency and large-scale electrical services. Term of the contract is one year from the date of execution by all parties. (C-13-0380)

MOTION: Raybould moved and Schorr seconded approval of the contract. Raybould, Amundson, Smoyer, Schorr and Hudkins voted aye. Motion carried 5-0.

U. Unit price contract between Commonwealth Electric Company of the Midwest, Lancaster County, the City of Lincoln and the Lincoln-Lancaster County Public Building Commission for emergency and large-scale electrical services. Term of the contract is one year from the date of execution by all parties. (C-13-0381)

MOTION: Schorr moved and Raybould seconded approval of the contract. Amundson, Smoyer, Schorr, Raybould and Hudkins voted aye. Motion carried 5-0.

V. Federal equitable sharing agreement and annual certification for the Lancaster County Sheriff's Office regarding equitable sharing activity of drug forfeiture funds for the fiscal year ending June 30, 2013. (C-13-0385)

MOTION: Smoyer moved and Raybould seconded approval of the agreement and certification. Smoyer, Schorr, Raybould, Amundson and Hudkins voted aye. Motion carried 5-0.

W. Agreement with Counseling Affiliates of Nebraska, LLC, for specialized serves at the Community Mental Health Center and the Lancaster County Mental Health Center Sex Offender Treatment Program to assist with mental health services. The County will pay up to \$7,500 per month for the services provided. Term of the agreement is July 1, 2013, to June 30, 2014. (C-13-0382)

Schorr questioned if there was a termination clause in the agreement. Brittany Behrens said there is a 30-day termination provision in Paragraph 11, which is standard for the Community Mental Health Center contracts.

MOTION: Raybould moved and Amundson seconded approval of the agreement. Schorr, Raybould, Amundson, Smoyer and Hudkins voted aye. Motion carried 5-0.

X. Agreement with Region V Systems for Emergency Protective Custody (EPC) services at the Mental Health Crisis Center. Region V will enter into separate agreements with referring counties who will send acutely mentally ill individuals to Lancaster County. The County will be paid \$119 per individual for the County fee and \$53 from the rural pool for each individual. Term of the agreement is July 1, 2013, to June 30, 2014. (C-13-0386)

MOTION: Smoyer moved and Raybould seconded approval of the agreement. Raybould, Amundson, Smoyer, Schorr and Hudkins voted aye. Motion carried 5-0.

 Y. Agreement with the Child Guidance Center for internal case management and evaluation services at the Youth Services Center. The County will pay \$64,791.68 for the services. Term of the agreement is August 1, 2013, to June 30, 2014. (C-13-0383)

MOTION: Schorr moved and Raybould seconded approval of the agreement. Amundson, Smoyer, Schorr, Raybould and Hudkins voted aye. Motion carried 5-0.
