The Chair noted the location of the Open Meetings Act and opened the meeting at 8:30 a.m.

AGENDA ITEM

1 APPROVAL OF THE STAFF MEETING MINUTES OF THURSDAY, APRIL 11, 2013

MOTION:

Smoyer moved and Raybould seconded approval of the minutes of the April 11, 2013 Staff Meeting. Smoyer, Schorr and Hudkins voted aye. Raybould abstained from voting. Amundson was absent from voting. Motion carried 3-0, with one abstention.

2 ADDITIONS TO THE AGENDA

A. Letter from Lower Platte South Natural Resources District (NRD)
Regarding Multi-Jurisdictional Hazard Mitigation Plan Update (Exhibit A)

MOTION:

Smoyer moved and Raybould seconded approval of the addition to the agenda. Raybould, Schorr, Smoyer and Hudkins voted aye. Amundson was absent from voting. Motion carried 4-0.

3 LEGISLATIVE UPDATE - Gordon Kissel, Kissel/E&S Associates (Legislative Consultant)

Gordon Kissel, Kissel/E&S Associates, presented a legislative update and a bills of interest report (Exhibits B and C).

Raybould noted Juvenile Court Judge Reggie Ryder sent a letter to Nebraska Supreme Court Chief Justice Heavican expressing concerns regarding Legislative Bill (LB) 464 (Change court jurisdiction over juveniles and indictment procedures) and asked whether his concerns have been addressed. Kissel said it will be difficult to make changes at this point as the bill is on Select File.

Hudkins inquired about LB 632, which would eliminate responsibility for counties to pay the Department of Health and Human Services' (HHS') rent. Kissel said discussions are ongoing with Senator Bolz and Senator Avery, proponents of the bill. Raybould said some counties have stated it is a financial hardship and indicated they can no longer fulfill the obligation. She suggested that is an option Lancaster County may want to pursue.

Kerry Eagan, Chief Administrative Officer, referred to LB 561 (State findings and intent for changes to the juvenile justice system and a funding mechanism) and said the requirement that the State is responsible for costs after 10 days when a youth in custody is sent out for evaluation has been deleted from the latest version of the bill. He said that would be a significant loss of revenue for the County. Kissel agreed to follow-up on the bill and will report back.

4 ADDITIONAL APPROPRIATIONS FOR FISCAL YEAR 2012-2013 - Dennis Meyer, Budget and Fiscal Officer

Dennis Meyer, Budget and Fiscal Officer, discussed a letter to all County departments regarding additional appropriations for Fiscal Year 2012-2013 and the year-end expenditure cut-off.

MOTION: Smoyer moved and Raybould seconded to authorize the letter to be sent. Schorr, Smoyer, Raybould and Hudkins voted aye. Amundson was absent from voting. Motion carried 4-0.

Meyer said a resolution to amend the budgets for the Budget and Fiscal Office and Juvenile Court will be scheduled on the April 23, 2013 County Board of Commissioners Meeting agenda.

ADDITIONS TO THE AGENDA

A. Letter from Lower Platte South Natural Resources District (NRD)
Regarding Multi-Jurisdictional Hazard Mitigation Plan Update (Exhibit A)

Board consensus was to appoint Doug Ahlberg, Emergency Management Director, to represent the County at the hazard identification meetings.

ADMINISTRATIVE OFFICER REPORT

A. Blood Chemistry Profiles and Health Risk Appraisals

Eagan said Sue Eckley, County Risk Manager, has asked whether the Board wants to offer the blood chemistry profiles and health risk appraisals to Community Mental Health Center (CMHC) employees as CMHC will be transitioning to a new provider in a few months.

MOTION: Raybould moved and Smoyer seconded to offer the blood chemistry profiles and health risk appraisals to Community Mental Health Center (CMHC) employees. Raybould, Schorr, Smoyer and Hudkins voted aye. Amundson was absent from voting. Motion carried 4-0.

B. County Extension Board Appointment (Martha A. Minchow)

The Board scheduled the appointment on the April 23, 2013 County Board of Commissioners Meeting agenda.

DISCUSSION OF BOARD MEMBER MEETINGS

B. Parks and Recreation Advisory Board - Hudkins

Hudkins reported on the planned purchase of additional park land at 98th and Adams Streets and renovations to Sherman Field (ballpark) at Sampson Park. He said he renewed an offer to have jail inmate crews assist with parks maintenance, if the Parks and Recreation Department will provide supervision.

5 COUNTY ASSESSOR/REGISTER OF DEEDS MOTOR VEHICLE PURCHASES - Norm Agena, County Assessor/Register of Deeds; Rob Ogden, Chief Field Deputy Assessor/Register of Deeds; Terry Wagner, Lancaster County Sheriff

Terry Wagner, Lancaster County Sheriff, said vehicles that have between 80,000 to 100,000 miles are removed from patrol duty and used for prisoner transportation or

civil process. He said they are offered to other county agencies when they have 130,000 or more miles, noting the Assessor's Office has received a number of those vehicles.

Norm Agena, County Assessor/Register of Deeds, said 12 of the vehicles in his fleet are an average of 14 years old. He said maintenance costs average \$600 per vehicle and said he has concerns about sending employees out in the vehicles. Agena requested authorization to purchase six new Ford Fiesta vehicles at an estimated cost of \$11,000 to \$12,000 each, noting the last time the department purchased new vehicles was 1996. He said the purchase could be funded with \$74,000 remaining in this year's budget from vacancy savings. The vehicles that would be removed from the department's fleet would be auctioned off.

Schorr asked Agena whether he has looked at the inventory list of CMHC's vehicles. Agena said those vehicles are in worse condition than the vehicles he is looking to replace. Wagner said CMHC's vehicles have around 200,000 miles each and are at the end of their useful life.

Raybould noted asked whether some employees would prefer to use their own vehicle and be reimbursed by the County. Agena said there are liability issues.

MOTION: Raybould moved and Schorr seconded to approve the County Assessor's request to purchase new vehicles, in accordance with what the department's budget will allow. Smoyer, Raybould, Schorr and Hudkins voted aye. Amundson was absent from voting. Motion carried 4-0.

DISCUSSION OF BOARD MEMBER MEETINGS

C. Lincoln Independent Business Association (LIBA) Budget Monitoring Committee - Smoyer

Smoyer said the discussion focused primarily on indigent burials and the Railroad Transportation Safety District (RTSD). He said the Committee does not support Mayor Beutler's suggestion that the County Board either quit using part of the RTSD's taxing authority to help solve the County's budget problems or quit funding the RTSD entirely. The Mayor felt that would allow the City to spend an additional \$2,000,000 a year on the South Beltway Project.

D. District Energy Corporation (DEC) - Hudkins, Schorr

Hudkins said they approved a resolution to expand the DEC facility that will serve the Haymarket arena to allow for installation of an additional boiler and chiller, noting the project will still come in under budget.

6 COUNTY CLERK'S WEBSITE - Dan Nolte, County Clerk; Tim Genuchi, Accounting Operations Manager; Melissa Virgil, Board of Equalization (BOE) Specialist

Dan Nolte, County Clerk, said he read an article about a county that showed where property tax dollars were going. He said he asked Tim Genuchi, Accounting Operations Manager, how he did that for Lancaster County and Genuchi explained there are several different methods and formulas that can be used. Nolte then asked Melissa Virgil, who serves as the department's webmaster, how to put it out on the County Clerk's webpage and she worked with Information Services (IS) to develop a calculator. He said a property owner will be able to enter their value and it will calculate the amount of County taxes and show how they are split between the General Fund agencies (Exhibit D). He said the department is ready to move forward but wanted to update the Board first. Schorr suggested it also be listed in the "What's New" section on the County's web site.

In response to a question from Raybould, Genuchi said they decided to limit it to the General Fund agencies to keep it simple. Smoyer suggested that they show a tax statement and highlight the portion that represents the County.



Dear Chair Hudkins:

The NRD has secured grant funding from the Federal Emergency Management Agency (FEMA) and is in the process of updating the NRDs Hazard Mitigation Plan with assistance from JEO Consulting Group, Inc of Lincoln, NE. You are receiving this letter because your jurisdiction is eligible and encouraged to participate in this planning effort to update the plan, which has multiple benefits for your community.

A hazard mitigation plan identifies the vulnerability of a jurisdiction to various natural hazards (flood, drought, earthquake, wildfire, winter storm, etc.) and assesses the potential losses associated with each hazard. In addition, the plan identifies mitigation alternatives to decrease the threat from identified hazards and establishes a prioritized list of these mitigation projects.

The LPSNRD's existing plan was approved by FEMA on August 2009 and will expire on August 2014. FEMA requires that the plan must be updated and approved within a five year period. Typical plan takes 12 months to 18 months to complete and obtain FEMA approval. The plan will include hazard assessments for all eligible participants. The eligible participants will include: Counties, Cities, Villages, School Districts, Rural Water Districts, etc.

Through this update of plan, LPSNRD is planning to take the plan beyond FEMA minimum standards. In a 'traditional' plan, typical mitigation projects include very minimal information on project components. The updated plan will incorporate more detailed project recommendations for post-plan implementation and hopefully FEMA assistance. Proposed mitigation projects will be screened based upon criteria for feasibility of FEMA and other potential funding.

Once the updated plan is approved by FEMA, and adopted by each participant, projects may be eligible for federal cost-share assistance. Project examples include: drainage and stormwater infrastructure improvements, warning sirens, assistance with educational activities, storm shelters, bridge elevation improvements, and a number of other possible mitigation activities. Participants will become eligible to receive a cost-share at a 75/25 ratio (75% federal and 25% local) for qualifying projects.



As required by FEMA to be included in the plan at least one 'designated representative' from your jurisdiction must be present at one of the upcoming public meetings.

Two 'Hazard Identification' Meetings will be held:

- May 16, 2013 at 5:30 PM at the Lower Platte South NRD Office 3125 Portia St, Lincoln, NE; and
- May 30, 2013 at 7:00 PM at Weeping Water City Hall 101 West Eldora Avenue, Weeping Water, NE

We highly encourage you to participate in this project.

RE: Weekly Update on the 2013 Legislature

Please accept this as the tenth weekly report for the 2013 Legislative Session. Today is the sixty-second day of the 90-day session. As previously mentioned, the Legislature continues to work long days beginning at 9am, recessing for lunch, reconvening at 130pm and concluding daily business around 530pm or 630pm.

After reconvening on Tuesday, the Legislature has spent all of its time debating two measures – LB577 and LB579. LB577 is detailed more below and LB579 would add additional State Patrol officers for liquor control and enforcement.

LANCASTER COUNTY PRIORITIES:

- 1. Oppose Elimination of the inheritance tax. As we have reported previously no bills were introduced to eliminate the inheritance tax. Senator Wightman's LB600 the bill that would lower rates of taxation was heard on Wednesday, February 27, 2013 before the Revenue Committee and Chairman Hudkins testified in opposition. The bill has not advanced and was not prioritized. We believe that there will be some component of review of the inheritance tax under the LB613 review.
- 2. Support Expansion of Medicaid under the Affordable Care Act. LB577 was debated on Monday and Tuesday of this week. The bill faced significant opposition on the floor of the Legislature. Concern about unintended cost and long term sustainability of the program were raised prior to and during debate. Ultimately, there were not the votes committed to invoking cloture over the opponent's filibuster. Therefore the bill was debated until 4pm yesterday and then pulled from Legislative consideration. No vote was taken on the measure. I would like to thank both Commissioner Schorr and Commissioner Raybould for their efforts both inside and outside the rotunda for their lobbying efforts. I am confident that if a vote would

- have occurred we would have had a near-unanimous vote of support for the bill by the Lancaster County delegation.
- 3. Eliminate Responsibility of Counties to Pay HHS Rent. LB632 was referred to the Government, Military and Veterans Affairs Committee and public hearing was held on Wednesday, March 6, 2013. Mr. Eagan appeared in support along with NACO. The Department appeared in opposition through Kerry Winterer. Senator Bolz has provided the list to Senator Avery that was referenced in last weeks' report. There are further conversations occurring on this bill.
- 4. Modify Right to Court Appointed Attorney in Juvenile Court. LB342 was referred to the Judiciary Committee and public hearing held on March 6, 2013. Liz Neely appeared on behalf of the county along with NACO. There was no opposition. We are pleased to report that the bill has been advanced by the Judiciary Committee and Senator Coash has requested Consent Calendar status for the bill.
- 5. Definition and Oversight for Staff Secure Juvenile Detention Facilities. LB86 was referred to the Judiciary Committee and hearing held on March 7, 2013. Sheli Schindler appeared on behalf of the county along with NACO and Sarpy County. In the first amendment to LB561, the language from this bill was included. The amendment to LB561 presented to us last week does continue to include the language from LB86.

OTHER LEGISLATION:

- 1. **LB63 (Schilz) Change distribution of certain sales and use tax revenue.** *NO POSITION.* Brent Meyer recommends that we support this legislation because it will provide additional funding for aquatic invasive plants. It diverts ½ of the sales tax and registrations fees from motorboats to create a special fund. It was heard on March 14, 2013 before the Revenue Committee and there was a significant amount of support with no opposition. We do not expect this bill to advance.
- 2. **LB123 (Lautenbaugh) Change distribution of indigent defense fees.** *OPPOSE.* This hearing was held on January 25, 2013 before the Judiciary Committee. This bill was indefinitely postponed by the Judiciary Committee.
- 3. **LB215 (Schilz) Change provisions relating to use of the County Visitors Promotion Fund.** *OPPOSE/NEUTRAL WITH AMENDMENT.* As previously reported, an amendment was offered to the committee during the hearing February 13, 2013 that addressed the concerns raised by Lancaster County. The bill has advanced with the amendment agreed to by Lancaster County. Please note that this bill was not prioritized but could be eligible for the Consent Calendar.
- 4. LB284 (Conrad) Change provisions of the Political Subdivisions Tort Claims Act relating to actions and amounts recoverable. *OPPOSE*. Referred to the Judiciary Committee, the hearing was on February 13, 2013. Lancaster County submitted a letter in opposition to the bill. We expect the bill to advance from that committee but have not yet. Please note that this bill was not prioritized.
- 5. **LB317** (Price) Change a duty of county assessors relating to real property valuation. *OPPOSE*. This bill was heard by the Revenue Committee on March 21, 2013 and



- both NACO and Douglas County appeared in opposition. Mr. Agena indicated during a previous meeting that he may need an additional 8 people and \$700,000 to comply with this legislation. This bill was not prioritized and has not been advanced by the Revenue Committee.
- 6. **LB348 (Harr) Change provisions relating to the assessment of certain rent-restricted housing projects.** *NO POSITION.* The hearing was held on March 1, 2013. As you will recall, we indicated that we would not oppose this legislation. The bill has advanced and was declared a speaker priority.
- 7. **LB381 (Janssen) Require photographic identification to vote.** *NO POSITION.* Introduced by Senator Charlie Janssen, the bill was referred to the Government Committee and hearing was held on March 7, 2013. Please note that this bill was not prioritized.
- 8. **LB483 (Bolz) Provide for a reentry planning program in adult correctional facilities.** *SUPPORT.* This measure was heard before the Judiciary Committee on Friday, February 22, 2013. A letter of support was submitted to the Committee. It has been declared a speaker priority.
- 9. LB613 (Schumacher) Create the Tax Modernization Commission. NO POSITION. This bill was heard by the Executive Board of the Legislative Council on February 19, 2013. It was prioritized by Senator McCoy and will be amended to allow for the Revenue Committee chairman to serve as chair of that Committee. The bill has been the subject of a filibuster by Senator Chambers for several days and cloture was invoked yesterday. The study will move forward. An amendment has been filed by Senator Krist that would place a moratorium on both occupation taxes enacted by cities and on the additional one-half cent of sales tax that was passed last year. The bill has not yet come up for Select File debate.
- 10. **LB636 (Wallman) Provide restrictions for application of certain herbicides.**OPPOSE. This legislation was heard on March 5, 2013 before the Agriculture Committee. We do not expect this bill to move. Please note that this bill was not prioritized.
- 11. **LB246 (Larson) Provide for a health care copayment for jail and prison inmates.** *NO POSITION.* The hearing was held on February 7, 2013 before the Judiciary Committee. We do not expect this bill to move. Please note that this bill was not prioritized.
- 12. **LB531 (Conrad) Change distribution of sales and use tax revenue and repeal the Build Nebraska Act.** *NO POSITION.* The hearing was held on February 27, 2013 before the Revenue Committee with significant opposition. Please note that this bill was not prioritized.
- 13. **LB561 (Ashford) State findings and intent for changes to the juvenile justice system and a funding mechanism.** *NO POSITION.* The hearing on this bill was held on March 7, 2013 before the Judiciary Committee and is the Judiciary Committee priority bill. As previously mentioned, we have been working with Mr. Eagan, Ms. Thorpe and Ms. Schindler to develop concepts that would address Lancaster County's concerns with the original amendments thereto. We met this week with the aforementioned staff to review the latest amendments to LB561 and have



discovered only one change that we would like to request. We have discussed that change with the proponents and they believe that it is otherwise covered under other sections of the bill. We continue to work with them.

Lancaster County Clerk Where Do Your County Tax Dollars Go?

When owners of real estate pay property taxes, the amount is divided among several government entities such as the county, a city or village, a school district and several others.
