The location announcement of the Nebraska Open Meetings Act was given and the meeting was called to order at 10:30 a.m.

1) MINUTES: Approval of the minutes of the Board of Commissioners meeting held on Tuesday, January 21, 2014.

MOTION: Smoyer moved and Amundson seconded approval of the minutes. Schorr, Amundson, Smoyer and Hudkins voted aye. Raybould was absent. Motion carried 4-0.

2) **CLAIMS:** Approval of all claims processed through Tuesday, January 28, 2014.

MOTION: Amundson moved and Smoyer seconded approval of the claims. Amundson, Smoyer, Schorr and Hudkins voted aye. Raybould was absent. Motion carried 4-0.

3) **SPECIAL PRESENTATION:**

A. County Sheriff 2014 Employee Recognition Awards

Terry Wagner, County Sheriff, and Jeff Bliemeister, Chief Deputy Sheriff, presented the awards.

4) **PUBLIC HEARINGS**:

- A. County Text Amendment No. 13013 to amend Lancaster County Zoning Resolution Articles 2, 4 and 13 to allow commercial composting operations by special permit in the AG Agricultural District. (See 5A for correlating item.)
- B. County Special Permit No. 13051 to allow a commercial composting operation at S. 134th Street and Pella Road. (See 5B for correlating item.)

The Chair opened the public hearings.

Sara Hartzell, County Planner, was administered the oath. She said the text amendment would add a definition for commercial composting facilities, as well as sub-definitions for compost and organic materials; add commercial composting facilities as a specially permitted use in the AG district; and add conditions to be reviewed for commercial composting. These conditions include information on the composting operation and on-site buildings used; a minimum separation of 750 feet from residential buildings not used as part of the facility; information on vehicle types, paths and daily estimate; visual screening; and final action by the County Board. If the composting facility reaches 1,000 cubic yards per year, a permit must be approved by the State of Nebraska Department of Environmental Quality (DEQ).

Hartzell said the special permit would allow Prairieland Dairy to have up to 100,000 cubic yards of composting total. Five trucks per day are estimated with the anticipated route being from Firth Road (paved) along 134th Street. If they significantly exceed five trucks per day, Prairieland Dairy would notify the County Engineer who would check the road condition. If the condition is not good, Prairieland Dairy has agreed to enter into a maintenance agreement with the County Engineer. In addition, Hartzell discussed the layout of the property, distance from residential buildings and the nearest non-related dwelling, screening provided by the buildings and rise in land, and work done with Norris School to compost food waste.

Hartzell said the Planning Commission held a public hearing, and both the text amendment and special permit received unanimous recommendation. There was some testimony in support with the main concern being odor and traffic.

Schorr asked what type of review was in place for the operation and if the permit was permanent. Hartzell said the permit does not have an expiration date. DEQ monitors the facility on a continuous basis, the Health Department handles any nuisance issues, the County Engineer handles the roads and Building & Safety monitors the buildings.

Dan Rice, Prairieland Dairy, was administered the oath. He said their farm has been composting for a while and now are starting with food waste. They are approaching the 1,000 cubic yards permitted under the dairy permit through the DEQ and are trying to be proactive for future needs. Rice discussed the amount of food waste in landfills and routing of trucks on Firth Road.

In response to Hudkins, Rice said their farm is classified as a confined animal feeding operation (CAFO) with 1,000 head in one location, which involves permitting through the Environmental Protection Agency (EPA). He noted that nine families are involved with the farm. Rice promoted Prairieland Dairy Day, which is held on the last weekend of June with around 5,000 people attending and 100 people volunteering.

PUBLIC HEARINGS CONTINUED:

The Chair closed the public hearings.

5) **NEW BUSINESS**:

A. Resolution in the matter of County Text Amendment No. 13013, text amendment to the Lancaster County Zoning Resolution to amend Articles 2, 4 and 13 as provided in Attachment A. (R-14-0007)

MOTION: Amundson moved and Smoyer seconded approval of the resolution. Schorr, Amundson, Smoyer and Hudkins voted aye. Raybould was absent. Motion carried 4-0.

B. Resolution in the matter of County Special Permit No. 13051, granting authority to allow a commercial composting operation on property generally located at S. 134th Street and Pella Road, Lancaster County, Nebraska. (R-14-0008)

MOTION: Smoyer moved and Amundson seconded approval of the resolution. Amundson, Smoyer, Schorr, Raybould and Hudkins voted aye. Raybould was absent. Motion carried 4-0.

C. Exceptional circumstance award under the provisions of Personnel Rule 17.9(b) for Nicole Preister, Community Corrections Case Worker – Drug Court, for a one-step salary increase from Step 6 (\$20.036 per hour) to Step 7 (\$20.756 per hour).

MOTION: Schorr moved and Smoyer seconded approval of the exceptional circumstance award. Amundson, Smoyer, Schorr and Hudkins voted aye. Raybould was absent. Motion carried 4-0.

D. Setting the salary of Teresa Nutzman, Deputy Public Defender, at \$37,900 per year, effective January 28, 2014.

MOTION: Amundson moved and Smoyer seconded approval of the salary. Smoyer, Schorr, Amundson and Hudkins voted aye. Raybould was absent. Motion carried 4-0.

E. Setting the salary of Abbi Romshek, Deputy Public Defender, at \$59,178 per year, effective February 3, 2014.

Schorr noted this is not a new position, but a replacement for an employee who is leaving.

MOTION: Amundson moved and Smoyer seconded approval of the salary. Schorr, Amundson, Smoyer and Hudkins voted aye. Raybould was absent. Motion carried 4-0.

F. Agreement with U.S. Bank National Association for banking services. (C-14-0042)

Bill Jarrett, Deputy County Treasurer, discussed the process involved in setting up the new agreement and noted it would save around \$105,000 over three years.

Schorr questioned the timeline for the transition and if it would be seamless to constituents. Michelle Raphael, County Treasurer's Office, said implementation would begin as soon as the contracts are executed. Jarrett added that citizens would not notice any changes.

NEW BUSINESS CONTINUED:

Jarrett introduced Greer Almquist, US Bank, who thanked the County for using their services.

MOTION: Schorr moved and Smoyer seconded approval of the agreement. Amundson, Smoyer, Schorr and Hudkins voted aye. Raybould was absent. Motion carried 4-0.

G. Deposit placement agreement and custodial agreement with Security First Bank for insured cash sweep services. (C-14-0043)

MOTION: Schorr moved and Smoyer seconded approval of the agreement. Amundson, Smoyer, Schorr and Hudkins voted aye. Raybould was absent. Motion carried 4-0.

H. Utility relocation agreement with Windstream Nebraska, Inc., to relocate communication facilities for a road grading project on Pine Lake Road between S. 112th Street and S. 148th Street; Project C55-Q-409(1). (C-14-0044)

MOTION: Amundson moved and Smoyer seconded approval of the agreement. Smoyer, Schorr, Amundson and Hudkins voted aye. Raybould was absent. Motion carried 4-0.

1. Recommendation from the County Engineer to award a bid to Theisen Construction, Inc., in the amount of \$29,563.75 for repair of County Bridge C-284. (B-14-0005)

Pam Dingman, County Engineer, said this bridge is one of several in the County that needs to be monitored and repaired.

MOTION: Smoyer moved and Amundson seconded approval of the recommendation. Schorr, Amundson, Smoyer and Hudkins voted aye. Raybould was absent. Motion carried 4-0.

J. Recommendation from the Purchasing Agent and the County Engineer to issue a purchase order to Sid Dillon Ford Lincoln Mercury, Inc., at an estimated cost of \$103,840 for four 2014 Ford F-250 trucks from the State of Nebraska Contract 13600 OC. (B-14-0006)

Pam Dingman said there were five trucks budgeted, but she chose to return one.
