The Chair called the meeting to order at 10:30 a.m. The pledge of allegiance was recited and the location of the Nebraska Open Meetings Act was announced.

1) MINUTES: Approval of the minutes of the Board of Commissioners meeting held on Tuesday, March 11, 2014.

**MOTION:** Raybould moved and Schorr seconded approval of the minutes. Schorr, Raybould and Smoyer voted aye. Amundson abstained. Hudkins was absent. Motion carried 3-0 with one abstention.

2) CLAIMS: Approval of all claims processed through Tuesday, March 18, 2014.

**MOTION:** Schorr moved and Amundson seconded approval of the claims. Raybould, Amundson, Schorr and Smoyer voted aye. Hudkins was absent. Motion carried 4-0.

# 3) **PUBLIC HEARING:**

A. Class IK liquor license for Prairie Plate Restaurant, 10405 Branched Oak Road, Waverly. (See 4A for correlating item.)

The Vice Chair continued the public hearing from last week. Since no one appeared to testify, the Vice Chair closed the public hearing.

# 4) **NEW BUSINESS**:

A. Resolution in the matter of an application for a Class IK liquor license for Prairie Plate Restaurant, LLC, located at 10405 Branched Oak Road, Waverly, Lancaster County, Nebraska. (R-14-0014)

**MOTION:** Schorr moved and Raybould seconded approval of the resolution. Schorr, Raybould, Amundson and Smoyer voted aye. Hudkins was absent. Motion carried 4-0.

B. Recommendation from the County Engineer to award a contract to H.R. Bookstrom Construction, Inc., in the amount of \$187,999 for culvert maintenance and replacement. (B-14-0013)

**MOTION:** Raybould moved and Amundson seconded approval of the recommendation. Schorr, Raybould, Amundson and Smoyer voted aye. Hudkins was absent. Motion carried 4-0.

C. Recommendation from the County Engineer to award a contract to K2 Construction in the amount of \$126,193.30 for culvert maintenance and replacement. (B-14-0014)

**MOTION:** Amundson moved and Schorr seconded approval of the recommendation. Raybould, Amundson, Smoyer and Schorr voted aye. Hudkins was absent. Motion carried 4-0.

D. Recommendation from the Purchasing Agent to award a bid to Eagle Services in the amount of \$4,000 (four-year term) for portable chemical toilets. (B-14-0015)

**MOTION:** Amundson moved and Raybould seconded approval of the recommendation. Amundson, Schorr, Raybould and Smoyer voted aye. Hudkins was absent. Motion carried 4-0.

E. Amendment to County Contract C-11-0199 with Swarco Reflex, Inc., for the annual supply of glass pavement marking beads. The amendment renews the agreement for an additional one-year term from March 1, 2014, to February 28, 2015. (C-14-0146)

**MOTION:** Schorr moved and Amundson seconded approval of the amendment. Schorr, Raybould, Amundson and Smoyer voted aye. Hudkins was absent. Motion carried 4-0.

F. Agreement with Jennifer Blankenship for class instruction to participants in Lancaster County Community Corrections programs. The County will pay \$22 per hour for up to 20 hours per week. Term of the agreement is March 1, 2014, to June 30, 2015. (C-14-0147)

**MOTION:** Raybould moved and Amundson seconded approval of the agreement. Schorr, Raybould, Amundson and Smoyer voted aye. Hudkins was absent. Motion carried 4-0.

### **NEW BUSINESS CONTINUED:**

G. Agreement with the Village of Firth for the provision of law enforcement services by the Lancaster County Sheriff to the Village. Term of the agreement is April 1, 2014, to March 31, 2015, and shall automatically renew for additional one-year periods unless terminated by either party in accordance with the agreement. (C-14-0148)

**MOTION:** Raybould moved and Schorr seconded approval of the agreement. Raybould, Amundson, Schorr and Smoyer voted aye. Hudkins was absent. Motion carried 4-0.

H. Agreement with Norris School District 160 for the provision of a school resource officer by the Lancaster County Sheriff's Office to Norris High School. Term of the agreement is August 1, 2014, to July 31, 2015, and shall automatically renew for additional one-year periods upon mutual written agreement of the parties. (C-14-0149)

**MOTION:** Amundson moved and Raybould seconded approval of the agreement. Amundson, Schorr, Raybould and Smoyer voted aye. Hudkins was absent. Motion carried 4-0.

1. Request from Mark Coleman for a determination of disability for purposes of the Lancaster County, Nebraska Employees Retirement Plan.

Kerry Eagan, Chief Administrative Officer, said the information has been reviewed by the County Attorney's Office and is recommended for approval.

**MOTION:** Schorr moved and Amundson seconded approval of the request based on the recommendation. Schorr, Raybould, Amundson and Smoyer voted aye. Hudkins was absent. Motion carried 4-0.

J. Political subdivision tort claim filed against Lancaster County Corrections by Justin Coleman in an undisclosed amount.

**MOTION:** Raybould moved and Amundson seconded denial of the tort claim based on the Corrections Director's recommendation. Schorr, Raybould, Amundson and Smoyer voted aye. Hudkins was absent. Motion carried 4-0.

K. Political subdivision tort claim filed against Lancaster County Corrections by Dan Muratella in the amount of \$150,000.

**MOTION:** Raybould moved and Amundson seconded denial of the tort claim based on the Corrections Director's recommendation. Raybould, Amundson, Schorr and Smoyer voted aye. Hudkins was absent. Motion carried 4-0.

L. Political subdivision tort claim filed against Lancaster County Corrections by Elizabeth Hogrefe in the amount of \$1,750,000.
