2) <u>MINUTES:</u> Approval of the minutes of the Board of Commissioners meeting held on Tuesday, April 1, 2014.

Amundson entered the meeting at 10:34 a.m.

**MOTION:** Smoyer moved and Raybould seconded approval of the minutes. Schorr, Raybould, Amundson, Smoyer and Hudkins voted aye. Motion carried 5-0.

3) <u>CLAIMS:</u> Approval of all claims processed through Tuesday, April 8, 2014.

**MOTION**: Raybould moved and Smoyer seconded approval of the claims. Raybould, Amundson, Smoyer, Schorr and Hudkins voted aye. Motion carried 5-0.

# 4) **NEW BUSINESS**:

A. Amusement license renewal application for Capital City Horse & Pony Club, 12900 N. 14<sup>th</sup> Street, Raymond, on August 16, 2014.

**MOTION**: Raybould moved and Smoyer seconded approval of the amusement license renewal. Amundson, Smoyer, Schorr, Raybould and Hudkins voted aye. Motion carried 5-0.

#### **NEW BUSINESS CONTINUED:**

B. Recommendation from the County Engineer to award contracts to Western Sand, Lyman-Richey, Gana Trucking and Westover Trucking in the total amount of \$150,030 for spring gravel hauling to County stockpiles. (B-14-0018)

Pam Dingman, County Engineer, said traditionally rock and gravel have been bid in two parts – one for the rock and one for the hauling. She said she is looking at collaborating with other entities, such as Saunders County or the City of Lincoln, to do one large bid for a better price.

C. Amendment to County Contract C-12-0155 with VSA, Inc., for the annual supply of cassette tapes. The amendment renews the agreement for an additional one-year term from March 27, 2014, to March 26, 2015. (C-14-0175)

D. Amendment to County Contract C-09-0160 with Whitehead Oil Company for the annual requirements of fuel (point of sale). The amendment extends the term of the agreement from March 31, 2014, to May 30, 2014. (C-14-0176)

E. Agreement between Steve McClatchey and Lancaster County, on behalf of the Lancaster County Election Commissioner, for the delivery of voting machines and other miscellaneous equipment to several polling locations for the primary election to be held on Tuesday, May 13, 2014. The agreement shall continue until May 16, 2014. The County will pay \$53 per polling location for the delivery service. (C-14-0177)

**MOTION**: Smoyer moved and Schorr seconded approval of the agreement. Amundson, Smoyer, Schorr, Raybould and Hudkins voted aye. Motion carried 5-0.

F. Agreement between Justin Coleman and Lancaster County, on behalf of Lancaster County Community Corrections, to provide psycho-educational class instruction to participants of Lancaster County's Pretrial Diversion Program. The County shall pay \$20 per hour, not to exceed 20 hours per week, for the services provided. Term of the agreement is April 1, 2014, to June 30, 2014. (C-14-0178)

**MOTION**: Raybould moved and Smoyer seconded approval of the agreement. Smoyer, Schorr, Raybould, Amundson and Hudkins voted aye. Motion carried 5-0.

G. Business associate agreement with Centerpointe for the protection and safeguarding of protected health information. (C-14-0179)

H. Deposit placement agreement and custodial agreement with Cornhusker Bank for certificate for deposit account registry services. (C-14-0181)

Bill Jarrett, Deputy County Treasurer, said Cornhusker Bank is being added to the list of banks that can provide insured cash sweep (ICS) and certificate of deposit account registry service (CDARS). He introduced Kevin Deaver, Cornhusker Bank Senior Vice President, who expressed his appreciation for the opportunity to provide the services.
