The Chair called the meeting to order at 10:30 a.m. and the location of the Nebraska Open Meetings Act was announced.

# 2) <u>MINUTES:</u> Approval of the minutes of the Board of Commissioners meeting held on Tuesday, May 13, 2014.

**MOTION:** Smoyer moved and Raybould seconded approval of the minutes. Schorr, Raybould, Amundson, Smoyer and Hudkins voted aye. Motion carried 5-0.

# 3) <u>CLAIMS:</u> Approval of all claims processed through Tuesday, May 20, 2014.

**MOTION:** Schorr moved and Raybould seconded approval of the claims. Raybould, Amundson, Smoyer, Schorr and Hudkins voted aye. Motion carried 5-0.

# A. Recognition of County Employees' service anniversaries.

The Clerk read the list of employees observing service anniversaries. William Bell, County Engineer's Office, discussed his 40 years of service and praised his co-workers for their work.

# 5) **NEW BUSINESS:**

#### A. Amusement license renewal application from Josh Kadavy to operate JK's Pumpkin Patch, 757 Bluff Road, Lincoln, from September 19-November 2, 2014.

**MOTION:** Smoyer moved and Raybould seconded approval of the amusement license renewal.

Josh Kadavy, JK's Pumpkin Patch, said his business received the 2013 Nebraska Outstanding Nature-Tourism Entity Award. He discussed the growth of the business and asked the Board to reduce the liability insurance requirement as they had in past years. *(Previously, the Board had reduced the \$5,000,000 liability requirement to \$2,000,000.)* 

Smoyer withdrew the original motion.

**MOTION:** Schorr moved and Smoyer seconded approval of the amusement license renewal with a reduction in liability insurance as in previous years. Smoyer, Schorr, Raybould, Amundson and Hudkins voted aye. Motion carried 5-0.

# B. Special designated license applications from WunderRosa Winery, 2361 Wittstruck Road, Roca, for June 28-29 and July 3-4, 2014.

**MOTION:** Raybould moved and Amundson seconded approval of the special designated licenses. Schorr, Raybould, Amundson, Smoyer and Hudkins voted aye. Motion carried 5-0.

# C. Appointment of Phillip Nalley to the Lincoln-Lancaster County Air Pollution Advisory Board for a term expiring September 1, 2016.

**MOTION:** Amundson moved and Smoyer seconded approval of the appointment. Raybould, Amundson, Smoyer, Schorr and Hudkins voted aye. Motion carried 5-0.

#### D. Approval of an amendment to Section 3 of the Lancaster County Visitors Promotion Committee By-Laws, clarifying the length of service of Committee members, effective May 20, 2014.

**MOTION:** Smoyer moved and Amundson seconded approval of the amendment. Amundson, Smoyer, Schorr, Raybould and Hudkins voted aye. Motion carried 5-0.

#### E. Approval of Lancaster County's Governmental Accounting Standards Board (GASB) Fund Balance Policy.

Dennis Meyer, Budget & Fiscal Director, said the policy will show definitions, balances available, types of funds and how funds can be moved.

**MOTION:** Amundson moved and Raybould seconded approval of the policy. Smoyer, Schorr, Raybould, Amundson and Hudkins voted aye. Motion carried 5-0.

# **NEW BUSINESS CONTINUED:**

F. Agreement with Lincoln Literacy Council to conduct on-site English language and literacy classes for Lancaster County Corrections inmates. The County will pay up to \$9,090 for the services. Term of the contract is May 1, 2014, to April 30, 2015. (C-14-0237)

Schorr clarified that funding is from the Inmate Benefit Fund and not from property tax dollars.

**MOTION:** Smoyer moved and Raybould seconded approval of the agreement. Schorr, Raybould, Amundson, Smoyer and Hudkins voted aye. Motion carried 5-0.

G. Agreement with Great Plains Appraisal Company, on behalf of Wayne Kubert and Tom Kubert, to provide the services of a referee coordinator to coordinate referees who will hear all property tax protests for the 2014 tax year before the Lancaster County Board of Equalization. The referee coordinator shall be reimbursed at a rate of \$720 per working day up to \$180,000. (C-14-0241)

**MOTION:** Smoyer moved and Amundson seconded approval of the agreement. Raybould, Amundson, Smoyer, Schorr and Hudkins voted aye. Motion carried 5-0.

H. Memorandum of understanding with the Board of Regents of the University of Nebraska, on behalf of the University of Nebraska-Lincoln, Midwest Roadside Safety Facility. The agreement confirms the County's participation in motorvehicle accident reconstruction, testing and research conducted by the Midwest Roadside Safety Facility. (C-14-0242)

**MOTION:** Raybould moved and Smoyer seconded approval of the memorandum of understanding. Amundson, Smoyer, Schorr, Raybould and Hudkins voted aye. Motion carried 5-0.

1. Amendment to County Contract C-12-0612 with Magellan Behavioral Health, Inc., for reimbursement of services at the Community Mental Health Center. The amendment removes various services no longer provided at the Community Mental Health Center. (C-14-0243)

**MOTION:** Raybould moved and Schorr seconded approval of the amendment. Smoyer, Schorr, Raybould, Amundson and Hudkins voted aye. Motion carried 5-0.

J. Agreement with Pharmerica for pharmacy services at the Youth Services Center and Mental Health Crisis Center. Term of the agreement is three years from the date of execution. (C-14-0244)

**MOTION:** Schorr moved and Raybould seconded approval of the agreement. Schorr, Raybould, Amundson, Smoyer and Hudkins voted aye. Motion carried 5-0.

Agreement between Nifco Mechanical Systems, Inc., the City of Lincoln, Lancaster County and the Lincoln-Lancaster County Public Building Commission for inspection, testing and maintenance of sprinkler alarm system and backflow preventers. L. Contract between Recycling Enterprises of NE, Inc., the City of Lincoln, Lancaster County and the Lincoln-Lancaster County Public Building Commission for recycling services. Term of the agreement is June 1, 2014 to January 31, 2015. (C-14-0246)

**MOTION:** Raybould moved and Smoyer seconded approval of the contract. Amundson, Smoyer, Schorr, Raybould and Hudkins voted aye. Motion carried 5-0.

M. Contract between New Heights Tree Service, the City of Lincoln, Lancaster County and the Lincoln-Lancaster County Public Building Commission for the annual requirement of tree trimming and removal services. Term of the contract is one year from date of execution. (C-14-0247)

**MOTION:** Schorr moved and Smoyer seconded approval of the contract. Smoyer, Schorr, Raybould, Amundson and Hudkins voted aye. Motion carried 5-0.

 N. Amendment to County Contract C-14-0155 with Hood Masters, Inc., for the annual requirements of kitchen exhaust hood and equipment cleaning services for Lancaster County Corrections. The amendment sets the annual cleaning cost at \$4,950. (C-14-0248)

Scott Gaines, Deputy County Assessor/Register of Deeds, recommended approval of all applications except for three. Family Christian, LLC, has personal property that is part of a retail store, and the Islamic Foundation of Lincoln purchased property that will remain empty for a few years. Since neither is used for a religious, educational or charitable purpose, he recommended denial. Nebraska Wesleyan University is still gathering information for their exemption, so Gaines asked to hold this application for one week.

Scott Gaines recommended approval of the changes in exemption status. In all five cases, the properties have been sold, which results in a loss of that owner's exemption. The new owner is then notified so they can make new application.

Schorr asked how long the new owner has to file for exemption. Gaines said the State Statute now requires filing by July 1 (formerly August 1).
