The Vice Chair noted the location of the Open Meetings Act and opened the meeting at 8:33 a.m.

AGENDA ITEM

- 1 APPROVAL OF THE MINUTES OF THE MAY 29, 2014 STAFF MEETING
- **MOTION:** Raybould moved and Schorr seconded approval of the minutes of the May 29, 2014 Staff Meeting. Raybould, Schorr and Smoyer voted aye. Amundson and Hudkins were absent from voting. Motion carried 3-0.

2 ADDITIONS TO AGENDA

A. 2014 Community Conversations Series Sponsored by the Community Health Endowment of Lincoln (Exhibit A)

MOTION: Raybould moved and Schorr seconded approval of the addition to the agenda. Schorr, Raybould and Smoyer voted aye. Amundson and Hudkins were absent from voting. Motion carried 3-0.

Amundson arrived at the meeting at 8:37 a.m.

3 OVERVIEW OF GEOGRAPHIC INFORMATION SYSTEM (GIS) - Jeff McReynolds, Geographic Information System (GIS) Program Manager

Jeff McReynolds, Geographic Information System (GIS) Program Manager, gave an overview of GIS, noting the following (Exhibit B):

McReynolds also noted GIS analytical and cartographic capabilities and gave examples of GIS uses throughout Lancaster County and the City of Lincoln (see Exhibit B).

Amundson inquired about security measures. McReynolds explained not all GIS data is publicly available for download.

4 NATIONAL ARTS PROGRAM GRANT - Diane Gonzolas, Public Information Officer, Citizen Information Center

Diane Gonzolas, Public Information Officer, Citizen Information Center, invited the County to join the City and Lincoln Public Schools (LPS) in participating in the National Arts Program (Exhibit C). **NOTE:** Employees, retirees and immediate family members may exhibit their work and compete for cash prizes.

Amundson suggested that County public schools also be invited to participate.

MOTION: Schorr moved and Amundson seconded to authorize Lancaster County to participate in the National Arts Program for 2015. Amundson, Schorr, Raybould and Smoyer voted aye. Hudkins was absent from voting. Motion carried 4-0.

ADDITIONS TO AGENDA

A. 2014 Community Conversations Series Sponsored by the Community Health Endowment of Lincoln (Exhibit A)

It was noted discussion regarding the Lancaster County Adult Drug Court is scheduled and Board members are invited to attend and speak about other programs and projects that provide alternatives to incarceration. Schorr agreed to speak on behalf of the Board. Amundson and Raybould also expressed interest in attending.

ACTION ITEMS

- A. Revised Budget Summary for Nebraska Crime Commission Grant -Violence Against Women Act (VAWA)
- **MOTION:** Schorr moved and Raybould seconded to authorize the electronic version of the Chair's signature on the document. Raybould, Amundson, Schorr and Smoyer voted aye. Hudkins was absent from voting. Motion carried 4-0.
 - 5 **CLAIMS REVIEW POLICY** Cori Beattie, Deputy County Clerk

Copies of the current Claims for Review Policy, dated May 10, 2005, were disseminated (Exhibit D).

Cori Beattie, Deputy County Clerk, asked whether the Board would like to institute any changes to the policy (see Item 8E in the May 29, 2014 Staff Meeting minutes for discussion of possibly exempting employees from the 90-day requirement on certain types of reimbursement requests, such as mileage).

Kerry Eagan, Chief Administrative Officer, said he believes it would be better to address the issue in the Policy Governing the Expenditure of Public Funds for Payment or Reimbursement of Actual and Necessary Expenses Incurred by County Elected Officials, Appointed Officials, Employees and Volunteers (County Resolution No. R-07-0034) and proposed the following language:

> To avoid the administrative expense of processing many small claims, employees will be allowed to accumulate mileage claims and submit them collectively, even though some of the individual claims may exceed the 90day limit for submitting claims. PROVIDED, all mileage claims must be received by the County Clerk by June 15th of the budget year during which they are incurred. Claims occurring June 15th through June 30th must be submitted by June 15th of the following budget year. Any claims for mileage not submitted in accordance with these time limits will be considered forfeited.

Schorr recommended that a reminder be included in the year-end letter to departments.

Raybould suggested it may be less expensive for departments to rent vehicles for extended travel.

MOTION: Schorr moved and Amundson seconded to direct the County Attorney's Office to draft a resolution to add the new language to the Policy Governing the Expenditure of Public Funds for Payment or Reimbursement of Actual and Necessary Expenses Incurred by County Elected Officials, Appointed Officials, Employees and Volunteers for action at a regular County Board of Commissioners Meeting. Schorr, Raybould, Amundson and Smoyer voted aye. Hudkins was absent from voting. Motion carried 4-0.

ADMINISTRATIVE OFFICER REPORT

A. Saltdogs Baseball Game Invitation from John Abel (August Dates)

Board members indicated a preference to attend the August 13th game.

- 6 **PENDING LITIGATION** Richard Grabow, Deputy County Attorney
- **MOTION:** Raybould moved and Amundson seconded to enter Executive Session at 9:27 a.m. for the purpose of protecting the public interest with regards to pending litigation.

The Chair restated the motion for the record.

ROLL CALL: Raybould, Amundson, Schorr and Smoyer voted aye. Hudkins was absent from voting. Motion carried 4-0.

- **MOTION:** Schorr moved and Raybould seconded to exit Executive Session at 9:50 a.m. Schorr, Raybould, Amundson and Smoyer voted aye. Hudkins was absent from voting. Motion carried 4-0.
 - FENCE WITHIN RIGHT-OF-WAY (NORTH 27TH STREET, SOUTH OF MILL ROAD) - Tyrol Ehlers, Property Owner; Pam Dingman, County Engineer; Ken Schroeder, County Surveyor

Ken Schroeder, County Surveyor, explained that his department recently became aware that Tyrol Ehlers, who owns property at 2385 West Mill Road in Raymond, Nebraska, removed a fence on his property that was in the County right-of-way and was replacing it with a new fence (Exhibit E). The fence had bordered Mill Road and Northwest 27th, close to 33 feet easement line. He explained the policy has been to not require property owners to move an existing fence to accommodate a right-of-way dedication and to allow them to make repairs, but if a fence is rebuilt, it is to be built on the owner's property. Schroeder said Ehlers was advised to stop building the fence, which was three quarters completed, to see if the Board would allow it to be in the right-of-way or would require it to be moved. He estimated the fence is 35 to 40 feet off the section line and said it is well within the County's right-of-way. Schroeder said the County Engineering District Supervisor talked to Ehlers a year ago, when he started putting corner posts in, and advised him of the right-of-way taking in the subdivision (60 feet of right-of-way was dedicated when the subdivision was platted).

Tyrol Ehlers explained that he didn't have a clear understanding of what right-of-way was and thought it was still his property. He added he has made a significant investment in the fence at this point.

Pam Dingman, County Engineer, said she wants to make sure a precedent is not set if the fence is allowed. She said the standard practice for building a fence would be to have the property surveyed. Dingman noted there have been instances in the past where the Board allowed a fence to remain in the right-of-way. In those cases there were signed agreements with the property owners but they were not filed against the property. She recommended that any past or future agreements that allow a fence to be in the right-of-way be filed to "run with the property" in the event the property is transferred. Dingman noted Schroeder and other members of her staff are researching the County's right-of-way and developing a database to record any changes and the intent.

Eagan said it is a principal of law that you cannot acquire an interest in the County right-of-way, adding if you build something in the right-of-way, you do so at your own peril.

MOTION: Raybould moved and Amundson seconded to direct the County Attorney's Office to develop an agreement with the property owner for the fence in the County right-of-way and to file a notice of the agreement with the Register of Deeds Office.

In response to a question from Eagan, Schroeder said the Ehlers' property is in Tier III of the Comprehensive Plan.

Smoyer asked Ehlers whether he intends to build the remaining portion of the fence on his property. Ehlers said he would prefer to continue the fencing as planned because of the way his house lies, noting it is such a small section relative to what it is already there. He said he understands he will have to move the fence, at his expense, if the County needs to expand the road. Schorr confirmed that the fence is situated far enough back as not to be a safety issue.

Amundson and Raybould felt the fence should be located on the appropriate property line as opposed to in the right-of-way. Eagan added any future property owner would get notice of this through the sale.

ROLL CALL: Amundson, Schorr, Raybould and Smoyer voted aye. Hudkins was absent from voting. Motion carried 4-0.

PRINCETON RIGHT-OF-WAY ISSUE (SOUTH 10TH & BROAD STREETS) - Pam Dingman, County Engineer

Pam Dingman, County Engineer, discussed a right-of-way issue involving South 10th Street in the unincorporated village of Princeton. She said the owner of property at 1000 Broad Street would like the right-of-way on South 10th Street, between Broad Street and Angus Boulevard, vacated because cattle trailers taking Broad Street from Highway 77 to access a bull sales barn on Angus Boulevard have difficulty making the turn from Broad Street and are cutting across the corner of her property (see map in Exhibit F). **NOTE:** South 10th Street only has 35 feet of dedicated right-of-way. Dingman said the Board could either vacate the right-of-way or ask the farmer on the other side of South 10th Street, who owns the bull operation, to donate the remaining 35 feet of right-of-way. She noted that vacating the right-of-way would force the cattle trailers and farm equipment to use Angus Boulevard, or if there is a turning radius issue on Angus Boulevard, to turn around on the cul-de-sac at the end of South 12th Street Court.

MOTION: Schorr moved and Amundson seconded to schedule a resolution to direct the County Engineer's Office to begin the road vacation process for South 10th Street, between Broad Street and Angus Boulevard, in Princeton, Nebraska. Amundson, Raybould, Schorr and Smoyer voted aye. Hudkins was absent from voting. Motion carried 4-0.

ADMINISTRATIVE OFFICER REPORT

B. Date for One and Six Year Road and Bridge Improvement Program Public Hearing

Item was held, at the request of the County Engineer.

9 **BUDGET UPDATE** - Dennis Meyer, Budget and Fiscal Officer

Dennis Meyer, Budget and Fiscal Officer, presented the following budget documents (Exhibit G):

• <u>Lancaster County, Property Tax Funded Budgets, Fiscal Year (FY)</u> 2015 Requested Compared to FY 2014 Adopted

Meyer noted a shortfall of \$6,999,979 is now projected for FY 2015. **NOTE:** The amount has increased from a projection of \$6,866,740 at the May 8th Staff Meeting.

• Lancaster County General Fund

Meyer said expenditures are increasing by \$4,946,400 and revenues are increasing by \$1,156,761. He said the transfer to the Bridge Fund (\$190,269) is an estimated number. A transfer to the Noxious Weed Control Authority (\$16,792) is projected primarily because of the pickup truck included in their budget request.

MOTION: Schorr moved and Raybould seconded to eliminate the pickup truck from the Noxious Weed Control Authority's budget request. Raybould, Schorr, Amundson and Smoyer voted aye. Hudkins was absent from voting. Motion carried 4-0.

Meyer said the Crisis Center is also projected to require a transfer (\$254,575). He said their revenues are decreasing and said the Crisis Center may be picking up expenditures that were previously covered by the Community Mental Health Center (CMHC). There was consensus to schedule further discussion with Scott Etherton, Crisis Center Director.

Raybould inquired about inheritance tax revenues. Meyer said they have dropped off considerably which impacts the General Fund balance. He said he budgeted for \$5,000,000 but the County has only received \$3,900,000. Schorr said Commissioner Hudkins indicated some of the inheritance cases were not moving as quickly through the court system as they had previously. Eagan said he spoke to Mike Thew, former Chief Deputy County Attorney, about that and Thew didn't see anything different occurring.

• Lancaster County, Request for Increase in Personnel (FY 2015)

There was consensus to schedule further discussion with the departments that have asked for additional personnel. Meyer noted those costs are not built into the projected shortfall number.

Schorr suggested the Public Defender prioritize his request for three attorneys (one in the Felony Division and two in the Juvenile Division).

Amundson noted the Sheriff has requested a System Programmer (technology support position) and Administrative Services has requested a County Information Technology (IT)/TRIM (electronic records management system) Administrator and asked whether they could be "wrapped" into one position. Thorpe felt it would be worth exploring. Raybould said several Information Services (IS) personnel are shifting from programming to support and asked whether IS could provide the services for less. Jeff Bliemeister, Chief Deputy Sheriff, appeared and said Craig Gifford, Technology Support/Operations Coordinator for IS, has indicated the cost for 1,400 hours of technology support would be \$95,000. Thorpe said the County is at a "turning point" in its use of technology and could use more support. Raybould asked that further discussion be scheduled with Steve Henderson, Chief Information Officer for IS. Thorpe noted that IS is moving in a different direction with records management on the City side.

• Region V Systems, County Contribution (Proposed)

Meyer said Lancaster County pays \$928,008 to Region V Systems for Mental Health and Substance Abuse, which is \$408,651 more than the per capita rate. There was consensus to discuss the County contribution further with C. J. Johnson, Region V Systems Administrator.

Gwen Thorpe, Deputy Chief Administrative Officer, noted Johnson has also indicated Region V won't pay for the Sex Offender Treatment Program, even though it has provided funding for the program in the past.

Smoyer, who serves on the Region V Governing Board, was asked to notify that body at their meeting on Monday that Lancaster County is seriously looking at its contribution.







All artwork entered is on exhibit through April 4 through 30 at Bennett Martin Public Library and these three libraries:



CLAIMS FOR REVIEW POLICY

MAY \$ 2005

LANCASTER COUNTY BOARD OF COMMISSIONERS LANCASTER COUNTY CLERK

The Lancaster County Clerk's Office reviews and issues warrants for all County claims which are then submitted to the Lancaster County Board of Commissioners (Board). In their review process they are required to bring to the attention of the Board any specific claim(s) that require review by the Board. Examples of claims for review include, but are not limited to the following: a claim submitted over 90 days after the time the services, which form the basis of the claim, have been performed; a claim for which there is no contract; a claim not in compliance with the County Purchasing Act; and any claim not authorized by law.

Claims for review will be handled per the following procedure:

- 1. The County Clerk's Office will notify the claimant and the office submitting the claim that it is bringing that claim to the attention of the Board.
- 2. The Board will review the claim at a Thursday Staff Meeting.
- 3. The claimant and/or office submitting the claim is encouraged to provide additional information about the claim and, if necessary, come to the Thursday Staff Meeting at which the claim will be discussed.
- 4. If the Board is satisfied that the claim meets the requirements for payment it will be included with the regular claims and scheduled for official action at a Tuesday Board Meeting.
- 5. If the Board is not satisfied that the claim meets the requirements for payment, it will be scheduled for official action at a Tuesday Board meeting under a separate agenda item. The County Clerk's Office will provide the claimant reasonable written notice of when the claim will be scheduled for official action or discussion.

If any County Elected or Appointed Official has a question regarding a particular claim, they are encouraged to contact the County Clerk's Office to discuss the claim prior to submitting the claim for payment.




A. TRANSPORTATION EXPENSES

1. <u>Air Travel</u>. When air travel has been authorized by the department head, coach fair shall be used. A department may make reservations through a travel agency and charge the tickets to Lancaster County. A traveler who wishes to take advantage of electronic tickets, shop for the lowest fare on the Internet, or call airlines directly, will be required to personally pay for the tickets and request reimbursement from the County by submitting proper documentation.

2. <u>Motor Vehicles - Privately Owned</u>. When the use of a private motor vehicle has been authorized, the owner of the vehicle shall be reimbursed at the mileage rate allowed by Neb. Rev. Stat. §81-1176 (Reissue 2008), as amended, for the most direct round-trip route to and from the destination. This amount shall not exceed the coach round-trip fare to and from that point and shall be documented by a County mileage reimbursement form. When more than one employee is traveling to the same destination, they are expected to car pool if possible in order to minimize costs.

3. <u>Local Transportation</u>. Local transportation costs, including such costs as airport limousine and taxi fare (including reasonable tips not to exceed 15% of the fare) may be To avoid the administrative expense of processing many small claims, employees will be allowed to accumulate mileage claims and submit them collectively, even though some of the individual claims may exceed the 90-day limit for submitting claims. PROVIDED, all mileage claims must be received by the County Clerk by June 15th of the budget year during which they are incurred. Claims occurring June 15 through June 30 must be submitted by June 15th of the following budget year. Any claims for mileage not submitted in accordance with these time limits will be considered forfeited.






