The Chair called the meeting to order at 10:33 a.m., the pledge of allegiance was recited and the location of the Nebraska Open Meetings Act was announced.

A. Special events permit application from Tiger Coaching & Personal Training, Inc., to hold the Last Blast Lincoln Triathlon on September 20, 2015, at the Branched Oak State Recreation Area.

Gary Bredehoft, Tiger Coaching & Personal Training, informed the Board that it is the fourth year for the Last Blast Triathlon and they are expecting 200 participants. The triathlon serves as a fundraiser for the YMCA – Strong Kids Foundation. The event has raised over \$10,000 for the foundation.

D. Recommendation from the Purchasing Department and the County Sheriff to award a bid per Bid No. 15-026 to Teel Technologies, for Law Enforcement Computer Equipment. The total amount is \$26,630.00. (B-15-0008)

Jeff Bliemeister, Chief Deputy Sheriff, indicated that the funds to purchase the equipment and the cost of training would not be coming from the general fund but rather from drug forfeiture funds.

MOTION: Wiltgen moved and Hudkins seconded approval of the recommendation. Schorr, Hudkins, Avery, Wiltgen and Amundson voted aye. Motion carried 5-0.

E. Agreement between Oelling Development Company and Lancaster County to guarantee construction improvements within the final plat of Meadow View 2nd Addition. (C-15-0091)

MOTION: Hudkins moved and Avery seconded approval of the agreement. Hudkins, Avery, Wiltgen, Schorr and Amundson voted aye. Motion carried 5-0.

F. Agreement with Released and Restored for job readiness/life skills classes for inmates in custody at the Lancaster County Jail. The County will pay \$1,170 per eight-class program. Term of the contract is March 1, 2015 to February 29, 2016. (C-15-0092)

MOTION: Avery moved and Schorr seconded approval of the agreement. Avery, Wiltgen, Schorr, Hudkins and Amundson voted aye. Motion carried 5-0.

G. Grant contract with Voices of Hope to provide funding in the amount of \$99,756 for the "Improved Legal Advocacy Relating to Protection Orders and Immigrants in Lancaster County" project. Term of the grant contract is October 1, 2014 to September 30, 2017. (C-15-0093)

MOTION: Schorr moved and Hudkins seconded approval of the contract. Hudkins, Avery, Schorr and Amundson voted aye. Wiltgen abstained. Motion carried 4-0 with one abstention.

H. Authorize return of proceeds in the expense accounts for the 401(a) Lancaster County Employees Retirement Plan and the 457(b) Deferred Compensation Plan maintained by the Prudential Retirement Insurance and Annuity Company to plan participants under the following terms: (1) all returned funds will be deposited into the Gibraltar account; (2) all participants with a fund balance will receive a distribution; (3) the amount of each distribution will be prorated based on the amount of the balance each participant has in the plans; and (4) a combined total of \$30,000 for the plans shall be returned in the expense accounts.
