Advance public notice of the Board of Commissioners Staff Meeting was posted on the County-City Building bulletin board and the Lancaster County, Nebraska, web site and provided to the media on January 28, 2015.

The Chair noted the location of the Open Meetings Act and opened the meeting at 8:30 a.m.

AGENDA ITEM

1 APPROVAL OF STAFF MEETING MINUTES FOR JANUARY 22, 2015

The item was delayed due to a lack of a quorum.

2 ADDITIONS TO AGENDA

There were no additions to the agenda.

3 LEGISLATIVE UPDATE - Gordon Kissel, Joe Kohout and Jonathan G. Bradford Kissel/E&S Associates

Schorr arrived at 8:33 AM.

Joe Kohout, Kissel/E&S Associates, presented a weekly legislative update and legislative bills of interest report (Exhibits A and B). He also discussed bills relating to Lancaster County 2015 Legislative Priorities. With regard to Legislative Bill (LB) 88 (Change fees relating to marriage licenses), Kohout noted that the bill was in the middle of a filibuster. He added Senator Bill Kitner had some concerns about raising the fee to \$50 but agreed to an amendment which would allow county boards to set a rate from \$30 to \$50 and keeping the certified copy at \$16.

Kohout discussed bills that relate to the 2015 Lancaster County Legislative Priorities and suggested the County support Legislative Bill (LB) 427 (Provide for payment of probation office costs by the state).

MOTION:

Hudkins moved and Avery seconded to support Legislative Bill (LB) 427 (Provide for payment of probation office costs by the state) and LB 61 (Change funding for county offices relating to administration of public assistance programs). Hudkins, Avery, Schorr and Amundson voted aye. Wiltgen was absent from voting. Motion carried 4-0.

Kohout recommended opposition to LB 66 (Require political subdivisions to make disclosures regarding bonds and provide for liability) and monitoring of LB 142 (Create the Aquatic Invasive Species Program and provide funding) and LB 132 (Change joint public agency bonding powers and procedures). Kerry Eagan noted potential concerns with LB 132 and felt the City of Lincoln should take the lead in opposing the bill.

With regard to LB 212 (Prohibit use of restraints in juvenile courts as prescribed), it was noted that Sheli Schindler, Youth Services Center (YSC) Director, has raised concerns. Additionally, Dennis Meyer, County Budget & Fiscal Officer, had concerns with the breadth of LB 266 (Change provisions relating to jurisdiction for municipalities to enforce ordinances).

Eagan distributed an email (Exhibit C) from John Chapo, President/CEO of Lincoln Children's Zoo, requesting support for LB 419 (Exempt sales and purchases by zoos and aquariums from sales and use tax). Chapo appeared and said the legislation affects four zoos in Nebraska, including the one in Lincoln. Hudkins felt there may be some attempt to broaden the scope of the bill which could possibly affect the Agricultural Society and/or County Fair. In response to Hudkins' question, Chapo noted that he has also been discussing this legislation with the City. Eagan felt if the City endorses the bill, the County should, too. Chapo said the Children's Zoo pays approximately \$50,000 in sales tax for purchases related to repair and maintenance. An additional \$120,000 would be saved by eliminating sales tax on admission.

Kohout pointed out three bills which will be included on next week's report relating to the restoration of state aid to counties: LB 609, LB 610 and LB 626 - all of which deal with road repair and bridge funding. He said some concerns are still being worked out, thus, he hoped to have a recommendation ready for the Board by next week.

Judy Halstead, Lincoln-Lancaster County Health Department (LLCHD) Director, informed the County Board on the City's position with regard to various legislation. She noted support for LB 98 (State intent regarding appropriations for tobacco use prevention control); LB 148 (Provide for medical assistance program coverage for certain youth formerly in foster care); and LB 332 (Appropriate funds for the statewide prescription drug disposal project).

County Engineer Pam Dingman said LB 374 (Direct transfers from the State Recreation Road Fund) should be monitored to see what impact it may have on counties. She also had a safety concern pertaining to LB 564 (Change duties and obligations relating to the mowing of weeds along county roads).

Schorr noted Sara Hoyle, Human Services Director, also had concerns with LB 13 (Change Community-based Juvenile Services Aid Program provisions). She said she would talk to the Nebraska Association of County Officials (NACO) regarding opposition.

RETURNING TO ITEM 1

MOTION: Hudkins moved and Avery seconded approval of the January 22, 2015 Staff Meeting minutes. Hudkins, Avery and Amundson voted aye. Schorr abstained and Wiltgen was absent from voting. Motion carried 3-0 with one abstention.

4 YOUTH DETENTION SERVICES CONTRACT WITH STATE PROBATION - Sheli Schindler, Youth Services Center (YSC) Director; Melissa Hood, Administrative Aide, YSC; Brittany Behrens, Deputy County Attorney

Sheli Schindler, Youth Services Center (YSC) Director, presented information on how YSC's per diem rate is calculated (Exhibit D). She also presented information on costs of confinement reported by 46 states and jurisdictions (Exhibit E), pointing out the average is \$407 per day.

NOTE: There is also an attached factsheet from the Justice Policy Institute.

Dennis Meyer, Budget and Fiscal Officer, explained indirect costs are based on an indirect cost plan that is prepared by Maximus Inc., a consultant. He said it includes the methodology on how Maximus allocates the different costs.

Schindler also reported on per diems charged by other facilities: Scottsbluff County Juvenile Detention Center in Gering - \$200 per day (does not include all costs; they are considering increasing the per diem); Douglas County Youth Center - \$210.56 per day (includes all costs; larger facility); Northeast Nebraska Juvenile Detention Center in Madison, (a non-profit organization that is not bound by the same personnel rules; does not cover all costs) - \$200 per day; and Sarpy County Juvenile Justice Center (only a staff secure facility; they are considering increasing their per diem to \$236). Their current per diem was not stated.

Schindler noted the County is not required to serve Probation youth from other counties, noting 90% of the population is Probation post-adjudicated youth. She said Lancaster County would still have contracts with other counties for pre-adjudicated youth.

Brittany Behrens, Deputy County Attorney, explained the contract being discussed today will just serve Lancaster County Juvenile Court youth as the County has other contracts in place allowing the YSC to hold pre-adjudicated youth from other counties. It was noted that out-of-county, post-adjudicated Probation youth are another issue. Behrens said Probation is proceeding under the assumption that this contract would establish the rate for <u>all</u> Probation youth. Schindler noted there is a provision within the contract that stipulates they must meet certain criteria and numbers in order for the YSC to accommodate youth from other counties. Lancaster County youth would be served first and the facility would work with Probation to find alternative placements if certain population and staffing levels were met.

It was also noted that Lancaster County is being asked to provide things above and beyond housing, such as transportation, which Lancaster County taxpayers would be covering. Youth are also staying longer at the YSC because other placements are not available, which is a systemic issue.

Behrens explained there are significant financial and liability issues and added that a contract lays out policies and procedures which are crucial if there are litigation situations.

Schorr recommended that Lieutenant Governor Mike Foley be invited to tour the YSC to get a better visual feel.

With regard to the per diem, Amundson felt \$307 is justified. Schorr added the rate has not been adjusted since 2007. Schindler said they do bill at \$307 and the Nebraska Department of Health & Human Services (DHHS) reimburses at a rate of only \$276. Meyer said the State should also be covering indirect costs.

Schorr asked who is making the decision to reimburse at the lower rate. Schindler said she have been working with Jeanne Brandner, Deputy Administrator, Office of Probation Administration, Juvenile Services Division. Avery suggested Schindler talk to Chief Justice Michael Heavican. Meyer agreed that it is time to contact the Chief Justice with the hope of finalizing the contract.

MOTION: Schorr moved and Hudkins seconded to send a letter to Chief Justice Michael Heavican explaining the County's basis for continuing to bill at \$307 and to copy the Governor and Lieutenant Governor.

FRIENDLY AMENDMENT: Avery offered a friendly amendment that the letter discuss the County's consequences of not getting the \$307 per diem.

The maker of the motion and the seconder accepted the friendly amendment.

ROLL CALL ON THE MOTION AS AMENDED: Avery, Hudkins, Schorr and Amundson voted aye. Wiltgen was absent from voting. Motion carried 4-0.

6 RENEWAL OF RLI MARINE INSURANCE POLICY- Sue Eckley, County Risk Manager

Eckley distributed a Coverage/Cost Comparison handout (Exhibit F) and indicated she needs a form signed by the Chair declining the Federal Terrorism Insurance Coverage. The marine insurance policy covers such things as Emergency Management's mobile hospital unit and contents and the statue honoring the late Lancaster County Deputy Sheriff Craig Dodge. The premium is covered by the Emergency Management and County Sheriff budgets.

Eckley recommended the Board decline terrorism coverage which is limited to acts of foreign terrorism.

MOTION: Schorr moved and Hudkins seconded approval of the renewal of the RLI Marine Insurance Policy excluding the Terrorism Insurance Coverage. Schorr, Hudkins, Avery and Amundson voted aye. Wiltgen was absent from voting. Motion carried 4-0.

9 ADMINISTRATIVE OFFICER REPORT

A. Renew Denton Town Talk Subscription (\$12.00 per year) (Exhibit G)

MOTION: Hudkins moved and Avery seconded to renew the Denton Town Talk subscription. Avery, Schorr, Hudkins and Amundson voted aye. Wiltgen absent from voting. Motion carried 4-0.

B. Human Services Director Position Details

The item was delayed until later in the meeting.

10 PENDING

There were no pending items.

11 DISCUSSION OF BOARD MEMBER MEETINGS

A. Emergency Medical Services Oversight Authority (EMSOA) - Avery

Avery said a report was given by Lincoln Fire and Rescue (LFR) regarding emergency medical performance and statistics.

Schorr questioned whether Dr. Jason Kruger, Medical Director, should be invited to give a presentation on general medical oversight to the City-County Common. Avery agreed that would be useful.

Discussion took place regarding the appointment of Sara Hoyle as the new Human Services Director. Eagan confirmed that Hoyle is currently earning \$70,424 per year and she requested a starting salary of \$80,000 per year. In response to Hudkins' inquiry, Eagan said the former Director's salary was \$81,720. Eagan said he did inform Hoyle that she would be eligible for a raise after completing a six-month probationary period. He added Human Resources did not have comparable list of salaries, as no other counties have a Human Services Director.

Schorr exited the meeting at 9:43 AM.

Schorr said there are three new members on the JBC - Sara Hoyle, Roma Amundson, and Sarah Kramer, United Way Director of Funds Distribution. Hoyle gave a short presentation about her background and goals for the Human Services Department. She said United Way has almost reached its fundraising goal of \$7,000,000. MOTION: Schorr moved and Avery seconded to adjourn the meeting at 10:23 a.m. Avery,



Weekly Update on the 2015 Legislature

Please accept this as the fourth of your weekly reports for the 2015 Legislative Session. Today is day 16. The Legislature continues to convene in the mornings – typically at 9am – and adjourn at noon for committee hearings in the afternoon.

Of note, at 10am, the Legislature will hear Chief Justice Heavican's annual State of the Judiciary address.

2015 Lancaster County Legislative Priorities:

1. Property Tax Relief: The Board has identified several potential options under this priority.

RESTORE STATE AID TO COUNTIES:

LB 633 – Appropriate funds for state aid to municipalities and counties.

Introduced by Sen. John Stinner, Gering

Hearing Date: TBA; Appropriations

LB 633 appropriates \$20,000,000 to counties and \$20,000,0000 to cities

for infrastructure projects

POSITION: RECOMMEND SUPPORT

OPPOSE ELIMINATION OF THE INHERITANCE TAX

No legislation was introduced this year that would eliminate the inheritance tax

ELIMINATE UNFUNDED MANDATES

LB 105 - Change Provisions relating to payment of fees and costs associated with deaths of incarcerated persons and grand juries Introduced by Sen. Dan Watermeier, Syracuse

Hearing Date: TBD, Government

LB 105 would change provisions relating to the payment of fees and costs associated with the deaths of incarcerated persons and grand juries when it relates to the state. State of Nebraska would be responsible for payment of juror when the individual in question died by unlawful means while serving at a state facility. An autopsy done by the county coroner of that individual shall be charged back to the state.

POSITION: RECOMMEND SUPPORT

LB 427 – Provide for payment of probation office cost by the state Introduced by Sen. Mike Groene, North Platte

Hearing Date: 1/29/2015

Government

Probation services are at its very core a state mandate - the extent of its services are determined by the Nebraska Legislature, not County officials. Further, with the coming reform of the state's correctional services, the strain on County budgets will increase. This bill will ensure that property taxes will not need to be increased further to fund a state mandate. This bill allows for the state to pay the cost of probation offices and those facilities performing in their official capacity. Actual and necessary expenses shall be paid. As Prior to July 1, 2015, counties providing space for probation services, may negotiate lease arrangements. Upon the close of business of June 30, 2015, the county shall no longer provide office and facilities to probation

POSITION: RECOMMEND SUPPORT - HEARING TODAY

LB 341 – Provide requirements relating to health benefit plan coverage for insureds in jail custody.

Introduced by Sen. Sara Howard, Omaha

Hearing Date:

Banking

DOUGLAS COUNTY PRIORITY

LB 341 states that an insurer may not cancel coverage or deny reimbursement for services covered by the plan for an individual in jail. LB 341 allows for reimbursement of a political subdivision by the insurer for services covered of an individual in custody. Coverage can be denied if the injuries occurred as a result of violation of law.

POSITION: RECOMMEND SUPPORT

RAISE COUNTY FEES

LB 88 – Raise marriage license fees Introduced by Sen. Kathy Campbell, Lincoln Hearing Date: 1/21/2015

Judiciary

Would raise marriage license fees to \$50 from \$15 and certified copies from \$6 to \$16. This bill was heard last week and advanced earlier this



week on a near-unanimous vote by the Judiciary Committee including three Lancaster County Senators – Senators Coash, Morfeld & Pansing Brooks. Dan Nolte did a great job testifying on behalf of Lancaster County. The bill was the first item up for debate yesterday and Senator Chambers began to filibuster the bill. An amendment has been agreed-to by Senators Campbell and Bill Kintner of Papillion that would change the language in the bill so that the county board can set the rate in a range between \$30 and \$50 and certified copies be \$16.

POSITION: SUPPORT

SUPPORT ADEQUATE APPROPRIATIONS FOR IMPLEMENTATION OF LB561:

We continue to monitor all efforts in this area.

2. Support Medicaid Expansion under the Affordable Care Act:

LB 472 – Adopt the Medicaid Redesign Act. Introduced by Sen. Kathy Campbell, Lincoln

Hearing Date:

Health and Human Services

LB 472 sets out to redesign Nebraska's Medicaid program with a specific plan. LB 472 creates the Medicaid Redesign Task force to review the Medicaid program and provide recommendations. LB 472 allows DHHS to work with the federal government to create a coverage plan. An estimated 1.8 billion in funds would be returned to Nebraska's economy from now until 2020. The Governor and DHHS would design and implement a Nebraska plan. The bill would ask that enrollees to contribute 2% of their income, unless active in a wellness program.

POSITION: RECOMMEND SUPPORT

- 3. Address Lancaster County Obligations under the 300,000 population threshold. As mentioned previously, this legislation was drafted at our request last week for potential introduction. Once the bill was drafted it became very clear that a significant number of sections were opened up. There was a concern raised about the diversity of sections that were being opened up as well as the fact that it may implicate some of Douglas County's thresholds. In discussion with staff, it was determined to take some time to go through the draft and spend some analyzing the multitude of sections opened up.
- 4. Eliminate the Responsibility of Counties to Pay HHS Rent: LB61 has been set for public hearing today before the Government, Military & Veterans Affairs Committee at 130pm. Kerry Eagan plans to testify.
- 5. Amend Mental Health Commitment Act / Funding for Community Based Sex Offender Treatment. After discussion regarding the size of this request as drafted \$7.5 Million it was determined that Lancaster County should make a request of the Appropriations Committee at their hearing. The thought is that the complete picture of the LR424 task force recommendation the prison review are not complete and this could be a part of that broader conversation.



- 6. Monitor Adult Corrections Reform. We will continue to monitor introductions for legislation that affects adult corrections reform.
- 7. Retirement Adjustment. LB126 has been advanced by the Legislature from General to Select File.

Other Legislation:

1. LB188 (Watermeier) Change provisions relating to innocent third parties injured during a vehicular pursuit. This is Senator Watermeier's bill that states that a passenger in a fleeing vehicle shall not be considered to be an innocent third party if the passenger (a) enters with knowledge the driver is under the influence (b) fails to take steps to persuade the driver of the fleeing vehicle to stop the vehicle (c) promotes or provokes the driver to flee (d) are themselves subject to arrest or (e) is engaged in illegal activity that would itself give rise to arrest.

POSITION: Support. LB188 was heard by the Judiciary Committee last week and was opposed by several groups including the Nebraska Association of Trial Attorneys.

LB142 (Schilz) Create the Aquatic Invasive Species Program and provide funding. To create the Nebraska Aquatic Invasive Species Program to be used by Game and Parks to prevent and mitigate damage caused by aquatic invasive species such as the zebra mussel, silver carp, and other such species. These species have proven destructive to the ecosystems and usability of surface waters in surrounding states, and steps must be taken to prevent their establishment in Nebraska. The Aquatic Invasive Species Program will be funded with a fee of between five and ten dollars, every three years that is paid with motorboat registration and/or renewal. Non-Nebraska boats shall be eligible for a yearly stamp at a cost of between ten and fifteen dollars. These funds are to be allocated for use in monitoring, testing, decontamination, and mitigation of aquatic invasive species in Nebraska surface waters.

POSITION: Monitor. The hearing on this bill was last Wednesday before the Natural Resources Committee.

- 2. LB66 (Schumacher) Require political subdivisions to make disclosures regarding bonds and provide for liability. As we read this bill, it would require the following disclosure on bond documents:
 - (a) the amount of any unfunded pension obligations of the school district, city, village, or county
 - (b) the actual amount of the valuation of the real estate subject to taxation in the school district, city, village, or county,
 - (c) the actual amount of the valuation of the real estate in the school district, city, village, or county that will not be available for payment of the bonds because of tax increment financing, and



(d) a statement substantially as follows: It is uncertain if the bonds being issued would have priority over the pension obligations of (insert name of school district, city, village, or county) if it declares bankruptcy.

It also provides for pretty stringent liabilities in the case of non-disclosure including the governing board members in their personal capacities.

POSITION: Oppose. Bond counsel for the city of Lincoln testified and stated that Lancaster County opposed the bill in his testimony yesterday. There was significant opposition and no support for the measure other than the introducer.

LB 132 – Change joint public agency bonding powers and procedures.

Introduced by Sen. Laura Ebke, Crete

LB 132 links Joint Public Agency bond issuance procedures to taxing powers. It requires Joint Public Agencies follow the bond issuance procedures a participating public agency would be required to follow to bond the particular revenue stream.

The bill is in response to the guardian ad-litem contracting situation in Douglas County that was the subject of a Judiciary Committee hearing in November.

LB 113 - Provide a co-payment for correctional inmates' health care services Introduced by Sen. Tyson Larson, O'Neill

Hearing Date:

Judiciary

An inmate who request medical treatment will make a copayment of not less than \$10.00 when receiving non-emergency service. The visit shall be deducted from the inmate account as part of copayment. If the account has insufficient funds at the time of the non-emergency treatment, fifty percent of any future deposit shall be withheld until copayment amount owed is paid in full. Proceeds of any such copayment shall be credited to the general fund of the county. Copayment would not take place for Emergency Care.

LB 119 - Change where certain sentences of imprisonment may be served



Introduced by Sen. Paul Schumacher, Columbus

Hearing Date:

Judiciary

All sentences of imprisonment for classified felonies and sentences of more than 1 year and any lesser sentence shall be served concurrently or consecutively with such sentences. Sentence of 1 year or less may be served in a county jail.

LB 212 - Prohibit use of restraints in juvenile court as prescribed.

Introduced by Sen. Chambers of Omaha

Hearing Date:

Judiciary

Restraints shall not be used on a juvenile during a juvenile court proceeding and removed prior to the juvenile's appearance before the juvenile court. Unless there is cause to show the need of restraints in the court proceeding. If there is a determination that restraints are needed, juvenile court shall provide the juvenile, the juvenile's attorney, or the juvenile's parent or guardian an opportunity to be heard before ordering the use of restraints.

POSITION: Sheli Schindler has raised an issue with this legislation.

LB 266 – Change provisions relating to jurisdiction for municipalities to enforce ordinances

Introduced by Sen. Sue Crawford, Bellevue

Hearing Date: 2/3/15

Urban Affairs

Municipalities currently have the authority to regulate nuisances within their extraterritorial zoning jurisdiction. LB 266 amends various nuisance statutes to clarify this existing authority.

POSITION: Brent Meyer has raised a concern about the breadth of this legislation.

LB 476 – Provide duties for county assessors and the Property Tax Administrator relating to tax-exempt real property.

Introduced by Sen. Al Davis, Hyannis

Hearing Date: 3/5/15

Revenue

On or before December 1 each year, the county assessor will compile a list of parcel of real property in the county exempt from the property tax, and determine the estimated market value. The Property Tax Administrator shall prepare a report based off of the list. The report is due to the Clerk of Legislature before December 31, of each year.

POSITION: Scott Gaines has raised a concern about this legislation as there may be a sizable cost associated with performing this responsibility.

LB 499 – Provide duties for the Department of Health and Human Services relating to behavioral and mental health services.



Introduced by Sen. Bob Krist of Omaha

Hearing Date:

Health and Human Services

LB 449 states DHHS will reestablish the provision of behavioral and mental health services throughout Nebraska. Departments of Corrections, Probation Administration, and Juvenile Services will assist

POSITION: This is a placeholder bill for legislation that may come from the LR434 recommendations.

LB 543 – Provide for certification of community paramedics and reimbursement under Medicaid

Introduced by Sen. Burke Harr of Omaha

Hearing Date:

Health and Human Services

PRIORITY FOR DOUGLAS COUNTY

LB 543 establishes criteria and requirements for certification for community paramedics. To be eligible for certification, an individual must be a licensed paramedic and completed a paramedic education program from a board approved university or college.

POSITION: This is a priority for Douglas County. There are concerns with the bill.

The tip of the iceberg: What taxpayers pay to incarcerate youth

December 2014

Right now, taxpayers spend hundreds of dollars a day—in some places, hundreds of thousands of dollars a year—to confine a young person. Because every state (and local) juvenile justice system is different, it is a challenge to come up with a consistent way to describe these direct costs from state to state. These costs also change over time.

To advance the understanding of the direct costs of confinement, JPI collected information from 46 states and jurisdictions in the summer and fall of 2014 on what they said they pay on a perday or per-year basis to confine a young person in their most expensive confinement option. These 46 states or jurisdictions represent 93 percent of the population of the United States in 20131 and 86 percent of committed youth in secure placements in 2011.2

The information contained in the following table represents fiscal information provided directly from state juvenile corrections departments, agency annual reports, or legislative documents. When a state or juvenile correctional system provided more than one cost of confinement, the most expensive one is listed, reflecting the reality that it can cost hundreds of dollars a day, and hundreds of thousands of dollars a year, to incarcerate a single youth. When available, costs of other types of placements, which range from large, secure facilities to smaller group homes are included in the endnotes, along with details about each cost figure in the endnotes. To account for varying lengths of stay across different jurisdictions and recent research that indicates that longer stays in secure confinement do not reduce recidivism,3 JPI calculated the estimated cost of placing a young person out of his or her home for three months, six months,

and a full year. These estimates—per day, 90 days (three months), 180 days (six months), and a year (365 days)—vary to reflect the growing consensus from research and operations of juvenile justice systems that acknowledges that in the rare instances where secure care is appropriate, confinement should be for the shortest period of time possible to reduce harm to the youth and save money.

For these 46 states or jurisdictions that reported to JPI, the average costs of the most expensive confinement option for a young person out of his or her home are \$407.58 per day, \$36,682 per three months, \$73,364 per six months, and \$148,767 per year. Thirty-three states and jurisdictions reported spending \$100,000 or more on the most expensive confinement option for a young person.

The reasons states incur different per diem and annual costs vary, and they reflect various opportunities, challenges, and choices in how juvenile justice systems are designed. The reasons for these varied costs include the availability of treatment and rehabilitation services, privatization or lack of unions, and the extent to which every bed in a facility is used.

Depending on the state and the kind of facility or placement, a number of different funding streams may pay for these placements. Per-day or per-year expenditures can include a mixture of county dollars, state dollars, and federal dollars—something that is different from state to state.

Regardless of how the costs of confinement are shared, taxpayers pay these direct costs.
