The Vice Chair noted the location of the Open Meetings Act and opened the meeting at 8:36 a.m.

#### AGENDA ITEM

**LEGISLATIVE UPDATE AND LEGISLATIVE RETREAT DATE (AUGUST 13, 2015 AT RAYMOND FIRE HALL)** - Gordon Kissel and Jonathan Bradford, Kissel/E&S Associates (Legislative Consultants)

#### Legislative Update

Jonathan Bradford, Kissel/E&S Associates, presented a legislative update and legislative bills of interest report (Exhibits A and B).

Avery arrived at the meeting at 8:38 a.m.

Bradford said it is unlikely they will find a bill that could serve as a "vehicle" for an amendment for the provision of Legislative Bill (LB) 542 (Provide a sales tax exemption for purchases by county agricultural societies) and it will probably have to wait until the next legislative session.

Schorr noted Legislative Bill (LB) 605 (Change classification of penalties, punishments, probation and parole provisions, and provisions relating to criminal records and restitution and provide for a special legislative committee) and asked how the County can access the County Justice Reinvestment Grant Program funds other than for programming. Bradford said he will ask Senator Mello who is making that determination.

Schorr noted the County is already experiencing a fiscal impact as a result of LB 482 (Change provisions relating to juveniles). She said the Youth Services Center (YSC) has had to hire additional staff because more than one officer is required when a youth who is not in restraints is being transported.

Hudkins inquired about the appropriation for the Department of Health and Human Services (HHS) and asked whether the funding would be split on the biennium. Bradford said he will check and report back.

## Legislative Retreat Date

There was no objection to the proposed date.

B. "My Town, Lancaster County" Follow-Up Meeting (Friday, June 5, 2015)

Informational only.

It was suggested a representative(s) of the Lincoln/Lancaster County Planning Department, and Sara Hartzell, who led that project when she worked for the Planning Department, be invited to attend the Board's meeting with representatives of the County's rural communities on July 9th.

C. Personnel Policy Board Appointments

The Board reviewed a list of possible candidates: Mike McCrory, former Director of Personnel for the State of Nebraska; Bill Harding, retired employment and labor attorney; Linda Crump, Assistant to the Chancellor for Equity, Access and Diversity Programs, University of Nebraska-Lincoln (UNL); Gene Crump, attorney and former Chair of the Commission on Human Rights; and Mike Thew, retired Lancaster County Chief Deputy County Attorney.

There was consensus to hold the item and seek additional information about the makeup of the Personnel Policy Board.

4 BI-MONTHLY MEETING WITH LANCASTER COUNTY AGRICULTURAL SOCIETY - Amy Dickerson, Lancaster Event Center Managing Director; Alan Wood, Erickson Sederstrom Law Firm

Amy Dickerson, Lancaster Event Center Managing Director, gave an update on the recent re-launch of the Event Center, noting their vision, progress this past year and where they plan to go next (see Exhibit C). She said the Event Center has a new tag line, "Let the Good Times Grow", and brand and will launch a new website next week.

Alan Wood, Erickson Sederstrom Law Firm, discussed LB 542 (Provide a sales tax exemption for purchases by county agricultural societies) and agreed they will likely have to wait until the next legislative session to find a "vehicle" for the bill (see Agenda Item 3). Avery suggested the Agricultural Society work to get the bill introduced early in the session.

Dickerson discussed the Visitors Improvement Fund Grant the Lancaster County Agricultural Society received in 2013 to make improvements at the Event Center. The total amount of the grant is \$2,124,790 and the work is to be completed in five phases with the last phase completed in December 31, 2016. She said she was hired during Year Three of the grant and some of the projects were already underway. Dickerson said she halted plans to install chain link fencing last year and moved up plans for a parking lot, which followed the intent of the grant in terms of what was spent last year. She feels a white ranch fence relates better to the new brand and they will be able to secure more fencing for the same amount of money. Dickerson said there were plans to pave another grass lot this year, which is Year Four of the grant and said she would like to halt that project as well, noting \$284,000 of the \$440,000 in funding for next year had been set aside for that project. She said the Nebraska Statewide Arboretum and Nebraska Forest Service believe the Event Center has a good chance of getting a grant for permeable paving. Another change she would like to make is to a project scheduled for Year Five. Dickerson said almost \$100,000 had been set aside for landscaping and she felt they could secure grants for that as well. She said she would also like to move a parking lot lighting project up in the schedule so the lighting is in place for the Lancaster County Super Fair. The project is currently scheduled for Year Five of the grant. Dickerson noted they secure sealed bids for projects \$20,000 and over, using the E-Bid process, even though it is not required. The lighting project was budgeted at \$249,000 and they got a sealed bid for \$118,000. She said she would like to use the funds that would be freed up on other projects she has identified.

Eagan said Dickerson is proposing to change the scope of work and said he will draft an addendum to the Visitors Improvement Fund Grant contract if Dickerson can provide him with an exhibit which specifies the scope of the work she is proposing.

Avery exited the meeting at 9:34 a.m.

Information about space for events and the Lancaster County Super Fair was also disseminated (Exhibits D and E).

Avery returned to the meeting at 9:37 a.m.

5 UPDATE ON LANCASTER COUNTY BUILDING MASTER PLAN -John Kay, Sinclair Hille & Associates, Inc.; Don Killeen, County Property Manager

John Kay, Sinclair Hille & Associates, Inc., presented the <u>2014 Public Building</u> <u>Commission Facilities Report</u>, noting background and previous studies, purpose and objectives, facility locations and events impacting the following property recommendations (Exhibit F):

- 1) Justice and Law Enforcement Center and County/City Building - Maintain use of core government campus buildings.
- 605 Building Repurpose the 605 Building from the Former County Adult Detention Facility to office and courtroom space for County Attorney, Adult Probation, Community Corrections, County Court, District Court, and storage space for Lincoln Police Department (LPD) evidence.
- K Street Records Warehouse Use K Street Records Warehouse as 100% records storage. Increase storage capacity by relocating LPD Evidence Storage to the 3<sup>rd</sup> floor of the 605 Building.
- 4) **825 "J" Street (Benesch) Building** Relocate the County Mental Health Crisis Center to the building.
- 5) **900 "J" Street Building** Continue use of the building as Community Corrections meeting space (Safety Training Option Program (STOP) Classes).
- 6) **233 Building** Consider relinquishment of the building for potential private redevelopment.
- 7) District Energy Corporation (DEC) Plant Reserve the parking area immediately north of the building for future expansion of the DEC Plant. Add the 825 "J" Street (Benesch) and 900 "J" Street Buildings.
- 8) **Courthouse Plaza** Relocate Community Corrections administrative offices from the lower level and 1<sup>st</sup> floor of the building to the 605 Building, allowing expansion of the Public Defender Office.
- 9) 10<sup>th</sup> & "H" Street Parking Lot Continue use of the existing south surface parking lot between 9<sup>th</sup> and 10<sup>th</sup> Streets as County-City employee parking.
- 10) **8<sup>th</sup> & "H" Street Parking Lot** A 98-stall concrete surfacing parking lot was completed in September, 2014.
- 11) **Trabert Hall** Relinquish ownership of the building and relocate existing departments to the 605 Building.
- 12) **Community Mental Health Center Building (CMHC)** -Relinquish ownership of the building and relocate departments to the 825 "J" Street (Benesch) Building.

In response to a question from Avery, Don Killeen, County Property Manager, said the Public Building Commission (PBC) will go out for a revenue bond at the beginning of 2016 that will encompass all the projects. The bond will be repaid through rent in the various buildings.

Hudkins asked about the cost for a multiple layered parking facility. Kay said the cost per stall in typical pre-cast structure is \$14,000 to \$15,000. Killeen said the PBC was able to keep the cost around \$7,500 per stall when it built the parking garage north of the County-City Building in 2004 by taking advantage of the site topography.

Avery exited the meeting at 10:02 a.m.

Kay also discussed implementation and probable construction costs.

Avery returned to the meeting at 10:06 a.m.

Hudkins asked whether the parking lot on South 17<sup>th</sup> Street which is adjacent to the CMHC Building should also be mentioned in the report. Kay said they could amend the report to include it.

Schorr asked whether there are any overlaps with the new South Downtown (SoDo) Study. Kay noted the Lincoln Community Foundation is leading that effort and said the boundaries are A Street to M Street and 10<sup>th</sup> Street to 17<sup>th</sup> Street. Killeen added it shouldn't affect the government campus.

 A) WAIVER OF BIDDING REQUIREMENTS OF COUNTY PURCHASING ACT DUE TO EMERGENCY CAUSED BY FLOODING OF MAY 6-7, 2015 (ACTION REQUIRED); AND B) APPROVAL OF AMENDMENT TO CONTRACT WITH GANA TRUCKING & EXCAVATING (COUNTY CONTRACT NO. C-15-0202) TO INCLUDE REPAIR OF COUNTY BRIDGE DAMAGED DURING FLOODING OF MAY 6-7, 2015 (ACTION REQUIRED) - Pam Dingman, County Engineer; Bob Walla, Assistant Purchasing Agent; Kristy Bauer, Deputy County Attorney

### A) Wavier of Bidding Requirements of County Purchasing Act Due to Emergency Caused by Flooding of May 6-7, 2015

Pam Dingman, County Engineer, discussed the need to make emergency repairs to two county bridges that were damaged by recent flooding. One bridge is on West Pioneers Boulevard near Southwest 98<sup>th</sup> Street (County Bridge N19) and the other is the Sprague bridge on West 14<sup>th</sup> Street near Sprague (County Bridge T171). Both bridges have holes and drivers have been driving around or removing the barricades placed in front of the bridges. One driver got the back end of his truck stuck in a hole

on the Sprague bridge. She said she is worried both bridges will be heavily traveled over Memorial Day weekend and requested a waiver of the bidding requirements of the County Purchasing Act so that temporary repairs can be made before the weekend.

Schorr asked how long the temporary repairs will hold. Dingman said her department will not open the bridges to truck traffic but said the bridges could be impacted if there were another significant flood event. She said the bridges will be checked on a regular basis.

Eagan noted the possibility of reimbursement through the Nebraska Emergency Management Agency (NEMA). Jim Davidsaver, Emergency Management Director, appeared and said he spoke to NEMA about whether making a temporary fix at this time would potentially jeopardize any reimbursement and was assured it would not. He said the Federal Emergency Management Agency (FEMA) categorizes these events into eight categories and this would fall into the category that covers emergency protective measures.

Kristy Bauer, Deputy County Attorney, said the contract, as it stands, just addresses one bridge and one amount. Dingman said she would like it to cover both bridges, adding she believes the contract amount of \$30,000 would be adequate to make temporary repairs to both.

Bob Walla, Assistant Purchasing Agent, asked Dingman whether the repairs would fit within the line items issued in the contract with Gana Trucking & Excavating for excavating and dozing services (County Contract No. C-15-0202). Dingman said the only thing that is not listed is the clay, rock and filter fabric the contractor would be using to make the repairs. Walla asked whether the vendor has agreed to the pricing for the work, per their existing contract. Dingman said they have. Walla noted the existing contract has a maximum of \$10,000 per event and the total amount the County will expend per year, to at least the \$30,000, could be increased through a separate amendment. He said the amendment before the Board today would take care of the County's immediate needs. Eagan explained the County is "piggybacking" on a unit price contract for the work.

**MOTION:** Schorr moved and Avery seconded to: 1) Waive the bidding requirements of the County Purchasing Act, effective May 21, 2015, due to an emergency caused by the flooding event on May 6-7, 2015; and B) Direct the County Attorney's Office to prepare a resolution for the May 27, 2015 County Board of Commissioners Meeting to ratify the Board's action. Schorr, Avery and Hudkins voted aye. Amundson and Wiltgen were absent from voting. Motion carried 3-0.

#### B) Approval of Amendment to Contract with Gana Trucking & Excavating (County Contract No. C-15-0202) to Include Repair of County Bridge Damaged During Flooding of May 6-7, 2015

**MOTION:** Schorr moved and Avery seconded to approve an amendment to County Contract No. C-15-0202, between Lancaster County and Gana Trucking and Excavating, to include the repair of county bridges T171 and N19 which were damaged during flooding on May 6-7, 2015, at a total cost not to exceed \$30,000. Avery, Schorr and Hudkins voted aye. Amundson and Wiltgen were absent from voting. Motion carried 3-0.

## ADDITIONS TO THE AGENDA

**MOTION:** Avery and moved and Schorr seconded to add a flood damage update, for informational purposes, only to the agenda. Avery, Schorr and Hudkins voted aye. Amundson and Wiltgen were absent from voting. Motion carried 3-0.

Dingman disseminated a flood damage map (roads shown in purple and yellow represent federal aid routes) and summaries of labor, equipment and materials related to storm and flood damage (Exhibits G-I).

Dingman said Bridge H-207 on North 162<sup>nd</sup> Street, south of Greenwood Road (Waverly Bridge) was substantially damaged by the flood and estimated the cost to stabilize the banks on either side at \$250,000. Bridge G-2 (North 98<sup>th</sup> Street Bridge) which had \$100,000 in repairs last year, sustained \$200,000 in damage and has severe bank erosion. She said both bridges are nearly past their useful life.

RE: Weekly Update on the 2015 Legislature

Please accept this as the fourteenth of your weekly reports for the 2015 Legislative Session. Today is day 85. On thursday of last week, the Legislature successfully voted to override the Governor's veto of LB 610. The vote to override was 30-16-3. Yesterday morning the Governor signed the budget package with no mainline vetoes. Also yesterday, the Legislature passed on final reading the repeal of the death penalty, which the Governor has stated he plans to veto.

Below, please find legislation of particular note to Lancaster County

#### 2015 Lancaster County Legislative Priorities:

1. **Property Tax Relief:** The Board has identified several potential options under this priority.

#### **RESTORE STATE AID TO COUNTIES:**

LB 609 – Adopt the Nebraska Bridge Repair Act Introduced by Senator Jim Smith of Papillion

#### Hearing Date: March 9, 2015 Transportation & Telecommunication

LB 609 creates a mechanism for priority of bridge repairs in Nebraska which includes a process whereby projects are prioritized by a commission including some county commissioners. Engineer Dingman has expressed a concern about the design-build as well as the level of bureaucracy that the bill will provide.

POSITION: OPPOSE. The hearing on this measure was March, 9, 2015 before the Transportations and Telecommunication Committee. Engineer Dingman testified in opposition to the bill. Senator Smith indicated that he plans to hold the bill for discussions in the interim.

#### LB 610 – Change motor vehicle excise taxes. Introduced by Senator Jim Smith of Papillion Hearing Date: March 6, 2015 Revenue

Increases the gas tax by \$.015 over the next four years to a total of \$.06.

POSITION: SUPPORT. The hearing on this measure occurred Friday, March 6, 2015. There was a significant amount of support for the measure. Engineer Dingman testified on behalf of Lancaster County in support. The bill was advanced by the Revenue Committee and prioritized by Sen. Curt Friesen of Henderson. The bill advanced to Select File on April 1, 2015. The bill advanced to Final Reading on April 13, 2015. Senator Smith's motion to override the Governor's veto passed with 30-16-3 votes.

As a result of this measure, the estimated revenue for Lancaster County over the next five years is as follows: FY2016 - \$107,715; FY2017 - \$434,260; FY2018 - \$760,772; FY2019 - \$1,087,283; and FY2020 \$1,306,046.

We have attached the votes on LB 610 and the motion to override at the end of the report for your review.

## LB 626 – Create a fund and change motor vehicle fees and taxes and their distribution.

Introduced by Senator Kathy Campbell, Lincoln

#### Hearing Date: March 9, 2015 Transportation & Telecommunication

Is intended to increase the registration fee for vehicles and move an amount into a Bridge Bank which will be used to repair bridges throughout Nebraska.

POSITION: MONITOR. The hearing on this measure was on March 9, 2015 before the Transportation and Telecommunication Committee. Similar to LB609, Senator Campbell offered the bill to the committee to have the committee potentially use the bill for a roads package.

LB 633 – Appropriate funds for state aid to municipalities and counties. Introduced by Senator John Stinner, Gering Hearing Date: March 18, 2015 Appropriations

LB 633 appropriates \$20,000,000 to counties and \$20,000,000 to cities for infrastructure projects for one year.

POSITION: SUPPORT. The hearing on this measure occurred yesterday. A significant of support was registered before the committee including NACO, the City of Lincoln, the City of Omaha, and Pam Dingman on behalf of Lancaster County. The Appropriations Committee chose not to fund this at any level because of the potential passage of LB610.

#### **OPPOSE ELIMINATION OF THE INHERITANCE TAX:**

No legislation was introduced this year that would eliminate the inheritance tax

#### **ELIMINATE UNFUNDED MANDATES:**

I would note for each of the bills under this section, this legislation is not likely to move in the current legislative session.

LB 105 - Change Provisions relating to payment of fees and costs associated with deaths of incarcerated persons and grand juries Introduced by Senator Dan Watermeier, Syracuse

#### Hearing Date: February 12, 2015 Government

LB 105 would change provisions relating to the payment of fees and costs associated with the deaths of incarcerated persons and grand juries when it relates to the state. State of Nebraska would be responsible for payment of juror when the individual in question died by unlawful means while serving at a state facility. An autopsy done by the county coroner of that individual shall be charged back to the state.

POSITION: SUPPORT. The hearing on this bill was on Thursday February 12<sup>th</sup>, 2015. Mr. Eagan testified on behalf of Lancaster County. Those in support included NACO. No one appeared in opposition. The committee did advance the measure with an amendment attached. We have provided that amendment with a previous report.

#### LB 427 – Provide for payment of probation office cost by the state Introduced by Senator Mike Groene, North Platte Hearing Date: February 29, 2015 Government

This bill allows for the state to pay the cost of probation offices and those facilities performing in their official capacity. Actual and necessary expenses shall be paid. As Prior to July 1, 2015, counties providing space for probation services, may negotiate lease arrangements. Upon the close of business of June 30, 2015, the county shall no longer provide office and facilities to probation

POSITION: SUPPORT. The hearing on this bill was on Thursday, January 29, 2015. Those appearing in support included Joe Hewgley from the Lincoln County Board of Commissioners, Larry Dix with NACO, Mike Kelley representing the Douglas County Board of Commissioners and Kerry Eagan representing this board. There was no opposition to the bill. An amendment prepared by NACO in consultation with Douglas and Lancaster County to limit the legislation to only cover rent which will limit the fiscal impact to approximately \$4 million.

LB 341 – Provide requirements relating to health benefit plan coverage for insureds in jail custody. Introduced by Senator Sara Howard, Omaha

#### Hearing Date: March 9, 2015 Banking DOUGLAS COUNTY PRIORITY

LB 341 states that an insurer may not cancel coverage or deny reimbursement for services covered by the plan for an individual in jail. LB 341 allows for reimbursement of a political subdivision by the insurer for services covered of an individual in custody. Coverage can be denied if the injuries occurred as a result of violation of law.

POSITION: RECOMMEND SUPPORT. The hearing on this bill was on March 9, 2015. Douglas County Board Commissioner Mary Ann Borgeson, Mr. Mark Foxall, Director of Corrections for Douglas County and Elaine Menzel, NACO all testified in support. No opponent testimony and Eric Dunning for Blue Cross Blue Shield testified in a neutral capacity. The bill is still in committee.

#### RAISE COUNTY FEES:

#### LB 88 – Raise marriage license fees Introduced by Senator Kathy Campbell, Lincoln Hearing Date: January 21, 2015 Judiciary

As introduced and advanced by the Committee, the bill would raise marriage license fees to \$50 from \$15 and certified copies from \$6 to \$16. An amendment was adopted on General File that capped the fee at \$25,

POSITION: SUPPORT. This bill was advanced on a near-unanimous vote by the Judiciary Committee including three Lancaster County Senators – Senators Coash, Morfeld & Pansing Brooks. Dan Nolte did a great job testifying on behalf of Lancaster County. Senator Chambers began to filibuster the bill. An amendment had been agreed-to by Senators Campbell and Bill Kintner of Papillion that would change the language in the bill so that the county board can set the rate in a range between \$30 and \$50 and certified copies be \$16. However concerns were raised on this methodology due to consistency across the state. Senators Campbell and Chambers agreed to an amendment on LB88 that would raise fees to \$25. The amendment was adopted the bill advanced to Select File. The bill was debated last week on Select File. After conversations on the floor and after concerns were

raised about continued debate and potential loss of votes, an agreement was reached to amend the bill to reflect a \$9.00 fee for certified copy. The bill advanced to final reading. The bill was presented to the Governor on March 6, 2015. The Governor signed the bill on March 12, 2015.

#### SUPPORT ADEQUATE APPROPRIATIONS FOR IMPLEMENTATION OF LB561:

We continue to monitor all efforts in this area.

#### 2. Support Medicaid Expansion under the Affordable Care Act:

LB 472 – Adopt the Medicaid Redesign Act. Introduced by Senator Kathy Campbell, Lincoln Hearing Date: February 25, 2015 Health and Human Services

LB 472 sets out to redesign Nebraska's Medicaid program with a specific plan. LB 472 creates the Medicaid Redesign Task force to review the Medicaid program and provide recommendations. LB 472 allows DHHS to work with the federal government to create a coverage plan. An estimated 1.8 billion in funds would be returned to Nebraska's economy from now until 2020. The Governor and DHHS would design and implement a Nebraska plan. The bill would ask that enrollees to contribute 2% of their income, unless active in a wellness program.

POSITION: SUPPORT. The hearing on this bill was on February 25, 2015. Commissioner Schorr testified in support on behalf of Lancaster County. The bill advanced to General File with a committee amendment that rewrites a section regarding composition of the Task Force. The debate on this measure occurred last Wednesday and after 3 hours of debate, the Legislature bracketed LB 472. By way of reminder, the only record vote was on adoption of the committee amendment. Those members of the Lancaster County delegation voting in support were: Baker, Bolz, Campbell, Haar, Hansen, Morfeld, Pansing Brooks. Those who voted not to adopt the committee amendment were: Coash, Ebke. The bill will not come up again this year.

 Address Lancaster County Obligations under the 300,000 population threshold. As mentioned previously, this legislation was drafted at our request for potential introduction. Once the bill was drafted it became very clear that a significant number of sections were opened up. There was a concern raised about the diversity of sections that were being opened up as well as the fact that it may implicate some of Douglas County's thresholds. In discussion with staff, it was determined to take some time to go through the draft and spend some analyzing the multitude of sections opened up. Senator Hansen has introduced LR 196, on April 20, 2015.

- 4. Eliminate the Responsibility of Counties to Pay HHS Rent: LB61 was heard before the Government, Military & Veterans Affairs Committee. Mr. Eagan testified on behalf of Lancaster County. Those joining in support included Commissioner Mary Ann Borgeson on behalf of Douglas County, Dick Clark with the Platte Institute, Colby Mach with LIBA, Larry Dix with NACO and Fred Uhe with Sarpy County. Those opposed included Acting CEO of HHS Dr. Joseph Acierno. This bill, like the other unfunded mandate bills, are currently held in Government Committee.
- 5. Amend Mental Health Commitment Act / Funding for Community Based Sex Offender Treatment. After discussion regarding the size of this request as drafted - \$7.5 Million – it was determined that Lancaster County should make a request of the Appropriations Committee at their hearing. The thought is that the complete picture of the LR424 task force recommendation – the prison review – are not complete and this could be a part of that broader conversation.

Deputy Administrator Gwen Thorpe testified on behalf of Lancaster County and asked the committee to appropriate \$250,000 to fund Counseling Affiliates. Too, Joe Nigro has visited directly with members of the Appropriations Committee to fund not only this \$250,000 but also \$100,000 for a pilot mental health court in Lancaster County. The committee re-appropriated \$2.5 million for FY 2015 – 2016 and appropriated \$2.5 million in General Funds for 2016 – 2017 into behavioral health aid. They did not include the \$250,000 to fund Counselling Associates however there is a pot of one – time money of \$500,000 that is available to the Regions for one – time costs. Yesterday, the budget package was signed by the Governor with no mainline vetoes. Also, the following bill is of note on this issue as well:

LB 592 – Change provisions relating to corrections and parole and mentally ill offenders Introduced by Senator Kate Bolz of Lincoln Hearing Date: February 20, 2015 Judiciary LB 592 is one of six legislative bills introduced this session to address issues raised by the Interim Study report 424. LB 592 adds "personality disorder" to the definition of a mentally ill. The bill creates a clear separation of independence between the Department of Corrections and Pardons board when determining the treatment of inmates. Department of Corrections shall be responsible for an inmate while in confinement and Pardons board shall address the re-entry back to the general public. LB 592 adds a clean-up measure to the Sex Registry by adding "personality disorder" to the definition of mentally ill. The hearing on this bill was February 20, 2015. While the bill was not advanced on its own, the provisions of this bill have been included as part of the Committee Amendment to LB 598. That amendment has been forwarded to Mr. Eagan. LB 598 was placed on Final Reading on May 13th, 2015, with AM 1587.

6. Monitor Adult Corrections Reform. We will continue to monitor introductions for legislation that affects adult corrections reform.

LB 119 – Change where certain sentences of imprisonment may be served Introduced by Senator Paul Schumacher of Columbus Hearing Date: 2/12/15 Judiciary

The Nebraska Criminal Code at Neb. Rev. Stat §28-105 sets out penalties for the various classes of felonies which range from Class IV, with the least severe penalty, to Class I, with the most severe. Class IV and Class IIIA felonies have maximum penalties of 5 years imprisonment with no minimum sentences or fines. Section (2)(a) of §28-105 requires sentences of imprisonment of one year or more for convictions of Class IV and Class IIIa felonies be served in a State prison facility and sentences of less than one year be served in the county jail.

All sentences of imprisonment for classified felonies and sentences of more than 1 year and any lesser sentence shall be served concurrently or consecutively with such sentences. Sentence of 1 year or less may be served in a county jail.

Quoting from the fiscal note, "In the past 12 months Lancaster County has sent 268 felony 3,3A and 4 offenders to the Nebraska Department of Correctional Services. We are assuming the upper sentence level of these inmates is not included in this impact statement. Knowing inmates are credited for time served in a pre-trial capacity, and accrue good time, we feel we would add 59 inmates per day to our average daily population. By using an average cost of \$94.00 per day the impact to our FY15, would be approximately \$2,000,000. With this potentially growing population, we would be concerned our bed capacity would be limited in the following years. The County would be hard pressed to find available bed space for pre-trial offenders."

POSITION: OPPOSE. The hearing on this bill was on February 12<sup>th</sup>, 2015 before the Judiciary Committee. Mike Thurber testified in opposition on behalf of Lancaster Co. No one appeared in support.

7. Retirement Adjustment. LB126 signed by the governor on February 26, 2015.

#### Other Legislation:

 LB 374 - Direct transfers from the State Recreation Road Fund Introduced by Senator Ken Haar of Malcom Hearing Date: March 12, 2015 Appropriations Committee Engineer Dingman Discussed at January 29, 2015 Meeting

The bill would cap the amount in the State Recreation Road Fund at \$15 Million and move the amount greater than that to Game and Parks State Park Improvement and Maintenance Fund.

POSITION: Engineer Dingman testified in support of this legislation last Thursday. The bill is held in Committee. However, under LB661 the Appropriations Committee did cap the fund at \$14 million and transferred approximately \$700,000.

#### 2. LB 398 – Exempt all tangible personal property from property tax Introduced by Senator Burke Harr of Omaha Hearing Date: March 5, 2015 Revenue

This bill sets forth that beginning January 1, 2017, all tangible personal property shall be exempt from property tax. Property owned and used for agricultural and horticultural societies, educational, religious, etc. The fiscal impact that NACO submitted was \$217,700,000 statewide. The TEOSSA impact is \$67,000,000.

 LB 476 – Provide duties for county assessors and Property Tax Administrator relating to tax – exempt real property. Introduced by Senator AI Davis of Hyannis Hearing Date: March 5, 2015 Revenue

On or before December 1 each year, the county assessor will compile a list of parcel of real property in the county exempt from the property tax, and determine the estimated market value. The Property Tax Administrator shall prepare a report based off of the list. The report is due to the Clerk of Legislature before December 31, of each year.

POSITION: NO POSITION. Scott Gaines has raised a concern about this legislation as there may be a sizable cost associated with performing this responsibility.

4. LB 542 – Provide a sales tax exemption for purchases by county agricultural societies Introduced by Senator Burke Harr of Omaha Hearing Date: March 6, 2015 Revenue

The purpose of Legislative Bill 542 is to provide a sale and use tax exemption outlined in state statute 77-2704.15 for a "county agricultural society".

POSITION: SUPPORT. The hearing on this measure was on last Friday. Testifiers included Amy Dickerson, Steve Kruger, Alan Wood and Commissioner Amundson. The bill was advanced unanimously by the Revenue Committee. There are 4 bills that appeared on yesterday's agenda that could become vehicles for an amendment for the provision of LB542. We did attempt to work with Senator Schilz's office for a potential amendment to LB329 – the agri-tourism bill. But, Senator Schilz was uncomfortable with the divergence from the subject matter. LB 329 was placed on Final Reading on May 19, 2015.

 LB 13 – Change Community-based Juvenile Services Aid Program provisions Introduced by Senator Bob Krist of Omaha Hearing Date: February 26, 2015 Judiciary LB 13 states 10% of the annual GF appropriation to the community-based Juvenile Services Aid Program shall be set aside for the development of a common data system at the University of Nebraska at Omaha, Juvenile Justice Institute, to assess the effectiveness of community-based Juvenile Services Aid program.

In conversations with Senator Krist, he has indicated that he intends this to be a one-time ear mark not an ongoing one. We previously reported that the Appropriations Committee has included \$7.5 million in funding for 2015-16 and \$10 million in funding for 2016-17. In the final budget, we noticed that the Appropriations Committee funded this program at \$7.0 million per year.

POSITION: NEUTRAL. The bill advanced with an amendment we provided with last week's report which embodied changes suggested by multiple groups including Lancaster County. The language from LB13, as amended, was amended into LB265 via an amendment offered by Senator Krist - AM1014. LB 265 was placed on Second Final Reading on tuesday of this week.

## LB 15 – Provide additional powers and duties for guardians ad litem Introduced by Senator Bob Krist of Omaha Hearing Date: February 26, 2015 Judiciary

LB 15 states that a guardian ad-litem (GAL) is to receive required training required by the Nebraska Supreme Court. GAL is allowed to review and receive records/court plans prepared by the DHHS pertaining to the juvenile. GAL shall meet with the juvenile, upon the juvenile's request. LB 15 was introduced as a response to the guardian ad-litem contracting situation in Douglas County. The committee advanced the measure with an amendment which included (a) a requirement that the Supreme Court adapt a court rule on GALs; (b) to clarify how these contracts work/their transparency; (c) provisions that are currently contained in LB 265 which was placed on final reading on tuesday of this week.

POSITION: NEUTRAL. The bill was advanced to General File with the amendments provided in last week's report. Joe Nigro testified in support on behalf of the county. The bill advanced to Select File after adoption of the committee amendment. Joe Nigro, representatives of Legal Aid and Joe Kohout met with Senator Krist to develop an agreement that would eliminate any financial impact to Lancaster County. That amendment was adopted on March 30, 2015. On Tuesday, Senator Krist attached AM1067 to the bill. Joe Nigro submitted a fiscal note demonstrating AM 1067 had

no fiscal impact to the county. The bill was signed by the Governor on April 29, 2015.

*I would note that for items 7 – 10 under this section that the Appropriations Committee included almost \$ 60 million into additional Property Tax Credit Cash Fund and an amendment was adopted to the mainline budget to increase this to \$202,000,000 in both FY2015-16 and FY2016-17.* 

 LB 309 – Appropriate additional funds to the Property Tax Credit Cash Fund Introduced by Senator Al Davis of Hyannis Hearing Date: February 27, 2015 Appropriations

In addition to other appropriations for FY2016-17 to the Property Tax Credit Cash Fund, the State Treasurer shall transfer \$25,000,000 from the General Fund to the Property Tax Credit Cash Fund

In addition to other appropriations for FY2015-16 to the Property Tax Credit Cash Fund, the State Treasurer shall transfer \$25,000,000 from the General Fund to the Property Tax Credit Cash Fund on or before December 15, 2015, on such date as directed by the budget administrator of the budget division of the Department of Administrative December 15, 2016, on such date as directed by the budget division of the budget administrator of the Department of Administrator of the budget division of the Department of Administrator of the budget division of the Department of Administrator of the budget division of the Department of Administrator of the budget division of the Department of Administrative Services.

 LB 364 – Provide for transfers to the Property Tax Credit Cash Fund and appropriations Introduced by Senator Dan Watermeier of Syracuse Hearing Date: February 27, 2015 Appropriations

FY2015-16 the State Treasurer shall transfer \$60,000,000 from the General Fund to the Property Tax Credit Cash Fund and (2) FY2016-17 the State Treasurer shall transfer \$60,000,000 from the General Fund to the Property Tax Credit Cash Fund. Appropriation of (1) \$60,000,000 for FY2015-16 and (2) \$60,000,000 for FY2016-17 from the Property Tax Credit Cash Fund to the Department of Revenue, Program 132, to carry out the purposes of the property tax credit program.

9. LB 387 – Transfer funds from the Cash Reserve Fund to the Property Tax Credit Cash Fund

#### Introduced by Senator David Schnoor of Fremont Hearing Date: February 27, 2015 Appropriations

The State Treasurer shall transfer sixty million dollars from the Cash Reserve Fund to the Property Tax Credit Cash Fund on or before December 15, 2015, on such date as directed by the budget administrator of the budget division of the Department of Administrative Services.

#### 10. LB 442 – Appropriate additional funds to the Property Tax Credit Cash Fund Introduced by Senator Kate Bolz of Lincoln

Introduced by Senator Kate Bolz of Lincoln Hearing Date: February 27, 2015 Appropriations

In addition to other appropriations for FY2016-17 to the Property Tax Credit Cash Fund, the State Treasurer shall transfer \$20,000,000 from the General Fund to the Property Tax Credit Cash Fund on or before December 15, 2015.

In addition to other appropriations for FY2015-16 to the Property Tax Credit Cash Fund, the State Treasurer shall transfer \$20,000,000 from the General Fund to the Property Tax Credit Cash Fund on or before December 15, 2015, on such date as directed by the budget administrator of the budget division of the Department of Administrative December 15, 2016, on such date as directed by the budget administrator of the budget division of the Department of Administrator of the budget division of the Department of Administrative Services.

#### 11.LB 265 – Change provisions relating to juveniles and child welfare Introduced by Senator Kathy Campbell of Lincoln Hearing Date: February 27, 2015 Judiciary

LB 265 states a guardian ad-litem(GAL) will make a reasonable effort to become familiar with the needs of a juvenile by consultation with juvenile in his or her respective placement within 2 weeks of appointment and every 3 (was 6) months thereafter. GAL shall provide a written report, not limited to number of visits and make recommendations. LB 265 states the Foster Care Review board may participate in proceedings of the juvenile. LB 265 defines Trial Home visits as from the placement from foster care to the home of the legal guardian. LB 265 establishes a pilot project to determine whether policy outcomes meet the well-being outcomes for a juvenile and child-welfare involved in out of home

placement. LB265 was placed on second final reading on tuesday of this week with AM 1629 from Senator Krist.

#### 12.LB 391 – Change sales tax collection fees for motor vehicles Introduced by Senator Sue Crawford of Bellevue Hearing Date: February 27, 2015 Revenue

LB 391 adds language in 77-2703(1)(I)(iii) to read:

The county treasurer shall deduct and withhold for the use of the county general fund, from all amounts required to be collected under this subsection, the collection fee permitted to be deducted by any retailer collecting the sales tax plus an additional one-half of one percent of all amounts in excess of three thousand dollars remitted each month.

POSITION: SUPPORT. This bill comes out of the unfunded mandate study of last interim. The hearing on this measure occurred on February 27, 2015. Joe provided the letter to the committee. Concerns were raised by Senator Smith at the hearing about the impact on roads funding.

## 13.LB 564 – Change duties and obligations relating to the mowing of weeds along county roads

Introduced by Senator Brett Lindstrom of Omaha Hearing Date: March 3, 2015 Transportation and Telecommunications

The bill would limit mowing to one side of the road.

POSITION: OPPOSE. The hearing on this measure occurred on March 3, 2015. The bill has not advanced from committee.

#### 14. LB 499 – Provide duties for the Department of Health and Human Services relating to behavioral and mental health services Introduced by Senator Bob Krist of Omaha Hearing Date: March 4, 2015 Health and Human Services

LB 499 states DHHS will reestablish the provision of behavioral and mental health services throughout Nebraska. Departments of Corrections, Probation Administration, and Juvenile Services will assist

POSITION: NO POSITION. This is a placeholder bill for legislation that may come from the LR434 recommendations. This measure was heard in committee on March 4, 2015.

I would note that items 15 & 16 remain a high priority for Governor Ricketts, and the administration continues to work these measures. During consideration of LB 419 & LB 414, senators offered amendments to amend the provisions of LB 350 into both LB414 and 419. Too, there does not appear to be sufficient support for these several measures inside of the Revenue Committee.

#### 15.LB 293 - Change valuation of agricultural land and horticultural land Introduced by Senator David Schnoor of Scribner Hearing Date: February 19, 2015 Revenue

Lowers agricultural and horticultural land valuations from 75% to 65% of actual.

#### 16.LB 350 - Change valuation of agricultural land and horticultural land Introduced by Senator Lydia Brasch of Bancroft Hearing Date: February 19, 2015 Revenue

Lowers agricultural and horticultural land valuations from 75% to 65% of actual.

# 17.LB 384 - Provide for reclassification of agricultural land and horticultural land

Introduced by Senator Brett Lindstrom of Omaha Hearing Date: February 19, 2015 Revenue

The bill would allow for a reclassification of up to 30 acres per quarter section of cropland as range or pasture for purposes of property taxes.

#### 18. LB 605 – Change classification of penalties, punishments, probation and parole provisions, and provisions relating to criminal records and restitution and provide for a special legislative committee Introduced by Senator Heath Mello of Omaha Hearing Date: February 20, 2015 Judiciary

LB 605 is the first part of recommendations stemming from the CSG working group that was created at the end of last session. We were asked by

Commissioner Hudkins to convey County Attorney Joe Kelly's concern to Senator Mello. That was done as requested. Questions were raised during the hearing regarding both the County Attorney's suggested amendments and additional county aid. Senator Mello in follow-up conversations, is committed to the county aid we discussed at the 2/19/15 meeting. The bill was officially advanced to General File last week. A copy of the amendment was forwarded to Mr. Eagan for his review. The debate on LB 605 was very centered on two areas – first, the penalty changes that were embodied in LB 605 and second, the data that was presented to affect the prison population.

Last week, Senator Seiler filed an amendment to LB 605 – AM1530. It was 137 pages and was forwarded to Mr. Eagan for review. It included the provision we discussed that makes the funding under the grant program available in the first year (See sec. 87, p. 108). Too, it included a provision that would say that if the maximum penalty would place the individual in a state facility then that is where they will go (see sec. 6, p. 10). That amendment was adopted but right after an amendment by Senator Mello – AM1609 – was adopted that gives the oversight commission the ability to look at data from counties. LB605A was advanced from General File yesterday in a form reflective of the green copy of the bill. Senator Mello will be offering an amendment on Select File to include changes reflected in the Seiler & Mello amendments. The bill was placed on final reading on May 13th, 2015.

Previously, LB 605A included for FY2016-17 General Funds of \$250,000 for a potential state aid grant. That amount has since been increased to \$500,000.

19. LB 606 – Adopt the Office of Inspector General of the Nebraska Correctional System Act, change provisions relating to the Public Counsel, and mandate a declaration by the Governor of a correctional system overcrowding emergency as prescribed Introduced by Senator Heath Mello of Omaha Hearing Date: February 20, 2015 Judiciary

LB 606 would establish a full-time program of investigation and performance review to provide increased accountability and oversight of the Nebraska correctional system. The office of Inspector General of the Nebraska Correctional System is created within the office of the Public Counsel for the purpose of conducting investigations, audits, inspections and other reviews of corrections. LB 606 states that the Governor shall declare a correctional system overcrowding emergency when the population is determined to be over 140% of capacity by certification of the director. We understand that the provisions of LB606 have been amended into LB598, which is a Legislative Performance Audit Committee priority bill. This bill was advanced to Select File on April 13, 2015 after 30 minutes of debate.

#### 20. LB 273 – Authorize voters to decide partisan status of county offices Introduced by Sen. Kate Sullivan of Cedar Rapids Hearing Date: February 25, 2015 Government, Military and Veterans Affairs

Bill is to authorize voters to vote regarding partisan or nonpartisan ballots for nominations and election of county officers in certain counties. Summary of new language:

(1) All county officers elected shall be nominated and elected on a partisan ballot.

(2) County boards with a population of twenty thousand or fewer inhabitants may adopt a resolution requiring the submission of the question to the voters. Registered voters of a county with a population of ten thousand or fewer may file petition with county clerk requesting the question be put to the voters. The question shall be put to the voters at the first statewide general election after the adoption of the resolution.

(3) If the vote on the question is in favor of the nomination and election of all officers elected on a nonpartisan ballot, shall be nominated and elected at all subsequent elections.

LB 273 removes language in several sections including at 32-325, that states that the county surveyor shall be elected on the partisan ballot and 32-326 that states that the county engineer shall be elected on the partisan ballot.

## 21.LB188 - Change provisions relating to innocent third parties injured during a vehicular pursuit. Introduced by Senator Dan Watermeier of Syracuse

Hearing Date: January 23, 2015 Judiciary

This is Senator Watermeier's bill that states that a passenger in a fleeing vehicle shall not be considered to be an innocent third party if the passenger (a) enters with knowledge the driver is under the influence (b) fails to take steps to persuade the driver of the fleeing vehicle to stop the vehicle (c) promotes or provokes the driver to flee (d) are themselves subject to arrest or (e) is engaged in illegal activity that would itself give rise to arrest. POSITION: SUPPORT. LB188 was heard by the Judiciary Committee on January 23, 2015 and was opposed by several groups including the Nebraska Association of Trial Attorneys. The bill was advanced to General File with an amendment that is still pending.

#### 22. LB142 - Create the Aquatic Invasive Species Program and provide funding. Introduced by Senator Ken Schilz of Ogallala Hearing Date: January 21, 2015 Natural Resource

To create the Nebraska Aquatic Invasive Species Program to be used by Game and Parks to prevent and mitigate damage caused by aquatic invasive species such as the zebra mussel, silver carp, and other such species. These species have proven destructive to the ecosystems and usability of surface waters in surrounding states, and steps must be taken to prevent their establishment in Nebraska. The Aquatic Invasive Species Program will be funded with a fee of between five and ten dollars, every three years that is paid with motorboat registration and/or renewal. Non-Nebraska boats shall be eligible for a yearly stamp at a cost of between ten and fifteen dollars. These funds are to be allocated for use in monitoring, testing, decontamination, and mitigation of aquatic invasive species in Nebraska surface waters.

POSITION: Monitor. This bill advanced from the Natural Resources Committee with an amendment – AM45 which creates the Aquatic Invasive Species fund at the Department. The bill was approved by the Governor on March 5, 2015.

#### 23. LB66 - Require political subdivisions to make disclosures regarding bonds and provide for liability. Introduced by Senator Paul Schumacher of Columbus Heading Date: January 21, 2015 Judiciary

As we read this bill, it would require the following disclosure on bond documents:

(a) The amount of any unfunded pension obligations of the school district, city, village, or county

(b) The actual amount of the valuation of the real estate subject to taxation in the school district, city, village, or county,

(c) the actual amount of the valuation of the real estate in the school district, city, village, or county that will not be available for payment of the bonds because of tax increment financing, and

(d) A statement substantially as follows: It is uncertain if the bonds being issued would have priority over the pension obligations of (insert name of school district, city, village, or county) if it declares bankruptcy.

It also provides for pretty stringent liabilities in the case of non-disclosure including the governing board members in their personal capacities.

POSITION: OPPOSE. The hearing on this bill was held on January 21, 2015 and bond counsel for the city of Lincoln testified and stated that Lancaster County opposed the bill in his testimony. There was significant opposition and no support for the measure other than the introducer.

## 24.LB 132 – Change joint public agency bonding powers and procedures. Introduced by Sen. Laura Ebke, Crete Hearing Date: January 29, 2015 Government

LB 132 links Joint Public Agency bond issuance procedures to taxing powers. It requires Joint Public Agencies follow the bond issuance procedures a participating public agency would be required to follow to bond the particular revenue stream.

POSITION: OPPOSE. This bill was heard by the Government Committee on January 29, 2015. Mr. Eagan noted potential concerns with this bill that could affect the JPA. The supporters of the bill included LIBA and the Platte Institute. Those in opposition included bond counsel for the City of Lincoln and Lynn Rex representing the League. The bill was advanced to General File on March 6, 2015 with a committee amendment attached. We included a copy of the amendment with a previous report. The bill has been declared to be a Government Committee priority bill.

AM 582 to LB 132 addresses technical issues, but keeps the original content of the bill. AM 582 clarified electorate language relating to a vote on a bond issue. JPA shall have only those powers of taxation as one or more of participating public agencies as provided by agreement proposing creation of JPA. The JPA shall not levy a local option sales tax. A levy in property tax cannot exceed the limit agreed upon, if agreement limits the levy authority of overlapping participating public agencies to same amount. Levy authority of a JPA shall be allocated by city or county. If a participating agency is a municipality agreement, an agreement can allow for any occupation or wheel tax. Prior to the issuance of bonds and pledge of property tax levy authority to a JPA, the question shall be put forth to

the registered voters of the participating public agency. If voters exist in an overlap area of public agencies, the voter shall only vote once.

We met (along with Mr. Eagan) with Senator Ebke along with representatives of LIBA, the city of Lincoln and Senator Murante and Senator Morfeld's offices to bring up our two concerns about LB 132 – those about exemption under 23 – 120 and refinancing. While they have accepted our group's recommendations on the refinancing language, Senator Ebke has not agreed to the language allowing the use of the broader power of JPAs. We continued to work with her offering different options – along with those authored by the city of Lincoln. These amendments were not accepted by the bill's proponents. April 28, 2015, the bill moved to Final Reading after adoption of the refinancing language agreed to by the parties.

The bill passed on Final Reading with a 41-1-1 vote and was sent to the Governor on May 7th, 2015. The bill was approved by the Governor on May 13th, 2015.

## OTHER LEGISLATION OF NOTE RAISED BY DEPARTMENT HEADS:

LB482 - Change provisions relating to juveniles Introduced by Senator Bob Krist of Omaha Hearing Date: February 25, 2015 Judiciary

Restraints shall not be used on a juvenile during a juvenile court proceeding and removed prior to the juvenile's appearance before the juvenile court. Unless there is cause to show the need of restraints in the court proceeding. If there is a determination that restraints are needed, juvenile court shall provide the juvenile, the juvenile's attorney, or the juvenile's parent or guardian an opportunity to be heard before ordering the use of restraints.

POSITION: NO POSITION. Senator Krist has indicated that he introduced this legislation to conform to best practices. During debate on this measure on Tuesday he made reference to Lancaster County's Staff secure facility. This bill passed on April 23, 2015 and was signed by the Governor on April 29, 2015.

 LB 266 – Change provisions relating to jurisdiction for municipalities to enforce ordinances Introduced by Senator Sue Crawford of Bellevue Hearing Date: February 3, 2015 Urban Affairs Municipalities currently have the authority to regulate nuisances within their extraterritorial zoning jurisdiction. LB 266 amends various nuisance statutes to clarify this existing authority.

POSITION: NO POSITION: An amendment was worked out prior to the hearing to work out concerns raised by the League. An amendment was offered to the Committee during the hearing that would exempt out counties of greater than 100,000 – citing joint planning boards and commissions – and providing for a notice to County Boards of development in the ETJ of a city. The bill was signed by the Governor on March 5, 2015.

 LB 543 – Provide for certification of community paramedics and reimbursement under Medicaid Introduced by Senator Burke Harr of Omaha Hearing Date: February 6, 2015 Health and Human Services PRIORITY FOR DOUGLAS COUNTY

LB 543 establishes criteria and requirements for certification for community paramedics. To be eligible for certification, an individual must be a licensed paramedic and completed a paramedic education program from a board approved university or college.

POSITION: NO POSITION. This is a priority for Douglas County. There was significant opposition leveled at the hearing including most of the home-based healthcare organizations in the state. On Monday, Senator Harr offered AM153 that is still pending.

3. LB 106 - Adopt the Livestock Operation Siting and Expansion Act and change powers of counties relating to zoning Introduced by Senator Dan Watermeier of Syracuse Hearing Date: February 12, 2015 Government, Military & Veterans Affairs Committee NACO PRIORITY

This bill creates a mechanism for livestock operation siting and allows for certain officials to be on the board. This bill ran into serious opposition when debate began on this measure last Monday afternoon and Tuesday morning. Ultimately there was compromise on the bill and moved to Select File. The bill was advanced to Final Reading on April 15, 2015.

4. LB 98 - State intent regarding appropriations for tobacco use prevention control Introduced by Senator Kate Bolz of Lincoln Hearing Date: March 16, 2015 Appropriations Committee Judy Halstead Discussed at January 29, 2015 Meeting – Support with caveat around Health Care Cash funding levels

The bill would appropriate \$7 Million in both years of the biennium for tobacco use cessation. The committee funded this at \$200,000 in each year of the budget from the Health Care Cash Fund.

 LB 118 - Provide for licensure of cigar shops Introduced by Senator Tyson Larson of O'Neill Hearing Date: January 26, 2015 General Affairs Committee Judy Halstead Discussed at January 29, 2015 Meeting – Oppose

The bill re-creates an exemption for cigar bars. The bill has passed and was signed by the Governor.

 LB 148 - Provide for medical assistance program coverage for certain youth formerly in foster care Introduced by Senator Sue Crawford of Bellevue Hearing Date: January 30, 2015 Health & Human Services Committee Judy Halstead Discussed at January 29, 2015 Meeting – Support

This bill carries former foster youth on Medicaid until the age of 26.

 LB 332 - Appropriate funds for the statewide prescription drug disposal project Introduced by Senator John Kuehn of Heartwell Hearing Date: March 16, 2015 Appropriations Committee Judy Halstead Discussed at January 29, 2015 Meeting - Support

This bill appropriates \$600,000 in each year of the biennium to a drug disposal program. The committee funded this at \$300,000 in each year of the budget from General Funds.

## 8. Appropriation for Public Health Aid – HHS Budget

The Department of Health – along with others – is seeking a \$5.2 Million Appropriation. This would mean \$700,000 to Lincoln/Lancaster in both years of the biennium. The committee funded this at \$200,000 in each year.

## RULES AND REGULATIONS


- 1) The Exhibitor shall comply with the following conditions. In the event the Exhibitor fails to comply with any of the following conditions the Event Center may treat the Exhibitor as being in breach of this contract and at its option, may re-let the space to an alternate Exhibitor for the remaining term of this contract, remove the Exhibitor from the premises, placing any exhibits, supplies and materials in storage to be disposed of as the Event Center deems fit and/or retain all consideration paid as forfeiture.
- 2) Exhibitor shall not assign this contract to an alternate party. Exhibitor shall not sublet any part of this display space without written permission of the EC. Further, Exhibitor shall not share space with another company.
- 3) All booth construction must be approved by the EC Manager. Professional standards pertaining to appearance, materials and signage eliminate the use of used or scrap lumber, "blue tarps"/tarpaulins and handwritten signs. Continued participation in the EC is dependent upon conformation with these standards.
- 4) All concession booths shall be opened to the public during show hours. EC management will not be responsible for any loss or theft, which may occur in the absence of booth attendants because of early closure.
- 5) The Exhibitor must provide for delivery of all articles to the exhibit area. Delivery vehicles will not be permitted on the grounds after 9:30a.m. during the event. Exhibitor must use delivery route designated by EC.
- 6) Exhibitor shall keep premises neat and sanitary and deposit garbage in garbage containers. When leaving the premises, everything must be picked up and space left clean. There will be a monetary penalty of not less than \$50.00 to clean up space if it is not clean.
- 7) Exhibitor agrees that no vulgar, offensive, controversial or obscene material of any type or nature will be displayed, exhibited, presented or offered for sale. The EC Manager shall be the sole judge of what is vulgar, offensive, controversial or obscene and his judgment shall be finial. All material, including political or campaign material must be distributed from <u>WITHIN</u> the boundaries of the assigned booth space. No material may be distributed from aisles and/or outside of the grounds. Failure of the Exhibitor to abide by the decision so made shall constitute forfeiture of all rights obtained by the provisions of the agreement and forfeiture of all rentals paid by the terms of this agreement.
- 8) All electrical extension or flexible cords shall be of type S, 20 amp. 12 ga, with UL approval. Such cords may be used only when necessary, NEVER for fixed wiring, NEVER spliced, tacked, stapled or fastened to walls, tied or draped over pipes or supports.
- 9) Any proposed drawing, give-away program or special effects must be approved by the EC Manager at least two (2) weeks prior to the opening of the event. Drawing results must be submitted to the EC Office by 11.00 a.m. the day following the event.
- 10) Exhibitor is required to use only fireproof material for booth decoration. No permanent fixtures, shelving, counters or signs may be placed in the exhibit space without prior approval of the EC Manager.
- 11) Exhibitors may be allowed to hand out promotion or political materials FROM THE CONFINES OF BOOTH SPACE ONLY. No solicitation shall be allowed in the aisles or along walkways. Balloons may be given away.
- 12) Use of public address systems and other sound amplification will not be permitted except by special arrangement by EC Manager.
- 13) Any loss or damages to the Event Center facilities beyond normal use caused by the Exhibitor during the use of said facilities shall be to the Exhibitor, without consent in writing of the EC Manager.
- 14) The Exhibitor agrees to defend, indemnify and save harmless the EC, its appointed officials and elective officers and employees, from and against any and all liability, loss, cost, damage and expense including costs and attorneys fees in defense thereof, because of actions, claims or lawsuits for damages because of personal or bodily injury, including death at any time resulting there from, sustained or alleged to have been sustained by any person or persons and on account of damage to property including loss of use thereof, asserted or arising or alleged to have arisen directly or indirectly out of or in consequence of the performance of this agreement, whether such injuries to person or damage to property is due to the negligence of the Fair or as their interest may appear, their subcontractors or agents, successors or assignees, or the Exhibitor, its employees, or its agents.
- 15) Any and all other regulations, which may be necessary for the safety and benefit of Exhibitors and the general Fair public not listed in this contract shall be adhered to by all Exhibitors. Exhibitor must comply with all Federal, State and County laws.
- 16) Exhibitor shall endeavor to offer reasonable accommodations to persons with disabilities in accordance with the Americans With Disabilities Act.
- 17) Lessee agrees to carry Public Liability Insurance including Premises/Operations and Product/Completed Operations

coverage in the amount of \$1,000,000 in the aggregate for bodily injury and/or property damage. Said insurance will be with an insurance carrier acceptable to the EC (A M Best rating of A+ or better) and will name EC as an additional insured. Evidence of such insurance must be provided to the EC and its offices at the Lancaster Event Center, Lincoln, NE no less than five (5) working days prior to occupation. Said insurance must be in full force and effect at all times when the Lessee is making any use or occupying in any manner the premises or carrying on any activities associated with or incidental to the use of the premises.

- 18) OPERATING HOURS: All vendors must be open and ready for business from 10:00am-10:00pm from Thursday, July 30 through Saturday, August 8. All booths must have a staff person present at all times during open hours.
- 19) MOVE-IN: Move-in hours are Tuesday, July 28, 8:00am-8:00pm and Wednesday, July 29, 8:00am-8:00pm. All vendors must be set-up and ready for business by opening on Thursday, July 30, 10:00am.
- 20) MOVE-OUT: Move out is Saturday, August 8, 10:00pm-11:30pm, Sunday, August 9, 8:00am-5:00pm and Monday, August 10, 8:00am-5:00pm. All booth spaces must be clear by 5:00pm Monday, August 10.





#### CHARACTER OF EXHIBITS

Each exhibit will comply with the laws of the State of Nebraska and with all ordinances and regulations of the City of Lincoln and LEC. Exhibitor agrees to display only products and services which are sold by him in the regular course of business. Show officials reserve the right to eject or prohibit any exhibit, in whole or in part, or any exhibitor or his or her representatives which it considers not in keeping with the character of the Fair, with or without giving cause. If cause is not given for ejection of an exhibit or exhibitor, liability shall not exceed the return to the exhibitor the amount of rental unearned at the time of the ejection. If ejection is for violation of these rules and regulations or for a stated cause, no return of rental shall be made.

#### COMBUSTIBLE MATERIALS

Combustible products cannot be used without prior written approval. All flammable material must be fire-proofed. Any gas grills or fireplaces in use must meet the approval of management and the LEC before and during the Fair. Display vehicles must have one battery cable disconnected with end taped, gas caps locked and taped and no more than a 1/2 tank or 10 gallons of gas (whichever is less). All fueling must occur outside the building. Vehicles cannot be moved during the show, only during setup/tear down when not open to the general public.

#### MOVE IN & MOVE OUT

No move-in, rearrangement or adjustment may be done after the opening of the fair. Exhibitors will unload and load only at designated areas. Vehicles must be unloaded and loaded quickly and then immediately moved from the unloading and loading areas. Any vehicle left parked in these areas will be towed at owner's expense. Heavy materials or equipment will not be dragged, skidded, or rolled over the floors, but carried or moved in on wheels. Outside drop-off is at no charge but must be with approval and coordination with an LEC Operations Manager and Show management. The Fair management will assess a \$50 FINE to anyone attempting to move out before 9:00 p.m., Saturday, August 8. If fine is not paid, exhibitor will be banned from next year's fair. It is highly recommended that all small items, merchandise, lighting fixtures and other portable equipment be removed immediately after the show closes. EXHIBITS MUST BE REMOVED BY 5 P.M. ON MONDAY, AUGUST 10. If any accounts against the exhibitor have not been paid in full prior to the end of the show, no items exhibited shall be removed from the building until full settlement is made. In case of attachments or other legal proceedings, Show officials reserve the right to take charge of the exhibitor's props and properties.

#### PARKING

Ample, free parking is available in designated vendor parking area. Exhibitors must use designated Exhibitor Parking areas once the Fair begins. Violation of the posted "No Parking" signs or exhibitors parking outside of the designated Exhibitor Parking areas shall subject vehicle to towing and impoundment.

#### LEC SERVICES

A schedule of rates will be sent to all exhibitors covering electricity, wireless Internet access, carpentry, and decorating and furniture rental. Exhibitors will be billed for these services at reasonable and uniform rates. Any exhibitor who wishes to hook up to the LEC's gas line will be charged no less than \$150 plus permit costs. It is the responsibility of the exhibitor to place their order with Show management no later than 45 days in advance.

#### CARE OF EXHIBIT SPACE

LEC personnel will clean the aisles, but the exhibitors must keep their carpets and exhibits in good order. Exhibitors are allowed to bring in vacuum cleaners as long as they are compliant with UL regulations and cords are in good shape. Exhibitors must cooperate by maintaining their exhibits throughout the show in perfect condition. Exhibitor will be required to replace, repair, or otherwise assume the expense for any defacement or injury of premises caused by their exhibit or representatives. No LEC sponsor display material, banner or equipment may be removed for any reason. If any item is removed, there shall be a \$250 fee for replacement of said item. SELLING PRODUCTS

Retail selling of products over-the-counter on a carry-out basis requires prior written approval at the time of requesting space. Orders may be taken for merchandise or service to be delivered or rendered at a future date without prior approval. Exhibitors are required to be aware of and compliant of local and state laws. For more information on sales & use tax and income tax & withholding laws that apply to events, please see information guides for "Sales at Special Events" at www.revenue.ne.gov or contact Brandy Kennec at the Nebraska Department of Revenue at 402-471-5870 or brandy.kennec@nebraska.gov.

#### FOOD & BEVERAGE CONCESSIONS

No outside food or beverages can be brought to the LEC including coolers and deliveries of prepared food from outside food establishments. Alcoholic beverages can only be consumed when sold by the LEC in designated areas. No sales or sampling of food products from vendor booths will be permitted without prior approval from LEC. As required by the LEC, any exhibitors giving samples of their (homemade or purchased) food product must have a level IV food handlers permit and/or catering permit on file at the LEC and a signed agreement and/or statement stating that it shall be 2 oz. sample ONLY with one sample per customer and said statement on file at LEC. Food samples that are being handed out must be made in a Commercial Kitchen. All vendors who are handing out food samples must have a hand washing station. Vendors are responsible for displaying their Food Handlers Permit. All arrangements shall be agreed upon not less than 14 days PRIOR to Show. If an agreement is not on file, the LEC reserves the right of refusal. No bottled water, soda or full cups of coffee may be given. Exhibitors are restricted to samples only.

#### LITERATURE & SOUVENIRS

Printing, advertising, souvenirs, etc., may be distributed by exhibitors from their own space only. Any objectionable advertising will not be permitted. Souvenirs will not be of noise-making variety. All such gifts are subject to prior approval. Exhibitors must confine all sales activities to their own exhibit space.

#### PRIZES, DISCOUNTS, & DRAWINGS

Drawings for giveaways, prizes, discounts, etc., must be registered and approved by Fair management. A list of all recipients, winners, etc., must be supplied to the Fair officials before the end of the Show.

#### UNOCCUPIED SPACE

If exhibitor fails to occupy space contracted for or fails to comply with all the terms of the agreement, the Show officials have the right to rent such space to any other applicant without releasing the exhibitor from paying the sum agreed upon in his Show contract. No refunds will be made. Exhibitor shall not assign or SUBLET the whole or any part of his space.

#### **EVENTUALITIES**

In the case the LEC shall be destroyed by fire, other elements or by any other cause, or in case other circumstances make it impossible for the Fair officials to permit the contracted space to be occupied by the exhibitor, the Fair contract shall terminate and the exhibitor shall waive any claim for damages or compensation. In case of strikes, acts of God, the authority of law or any cause beyond their control, the Fair officials, LEC and their employees shall not be held liable for the fulfillment of the rental contract of space. Exhibitors hereby waive any claim for damages or compensation.

### MISCELLANEOUS

· Speakers, radios, televisions or noise which is of sufficient volume to be annoying to exhibitors will not be permitted.

No animals are allowed on the show floor.

#### LIABILITY

Neither the Lancaster County Agricultural Society, the Lancaster County Fair committee nor the LEC will be responsible for any injury, loss or damage that may occur to the exhibitor or to the exhibitor's employees or property from any cause whatsoever prior, during or subsequent to the period covered by the Fair contract. Upon signing this contract, the exhibitor expressly releases the foregoing named association, individuals, representatives, committee and officials from any claims from loss, damage or injury. The LEC will be secured during all non-show hours. This security of the LEC in no way assumes any responsibility for the care and safekeeping of exhibits. It is a provision of this contract that all exhibitors have public and property liability insurance to protect themselves, the Lancaster County Fair and its representatives and the LEC against possible claims arising out of negligent acts of his or her employees and booth visitors during the operation of his or her equipment in this show.


#### AMENDMENTS


# A. BACKGROUND AND PREVIOUS STUDIES

Since 1991, the Public Building Commission (PBC) has focused planning efforts on the continued use of the core government citycounty campus located on 9th and 10th streets between "G" Street and "L" Street. The PBC has made significant investments in facilities within this area as a means of providing a central downtown location for delivering Lincoln and Lancaster County residents with services related to criminal justice, law enforcement, and general government administration.

In the last twenty-three years, the PBC has completed two Master Plan documents (1991, 2002) that have guided both short-term and long-term decision-making relative to facility needs. Supplementing these plans, the PBC also completed a condensed 2012 planning study focusing on seven facilities: Trabert Hall, Community Mental Health Center, 605 So. 10th Street Building (former Lancaster County Adult Detention Facility), 900 'J' Street Building, 633 So. 9th Street Building (Courthouse Plaza), K Street Records Warehouse and the 825 'J' Street (Benesch) Building.


The 2014 Facilities Report builds on planning strategies included in the 2002 Master Plan, as well as recommendations documented in the condensed 2012 planning study. As a basis for recommendations, the 2014 Facilities Report examined growth projections completed in 2012 by twelve individual County departments currently occupying PBC-managed facilities identified within the study scope (see Section C Facilities Location Map). Growth projections completed by each department were based on a twenty-year period (2012-2032) to establish long-term benchmarks for future space needs. The twelve departments completing growth projection surveys included:

- Lancaster County Community Mental Health
- Lancaster County Attorney
- Lancaster County Community Corrections
- Lancaster County Sheriff
- Adult Probation
- County Court
- District Court
- Clerk of the District Court
- Juvenile Court
- Juvenile Probation
- City/County Records Management
- Lincoln Police Evidence Storage

## **B. PURPOSE AND OBJECTIVES**

The purpose of the 2014 Facilities Report is to summarize recent initiatives involving twelve properties currently under the management of the Public Building Commission (PBC) and to document recommendations for future use of each facility. Locations of the twelve properties are included in Section C on page 3-4. Recommendations for future use of the identified properties are based on ten primary objectives defined by the PBC during monthly Commission meetings.

- 1. To sustain previous master planning objectives and adapt as necessary to meet current facility demands
- 2. To respect capital investments made to facilities in the 24-year period since the 1991 Master Plan
- 3. To relinquish ownership of the Community Mental Health Building and Trabert Hall
- 4. To continue use of the existing PBC buildings on 9th and 10th Street as the central government campus
- 5. To address critical space deficiencies of departments currently occupying the twelve properties included in the report
- 6. To plan for anticipated growth needs in the Judicial System for a period of 20 years
- 7. To increase staff efficiencies by co-locating departments with multiple divisions currently operating in separate locations
- 8. To increase staff efficiencies by locating highly interactive departments in close proximity
- 9. To increase public convenience by locating related departments in close proximity
- 10. To decrease future space needs through shared intra-departmental space

## D. EVENTS IMPACTING PROPERTY RECOMMENDATIONS

During a two-year period from 2012 to 2014, several initiatives were undertaken by local government entities involving facilities owned by Lancaster County. These initiatives directly impacted facilities managed by the PBC and had a substantial effect on the recommendations formulated in this 2014 Facilities Update Report.

### NEW LANCASTER COUNTY CORRECTIONS FACILITY

In July, 2013, after four years of construction, Lancaster County opened a new 289,000-square-foot S65 million jail in west Lincoln. During the delayed construction of the new facility, the Lancaster County Commissioners authorized a space planning study in January, 2012 to determine the highest and best use of the existing 115,000 square-foot LCADF facility located on 605 South 10th Street in the central government campus. Known as the 605 Building Reuse Study, the primary concept of the study was to adaptively reuse the former detention facility to house justice-related county departments and alleviate the eminent overcrowding in the adjacent Justice and Law Enforcement Center. The recommendation in the 605 Building Reuse Study is consistent with the 2002 County-City Master Plan and can be implemented more economically than constructing a new facility to house similar functions. The proposal to reuse the 605 Building for justice related departments would essentially create a Justice Center Complex comprised of a Justice and Law Enforcement Center - North (current center) and Justice Center and Law Enforcement Center - South (converted 605 Building).

### COURT GROWTH IN THE JUSTICE & LAW ENFORCEMENT CENTER:

Lancaster County has experienced a consistent ten to fifteen year cycle in court growth. For example, the 3rd Judicial District Court received appointments for additional judges in 1972, 1982, 1995 and 2011. Juvenile Court received appointments in 1997 and 2007, and Lancaster County Court added a seventh judge in July, 2012. The high growth of the judicial departments reflects the changing social, economic, public safety, and mental health needs of the community. With the appointments of new judges in recent years, the courtroom floors of the Justice and Law Enforcement Center (2nd, 3rd and 4th) are virtually land-locked, having nearly maximized any growth potential for interior courtroom additions.

### TRABERT HALL, COMMUNITY MENTAL HEALTH, BENESCH BUILDINGS:

On February 28, 2012, the Lancaster County Board voted to buy the Alfred Benesch & Company building located on 825 'J' Street. The intent of the commissioners was to consolidate departments from Trabert Hall (2202 So. 11th Street) and Community Mental Health Center building (2201 South 17th Street) into both the 605 Building and 825 'J' Street Building. Following relocation of these departments, Lancaster County's intends to sell Trabert Hall and the Community Mental Health Building. The anticipated time-frame for relinquishing ownership of these two buildings is 2015 to 2016. The purchase of the 25,000-square-foot 825 'J' Street Building is consistent with the county's 10-year master plan for a county-city campus that locates departments primarily between 7th and 10th streets and 'G' to 'L' streets. Lancaster County currently uses 25,880 square feet of space in Trabert Hall for County Attorney Child Support Division and Adult Probation drug testing and supervision programs. The Community Mental Health Building consists of approximately 45,000 square feet of space.







### SOUTH HAYMARKET NEIGHBORHOOD STUDY, LINCOLN-LANCASTER COUNTY PLANNING DEPARTMENT:

In 2013, the Lincoln-Lancaster County Planning Department (LLCPD) initiated a separate study to set the course for future redevelopment of the area known as "South Haymarket". This area encompasses 38-blocks between 'G' Street (south) 'O' Street (north), 4th Street (west), and 10th Street (east). The boundary area for the LLCPD South Haymarket Neighborhood Study overlaps six full blocks and three partials blocks of the PBC master planning area.

While the South Haymarket Neighborhood Study is still in progress, the LLCPD has preliminarily identified significant areas for mixed-use/residential redevelopment and presented the initial study concepts to the PBC for consideration.

The PBC commends the LLCPD for their foresight in undertaking planning efforts aimed at establishing a long-term vision for the South Haymarket Neighborhood. The PBC has no objections to a majority of the preliminary planning concepts identified in the study.

However, the PBC's approach to property use in seven of the 38 blocks differs from those proposed by the LLCPD in the South Haymarket Neighborhood Study. Specifically, use of the existing PBC buildings within the area from 8th to 9th Street and 'H' Street to 'L' Street have been on a different 25-year planning trajectory in comparison to the concepts recently identified by the LLCPD. The PBC has invested significant financial resources both in terms of new construction and renovation of existing buildings within this seven-block area. Additionally, the PBC has practiced acquisition of contiguous private properties as they became available and subsequently repurposed those properties for delivering government services. Examples include the 825 'J' Street (Benesch) Building, Courthouse Plaza and K-Street Records Warehouse.

### K STREET RECORDS WAREHOUSE

K Street was converted in 1995 from a former power plant to the primary records storage facility for Lincoln and Lancaster County. The close proximity of the K Street facility to the core government campus has provided efficient transfer and retrieval of records on demand. The PBC invested approximately \$3 million in the initial renovation of the facility, which encompasses 115,000 square-feet of storage space on six floors. Of this total square-footage, the PBC leases 67,615 square-feet to the State of Nebraska for storage. These leases are with State Records Management (under the authority of the Secretary of State) and with the Nebraska State Historical Society. The state leases generate over \$350,000 of revenue annually for the PBC. The PBC planning goals are to continue use of K Street as the primary City-County Records facility.

### PARKING STRATEGY

The PBC currently maintains 1,256 parking stalls for employee and public use in areas surrounding the core government campus. The South Haymarket Neighborhood Study calls for construction of new parking decks in the existing employee south surface lot (343 new stalls based on capacity







of 619 minus 276 existing) and adding decks to the existing north deck (169 new stalls based on capacity of 619 minus 450 existing). While the LLCPD South Haymarket Study adds 512 new stalls, it would eliminate the new 98-stall lot on 'H' Street between 8th and 9th streets, as well as the 85 stall surface lot west of the 900 'J' Street building. Under the South Haymarket Study, the total capacity of parking would be approximately 1,600 stalls. However, the study also calls for adding 240,000 square-feet of office buildings. A reasonable calculation based on typical zoning ratios for office parking would call for 800 new stalls (in addition to existing capacity) to serve the new office space. This results in a total need of approximately 2,050 stalls. The South Haymarket Study (1,600 stalls) when implemented will eventually require the addition of 450 stalls to meet the projected demand of 2,050 total parking capacity.

#### DISTRICT ENERGY PLANT

The District Energy plant is currently located on the southwest corner of 9th Street and Rosa Parks Way. It is landlocked on the north and east sides by Rosa Parks Way and 9th Street respectively. It is also bordered on the west by private property (currently TMI Building), leaving the south PBC-owned land as the planned expansion area for the plant. The PBC has held the view that expansion would occur to the south of the existing plant in the event additional government office space is added to the core campus.

The LLCPD South Haymarket study calls for private redevelopment of the parking lot south of the plant, thus precluding the possibility for expansion and increase production capability. Concurrently, the South Haymarket study indicates proposed locations in the government core for relocating existing government offices displaced by the private development on the west side of 9th Street. The study indicates that these locations are capable of adding 240,000 SF of office space for county-city government.

However, if the expansion zone south of the existing DEC plant is relinquished to private development, the District Energy will be unable to expand and thus unable to meet the demand for 240,000 SF of additional heating and cooling.

#### 233 SO. 10TH STREET BUILDING:

The PBC concurs with the LLCPD South Haymarket Study that this site is potentially wellsuited for private redevelopment. The building houses the Lincoln-Lancaster Information Services (I.S.) Department on the second floor, including the primary computer hub for the government campus. Lancaster County Emergency Management (LCEMA) is also located in the lower level of the 233 Building. The PBC has proposed the relocation of I.S. to the third floor of the County/City Government Building. The South Haymarket study also recommends this movement. If private redevelopment were to occur in the short-term, the PBC will examine options for relocating LCEMA to the TMI building located immediately west of the DEC plant. This building is privately-owned at the time of this report.

While there are divergent short-term approaches to existing PBC buildings on seven of the 38-blocks in the South Haymarket study area, the PBC is optimistic that long-term coordination with LLCPD can result in a shared planning vision.


## Justice and Law Enforcement Center and County/City Building

# F. IMPLEMENTATION PLAN

### PHASING SEQUENCE

Successful implementation of the Public Building Commission (PBC) Facilities Plan is highly-dependent on a phased, incremental approach. Recommendations listed on pages 8-19 outline a multi-phase plan anticipated over a 25-year period between 2014 and 2039. The sequence of the phases is critical to the success of the plan and has important cost-savings implications to the PBC.

The following describes the phasing sequence and schedule associated with recommendations of the PBC Facilities Plan. Based on initiatives already started by the PBC, a progression of seven phases has been defined for implementation in the years 2014 to 2016. These initial seven phases encompass the following facilities:

### 2014

Phase 1: Constructed 8th & 'H' Street Parking Lot

### 2014-2015

Phase 2: 605 Building Sallyport Relocation and Interior Demolition Phase 3: 825 J Street Renovation for Mental Health Crisis Center

### 2015-2016

Phase 4: 605 Building Exterior Modifications and Interior Tenant Fit-Out

### 2016

Phase 5: Relinquish Ownership of 2200 St. Mary's Avenue (Community Mental Health) Phase 6: Relinquish Ownership of 2202 So. 11th Street (Trabert Hall) Phase 7: 633 So. 9th Building (Courthouse Plaza) Public Defender 1st Floor Expansion

### FUTURE PHASES DETERMINED BY DEMAND FACTORS

Following completion of the initial seven phases listed above, a series of additional facility improvements will be necessary to address the remaining recommendations in this report. The timing of these future phases will be driven by external demands outside of the direct control of the PBC. Foremost among these is the growth of the courts in the Justice and Law Enforcement Center. For example, renovation for additional courtrooms on second floor of the 605 Building will be implemented as additional judges are added in the Juvenile and District court levels. While these future facility demands are currently predicted to occur between the years 2017 to 2032, the specific timing of each phase is not known at this time.

- Finish 3rd floor County/City Building Tenant Space for Information Services
- Relocate Lancaster County Emergency Management from the 233 Building
- Expand District Energy Plant
- Court Renovations in County/City Building, Justice and Law Enforcement Center (JLEC) and 605 Building including:
  - 1. Additional District Courtroom, Judge's Chambers & Jury Room on the 3rd Level JLEC.
  - 2. Additional County Courtroom, Judge's Chambers & Jury Room on 2nd Level 605 Building.
  - 3. Additional Juvenile Courtroom and Judge's Chamber Set on the 4th Level JLEC.
  - 4. Relocation of Clerk of the District Court to 4th Level of JLEC triggered by appointment of next District Court judge.

# G. OPINION OF PROBABLE CONSTRUCTION COSTS

### PHASING SEQUENCE

The Probable Construction Costs for the initial seven phases of work described in Section F are based on average projected square footage costs (\$/sf) applied to the corresponding areas of conceptual plan diagrams. The intent of this estimate is to provide "order of magnitude" costs that will guide the PBC as it implements the report recommendations. All opinions of cost shown for years 2014 through 2016 include a construction inflation factor of four-percent (4%) per year calculated to the anticipated midpoint of construction.


