MINUTES LANCASTER COUNTY BOARD OF COMMISSIONERS COUNTY-CITY BUILDING, ROOM 112 TUESDAY, DECEMBER 13, 2016 9:00 A.M.

Advance public notice of the Board of Commissioners meeting was posted on the County-City Building bulletin board and the Lancaster County, Nebraska, web site and emailed to the media on December 9, 2016.

The Chair called the meeting to order at 9:00 a.m., the pledge of allegiance was recited and the location of the Nebraska Open Meetings Act was announced.

1) MINUTES:

A. Approval of the minutes of the County Corrections Director finalist meeting held on Friday, December 2, 2016.

MOTION: Schorr moved and Hudkins seconded approval of the minutes. Avery, Hudkins, Schorr, Wiltgen and Amundson voted yes. Motion carried 5-0.

B. Approval of the minutes of the Board of Commissioners meeting held on Tuesday, December 6, 2016.

MOTION: Wiltgen moved and Avery seconded approval of the minutes. Hudkins, Schorr, Wiltgen, Avery and Amundson voted yes. Motion carried 5-0.

2) <u>CLAIMS</u>: Approval of all claims processed through December 13, 2016.

MOTION: Hudkins moved and Avery seconded approval of the claims. Schorr, Wiltgen, Avery, Hudkins and Amundson voted yes. Motion carried 5-0.

3) SPECIAL PRESENTATIONS:

A. Visitors Improvement Fund Grant to the Lincoln Haymarket Development Corporation in the amount of \$7,871.48 for promotion of the Historic Haymarket District Walking Tour – Diane Cunningham, Lincoln Haymarket Development Corporation. (See correlating item 4A)

Diane Cunningham, Lincoln Haymarket Development Corporation Event Chair, appeared and gave an overview of the grant request. She said the funds will be used to enhance their informational brochures.

B. Recognition of County Commissioner Larry Hudkins for his dedicated service to the people of Lancaster County.

Item was held until later in the meeting.

4) <u>NEW BUSINESS</u>:

A. Visitors Improvement Fund Grant with the Lincoln Haymarket Development Corporation in the amount of \$7,871.48 for the purpose of promoting the Historic Haymarket District Walking Tour. The term of the contract is January 1, 2017 through December 31, 2017. (C-16-0706)

MOTION: Hudkins moved and Schorr seconded approval of the grant contract. Wiltgen, Avery, Hudkins, Schorr and Amundson voted yes. Motion carried 5-0.

B. Appointment of Allen Blezek, Paula Peterson and Larry Williams to the Lancaster County Extension Board for three-year terms commencing January 1, 2017 and ending December 31, 2019.

Karen Wobig, County Extension Educator, Unit Leader, appeared and introduced the three nominees for appointment. Allen Blezek, Paula Peterson and Larry Williams provided brief overviews of their background and their interest in serving on the County Extension Board.

MOTION: Hudkins moved and Wiltgen seconded approval of the appointments. Wiltgen, Schorr, Hudkins, Avery and Amundson voted yes. Motion carried 5-0.

C. Setting the annual salary for Brad Johnson, County Corrections Director, in the amount of \$106,000, effective December 8, 2016 with a six-month review and associated increase of the annual salary to \$110,000.

MOTION: Wiltgen moved and Schorr seconded approval of the salary.

AMENDMENT: Avery proposed to amend the review period to three months. He explained the Board went through a lengthy vetting process whereby Johnson served as interim director.

The seconder of the motion accepted the amendment.

ROLL CALL: Schorr, Hudkins, Avery, Wiltgen and Amundson voted yes. Motion carried 5-0.

D. Resolution in the matter of authorizing the County Clerk to issue payments while the County Board is adjourned. (R-16-0080)

MOTION: Schorr moved and Hudkins seconded approval of the resolution. Hudkins, Avery, Wiltgen, Schorr and Amundson voted yes. Motion carried 5-0.

E. Resolution authorizing the installation and removal of traffic signs in Lancaster County. (R-16-0081)

Pam Dingman, County Engineer, stated the majority of the signs on the list are associated with placement of new pavement in the Waverly area.

MOTION: Wiltgen moved and Schorr seconded approval of the resolution. Avery, Wiltgen, Schorr, Hudkins and Amundson voted yes. Motion carried 5-0.

F. Grant contract with the City of Lincoln on behalf of the Lincoln Police Department in the amount of \$52,000 to provide the supervision and gang suppression components of the Operation Tipping Point program. The City will document \$14,767 in matching funds. Term of the grant contract is from July 1, 2016 through June 30, 2017. (C-16-0690)

Sara Hoyle, Human Services Director, said the full-time gang outreach coordinator is employed by the City of Lincoln. The City will provide funding for office space, a computer, parking and internet access and the County will be responsible for the coordinator's salary.

MOTION: Schorr moved and Wiltgen seconded approval of the grant contract. Wiltgen, Hudkins, Avery, Schorr and Amundson voted yes. Motion carried 5-0.

G. Real estate purchase and sale agreement with Wyuka Cemetery for property adjacent to 625 North 46th Street, Lincoln, Nebraska. There is no cost to the County. (C-16-0713)

MOTION: Schorr moved and Hudkins seconded approval of the real estate purchase and sale agreement. Avery, Schorr, Hudkins, Wiltgen and Amundson voted yes. Motion carried 5-0.

H. Agreement with Christian Heritage for implementation of relationship workshops and parental involvement training at the Lancaster County Department of Corrections. The County will pay \$24,876.75 per year for the services. Term of the agreement is January 1, 2017 through December 31, 2018. (C-16-0709)

Brad Johnson, Corrections Director, and Brenda Fisher, Program Director, Corrections Department, appeared and discussed the two programs provided by Christian Heritage. Johnson said this is a renewal of a contract providing parenting and relationship classes for inmates.

In response to a question from Avery, Fisher said the Corrections Department did not pursue other entities to provide the services because Christian Heritage is the current provider and she has received very positive feedback from the participants. Johnson added that the funds come from the Inmate Benefits Fund.

MOTION: Hudkins moved and Wiltgen seconded approval of the agreement. Hudkins, Wiltgen, Schorr, Avery and Amundson voted yes. Motion carried 5-0.

I. Lease with Piertek, Inc., for land located at 801 Westgate Boulevard, Lincoln, Lancaster County, to facilitate Piertek, Inc.'s construction project. The term of the lease is December 13, 2016 through February 13, 2017. The County shall not receive monetary compensation. (C-16-0710)

Dingman stated the section of land is across from the County Engineer Shop. She said the adjacent landowner is constructing an expansion and the agreement will allow him to store construction materials in this area. The landowner has also agreed to restore any damage once the construction is completed.

MOTION: Hudkins moved and Wiltgen seconded approval of the lease.

Avery asked why there is no monetary transaction. Dingman said it is a temporary situation and explained the agreement is intended to cover any legal issues.

Ron Bohaty, Assistant Road Maintenance Superintendent, County Engineering, added the landowner has also agreed to place a retaining wall along a drainage ditch separating the two properties that has suffered some erosion.

ROLL CALL: Schorr, Avery, Wiltgen, Hudkins and Amundson voted yes. Motion carried 5-0.

J. Professional services agreement with Mainelli Wagner & Associates to finalize plans relating to Bridge Replacement Project No. C-55-C-91, located on Raymond Road. The work shall be completed by March 15, 2017. Cost to County is \$23,485.94. (C-16-0711)

Dingman said the agreement will complete the bridge plans as well as provide for the wetlands permitting. She stated construction should begin next spring.

In response to Avery's inquiry whether the bridge is a priority, Dingman responded yes.

MOTION: Schorr moved and Wiltgen seconded approval of the agreement.

Hudkins asked how traffic will be re-routed and the timeline for completion. Dingman said the bridge will be complex to construct because it spans the tiger beetle and salt wort habitat. In addition, there is also the possibility of the long eared brown bat being present. She stated a shoo fly is not an option and construction could take in the range of two to four months.

ROLL CALL: Avery, Hudkins, Schorr, Wiltgen and Amundson voted yes. Motion carried 5-0.

MOTION: Schorr moved and Wiltgen seconded approval of the contracts. Hudkins, Schorr, Wiltgen, Avery and Amundson voted yes. Motion carried 5-0.

L. Contract with Altec Industries to provide preventive maintenance and inspection for aerial lifts and trucks (Quote No. 5482). Term of the contract is one year from the date of execution. Cost to the County is not to exceed \$1,000. (C-16-0707)

MOTION: Schorr moved and Hudkins seconded approval of the contract. Schorr, Wiltgen, Avery, Hudkins and Amundson voted yes. Motion carried 5-0.

M. Designation of official Lancaster County newspapers for 2017 publication of transportation projects as follows: Lincoln Journal Star, The Voice (Hickman) and The News (Waverly).

MOTION: Wiltgen moved and Avery seconded approval of the newspaper designation. Wiltgen, Avery, Hudkins, Schorr and Amundson voted yes. Motion carried 5-0.

N. Deposit placement agreement and custodial agreement with Security First Bank for certificate of deposit account registry services. (C-16-0712)

MOTION: Hudkins moved and Schorr seconded approval of the agreements. Avery, Hudkins, Schorr, Wiltgen and Amundson voted yes. Motion carried 5-0.
