WHEREAS, the revised contract total with the additional service and the increase in expenditure not to exceed \$26,500.00; and

NOW, THEREFORE, IN CONSIDERATION of the mutual covenants contained in the County Contract No. C -13-0550 and stated herein the parties agree as follows:

- 1) The parties wish to amend the contract to add additional Armored Car service at Department of Motor Vehicles at 500 West O Street, Lincoln, Nebraska, per Attachment A.
- 2) The expenditure for this service is \$216.50 per month, for the remainder of the current term.
- 3) The parties wish to amend the Contract to increase the County's maximum expenditure \$13,300.00 for the remainder of this term.
- 3) The revised contract total with the additional service and the increase in expenditure not to exceed \$26,500.00.
- 4) All other terms of the Contract, not in conflict with this Amendment, shall remain in full force and effect.

The Parties do hereby agree to all the terms and conditions of this Amendment. This Amendment shall be binding upon the parties, their heirs, administrators, executors, legal and personal representatives, successors, and assigns.
