This Amendment is hereby entered into by and between Lincoln Journal Star, 926 P Street, Lincoln, NE 68508 (hereinafter "Contractor") and City of Lincoln, Lancaster County and the City of Lincoln-Lancaster County Public Building Commission, (hereinafter "Owners"), for the purpose of amending the Contract dated March 26, 2013, executed under City Executive Order No. 85914, and County Contract C-13-0151, dated April 9, 2013, and executed by the City of Lincoln-Lancaster County Public Building Commission, on April 18, 2013, for Annual Requirements - Publishing Legal Notices and All Other Verbiage Necessary to Conduct City/County/PBC Business, Bid No. 13-029, which is made a part hereof by this reference.

WHEREAS, the original term of the Contract is April 18, 2013 through April 18, 2014, with the option to renew for three (3) additional one (1) year terms.

WHEREAS, the Contract was amended by City Executive Order No. 87168 on May 16, 2014, and by the County Contract C-14-0221, executed by the County Board on April 29, 2014, and executed by the City of Lincoln-Lancaster County Public Building Commission on May 22, 2014 to renew the contract for an additional one (1) year period from April 9, 2014 through April 8, 2015; and

WHEREAS, the Contract was amended by City Executive Order No. 88148 on April 8, 2015, and by the County Contract C-15-0162, executed by the County Board on March 31, 2015, and executed by the City of Lincoln-Lancaster County Public Building Commission on May 13, 2017 to renew the contract for an additional one (1) year period from April 9, 2015 through April 8, 2016; and

WHEREAS, the Contract was amended by City Executive Order No. 89276 on April 4, 2016, and by the County Contract C-16-0266, executed by the County Board on June 7, 2016, and executed by the City of Lincoln-Lancaster County Public Building Commission on April 12, 2016 to renew the contract for an additional one (1) year period from April 9, 2016 through April 8, 2017; and

WHEREAS, the parties wish to extend the Contract from April 9, 2017 through June 8, 2017; and

WHEREAS the estimated expenditures for the City of Lincoln for the term of this extension shall not exceed \$3,100.00 for Contracts during the contract term without prior approval by the City of Lincoln; and

WHEREAS the estimated expenditures for Lancaster County for the term of this extension shall not exceed \$600.00 for Contracts during the contract term without prior approval by the Lancaster County Board of Commissioners; and

WHEREAS the estimated expenditures for City of Lincoln-Lancaster County Public Building Commission for the term of this extension shall not exceed \$200.00 for Contracts during the contract term without prior approval by the Public Building Commission; and

NOW, THEREFORE, IN CONSIDERATION of the mutual covenants contained in the Contract, under City Resolution No. A-85914 and County Contract No. C-13-0151, and stated herein the parties agree as follows:

- 1) The parties wish to extend the Contract from April 9, 2017 through June 8, 2017.
- 2) The estimated expenditures for the City of Lincoln for the term of this extension shall not exceed \$3,100.00 for Contracts during the contract term without prior approval by the City of Lincoln.
- 3) The estimated expenditures for Lancaster County for the term of this extension shall not exceed \$600.00 for Contracts during the contract term without prior approval by the Lancaster County Board of Commissioners.
- 4) The estimated expenditures for City of Lincoln-Lancaster County Public Building Commission for the term of this extension shall not exceed \$200.00 for Contracts during the contract term without prior approval by the Public Building Commission.
- 5) All other terms of the Contract, not in conflict with this Amendment, shall remain in full force and effect.

The Parties do hereby agree to all the terms and conditions of this Amendment. This Amendment shall be binding upon the parties, their heirs, administrators, executors, legal and personal representatives, successors, and assigns.
