This Amendment is hereby entered into by and between NMC, Inc., 401 NW 56th Street, Lincoln, NE 68528 (hereinafter "Contractor") and City of Lincoln and Lancaster County, (hereinafter "Owners"), for the purpose of amending the Contract dated August 28, 2015 executed under City Directorial Order No. 13697, and County Contract C-15-0407, dated August 25, 2015 for Annual Supply - Caterpillar Filters, SS-24, which is made a part hereof by this reference.

WHEREAS, the parties wish to amend the Contract to reflect a price increase per Attachment A for the remainder of the current term; and

WHEREAS, the expenditures for the City of Lincoln Public Works and Utilities Department will increase by \$600.00 for the remainder of this Contract term; and

WHEREAS, the expenditures for Lancaster County will increase by \$2,000.00 for the remainder of this Contract term; and

WHEREAS, the revised contract total with the price increase for the City of Lincoln Public Works and Utilities Department is 6,600.00; and

WHEREAS, the revised contract total with the price increase for Lancaster County is \$20,000.00; and

NOW, THEREFORE, IN CONSIDERATION of the mutual covenants contained in the Contract, under City Directorial Order No. 13697, and County Contract No. C-15-0407 and stated herein the parties agree as follows:

- 1) The parties wish to amend the Contract to reflect a price increase per Attachment A for the remainder of the current term.
- 2) The expenditures for the City of Lincoln Public Works and Utilities Department will increase by \$600.00 for the remainder of this Contract term.
- 3) The expenditures for Lancaster County will increase by \$2,000.00 for the remainder of this Contract term.
- 4) The revised contract total with the price increase for the City of Lincoln Public Works and Utilities Department is 6,600.00.
- 5) The revised contract total with the price increase for Lancaster County is \$20,000.00.
- 6) All other terms of the Contract, not in conflict with this Amendment, shall remain in full force and effect.

The Parties do hereby agree to all the terms and conditions of this Amendment. This Amendment shall be binding upon the parties, their heirs, administrators, executors, legal and personal representatives, successors, and assigns.


