

GRANT CONTRACT AMENDMENT

This Amendment is entered into by and between COUNTY OF LANCASTER, NEBRASKA, a political subdivision, hereinafter referred to as "Sponsor", and LIGHTHOUSE, INC., a nonprofit organization, hereinafter referred to as "Grantee".

WHEREAS, the parties entered into a Grant Contract executed by the County on October 18, 2016, under County Contract No. C-16-0624 and amended on November 22, 2016, under County Contract No. C-16-0686 ("the Grant Contract"), for the Restorative Justice program; and

WHEREAS, the Sponsor agreed to and has provided funding for the Grant Contract by expending State grant funds from the Nebraska Commission on Law Enforcement and Criminal Justice Community-based Juvenile Services Aid State Grant #15-EB-0602; and

WHEREAS, the original source of funding for the Grant Contract award of \$24,294.00 was solely Nebraska Commission on Law Enforcement and Criminal Justice Community-based Juvenile Services Aid State Grant #15-EB-0602; and

WHEREAS, the Sponsor desires to modify the source of funding for the Grant Contract award of \$24,294.00 to include two Nebraska Commission on Law Enforcement and Criminal Justice Community-based Juvenile Services Aid State Grants as follows: Nebraska Commission on Law Enforcement and Criminal Justice Community-based Juvenile Services Aid State Grant #15-EB-0602 in the amount of \$15,494.12; and Nebraska Commission on Law Enforcement and Criminal Justice Community-based Juvenile Services Aid State Grant #16-CB-0523 in the amount of \$8,799.88.

NOW THEREFORE, in consideration of the mutual covenants contained in the October 18, 2016, Grant Contract under County Contract Number C-16-0624, amended on November 22, 2016, under County Contract No. C-16-0686, and hereinafter, it is agreed by and between the parties that the following amendment to the Grant Contract be made:

Amend Paragraph 4 of the Grant Contract by substituting the following language:


Grant: In order to assist the Grantee in financing the cost of the project described in Paragraph 1 above for a period of twelve (12) months from July 1, 2016 through June 30, 2017, the Sponsor shall make a total Grant of \$24,294.00 (Twenty Four Thousand Two Hundred Ninety Four Dollars), from the Grants Fund, with \$15,494.12 coming from Nebraska Commission on Law Enforcement and Criminal Justice Community-based Juvenile Services Aid State Grant #15-EB-0602, and \$8,799.88 coming from Nebraska Commission on Law Enforcement and Criminal Justice Community-based Juvenile Services Aid State Grant #16-CB-0523.

All other terms of the Grant Contract, not in conflict with this Amendment, shall remain in full force and effect.

The Sponsor and the Grantee do hereby agree to all the terms and conditions of this Amendment. This Amendment shall be binding upon the parties, their heirs, administrators, executors, legal and personal representatives, successors, and assigns, and shall be effective upon execution by both parties.
