

**AMENDMENT TO CONTRACT**

This Amendment is hereby entered into by and between Galls, 1340 Russell Cave Road, Lexington, KY 40505 (hereinafter "Contractor") and City of Lincoln, Lancaster County and the City of Lincoln-Lancaster County Public Building Commission, (hereinafter "Owners"), for the purpose of amending the Contract dated March 16, 2015, executed under City Resolution No. A-88803, and County Contract C-15-0148, dated March 24, 2015, and executed by the City of Lincoln-Lancaster County Public Building Commission, on April 14, 2015, for Annual Supply - Work Clothing, Bid No. 15-019, which is made a part hereof by this reference.

WHEREAS, the parties wish to amend the Contract to reflect a 1% price increase for all items awarded on this contract, as per Attachment A for the remainder of the current term; and

WHEREAS, the estimated expenditures for the City of Lincoln will increase by \$200.00 for the remainder of this Contract term; and

WHEREAS, the estimated expenditures for Lancaster County will increase by \$150.00 for the remainder of this Contract term; and

WHEREAS, the estimated expenditures for the City of Lincoln-Lancaster County Public Building Commission will increase by \$100.00 for the remainder of this Contract term; and

WHEREAS, the revised contract total with the price increase for the City of Lincoln is estimated to be \$6,200.00; and

WHEREAS, the revised contract total with the price increase for Lancaster County is estimated to be \$4,150.00; and

WHEREAS, the revised contract total with the price increase for the City of Lincoln-Lancaster County Public Building Commission is estimated to be \$4,100.00; and

NOW, THEREFORE, IN CONSIDERATION of the mutual covenants contained in the Contract, under City Resolution No.88803, and County Contract C-15-0148 and stated herein the parties agree as follows:

- 1) The parties wish to amend the Contract to reflect a 1% price increase for all items awarded on this contract, as per Attachment A for the remainder of the current term.
- 2) The estimated expenditures for the City of Lincoln will increase by \$200.00 for the remainder of this Contract term.
- 3) The estimated expenditures for Lancaster County will increase by \$150.00 for the remainder of this Contract term.
- 4) The estimated expenditures for the City of Lincoln-Lancaster County Public Building Commission will increase by \$100.00 for the remainder of this Contract term.
- 5) The revised contract total with the price increase for the City of Lincoln is estimated to be \$6,200.00.
- 6) The revised contract total with the price increase for Lancaster County is estimated to be \$4,150.00.
- 7) The revised contract total with the price increase for the City of Lincoln-Lancaster County Public Building Commission is estimated to be \$4,100.00.
- 8) All other terms of the Contract, not in conflict with this Amendment, shall remain in full force and effect.

The Parties do hereby agree to all the terms and conditions of this Amendment. This Amendment shall be binding upon the parties, their heirs, administrators, executors, legal and personal representatives, successors, and assigns.


