AMENDMENT

THIS AMENDMENT, is entered into as of the date of the last party to sign below (“Amendment Effective Date”) by and between the County of Lancaster, Nebraska, a political subdivision of the State of Nebraska (hereinafter the “Customer”), and Global Software, LLC. (hereinafter “Global Software”).

WHEREAS, the parties entered into a perpetual license agreement executed by the Customer on May 11, 2006, under County Contract Number C-06-0201, to grant a non-exclusive, non-transferable full license for five users to use computer software called Spreadsheet Server for J.D. Edwards in the amount of \$9,000.00 (“the Contract”);

WHEREAS, the parties previously agreed to amend the Contract to allow the Customer to purchase additional full licenses in four separate amendments, one being executed by the Customer on April 17, 2007, under County Contract Number C-07-0132; one being executed by the Customer on December 4, 2012, under County Contract Number C-12-0667; one being executed by the Customer on December 9, 2014, under County Contract Number C-14-0615; and one being executed by the Customer on June 30, 2015, under County Contract Number C-15-0323;

WHEREAS, the parties previously agreed to amend the Contract to allow the Customer to purchase additional limited licenses by amendment executed by the Customer on March 1, 2016, under County Contract C-16-0099;

WHEREAS, the parties previously agreed to amend the Contract to allow the Customer to upgrade existing limited licenses to full-use licenses for two users by amendment executed by the Customer on November 13, 2016, under County Contract C-16-0682;

WHEREAS, limited licenses for additional users can be purchased for \$1,000.00 per user; and

WHEREAS, the Customer desires to purchase a limited license for one user;

NOW THEREFORE, in consideration of the mutual covenants contained in the May 16, 2006, license agreement under County Contract Number C-06-0201, and all amendments thereto, it is agreed by and between the parties that the following amendment to the Contract be made as of the Amendment Effective Date:

1. Amend page 1, under the headings Product Name and List Price, by substituting the following:
