This Amendment is hereby entered into by and between Bob Barker Company, 134 North Main Street, Fuquay-Varina, NC 27526 (hereinafter "Contractor") and Lancaster County (hereinafter "County"), for the purpose of amending the Contract dated November 16, 2010, executed under County Contract No. C-10-0590, for Annual Supply - Corrections Staff Clothing, Inmate Clothing and Accessories, Bid No. 10-168, which is made a part hereof by this reference.

WHEREAS, the original term of the Contract is November 16, 2010 through November 15, 2013, with the option to renew for one (1) additional three (3) year term upon written mutual consent of both parties; and

WHEREAS, the Contract was amended by County Contract No. C-13-0535 on October 29, 2013, to renew the contract for an additional three (3) year term from November 16, 2013 through November 15, 2016; and

WHEREAS, the Contract was amended by County Contract No. C-16-0648 on November 8, 2016, to extend the contract for an additional three (3) month term from November 16, 2016 through February 15, 2017; and

WHEREAS, the Contract was amended by County Contract No. C-17-0030 on January 31, 2017, to extend the contract for an additional two (2) month term from February 16, 2017 through April 15, 2017; and

WHEREAS, the Contract was amended by County Contract No. C-17-0228 on March 28, 2017, to extend the Contract for an additional two (2) month term beginning April 16, 2017 through June 15, 2017; and

WHEREAS, the parties hereby extend the Contract for an additional two (2) month term beginning June 16, 2017 through August 15, 2017; and

WHEREAS, the expenditures for Lancaster County for the term of this extension shall not exceed \$10,800.00 without prior approval by the Lancaster County Board of Commissioners; and

NOW, THEREFORE, IN CONSIDERATION of the mutual covenants contained in the Contract, under County Contract C-10-0590, and stated herein the parties agree as follows:

- 1) The parties wish to extend the Contract for an additional two (2) month term beginning June 16, 2017 through August 15, 2017.
- 2) The expenditures for Lancaster County for the term of this extension shall not exceed \$10,800.00 without prior approval by the Lancaster County Board of Commissioners.
- 3) All other terms of the Contract, not in conflict with this Amendment, shall remain in full force and effect.

The Parties do hereby agree to all the terms and conditions of this Amendment. This Amendment shall be binding upon the parties, their heirs, administrators, executors, legal and personal representatives, successors, and assigns.
