

AMENDMENT

THIS AMENDMENT is entered into by and between Klaus Hartmann, MD, (hereinafter referred to as “the Contractor”) and the County of Lancaster, Nebraska (hereinafter referred to as “the County”). Individually, the County and the Contractor may be referred to as a “Party,” and collectively they may be referred to as “Parties.”

WHEREAS, the Parties entered into an Agreement pursuant to Lancaster County Contract C-16-0393, executed by Lancaster County on July 26, 2016;

WHEREAS, the original term of the Agreement was from July 1, 2016, through June 30, 2017;

WHEREAS, the Parties wish to extend the Agreement for an additional one (1) year term beginning July 1, 2017, through June 30, 2018; and

WHEREAS, the Parties wish to amend the rate of compensation under the Agreement during the extension term;

NOW, THEREFORE, in consideration of the mutual covenants contained in the original Agreement and stated herein, the Parties agree as follows:

1. Section 1 of the Agreement shall be amended to read as follows:

1) Term. The length of this Agreement shall be from July 1, 2016, through June 30, 2018, unless terminated by either party pursuant to Paragraph 11 of this Agreement.

2. Section 5)A. of the Agreement shall be amended by inserting a new paragraph after the existing language therein, which new paragraph shall read as follows:

However, during the period from July 1, 2017, through June 30, 2018, the County will pay the Contractor Seven Hundred Twenty-Five Dollars (\$725.00) per twenty-four (24) hour time period of coverage. These amounts are to be paid only upon presentment of a statement for reimbursement and documentation that services have been provided pursuant to this Agreement. Statements will be submitted to the County for review prior to any payment for services

3. All other terms of the Agreement, not in conflict with this Amendment, shall remain in full force and effect.

The Parties do hereby agree to all the terms and conditions of this Amendment. This Amendment shall be binding upon the Parties, their heirs, administrators, executors, legal and personal representatives, successors, and assigns.

Dear Healthcare Provider:

On November 28, 2016, we received \$855.00, which represents 26% of the premium which you are being charged by Midwest Medical Insurance Company for \$500,000/\$1,000,000 limits coverage. Your renewal coverage with the Act is effective from January 1, 2017 to January 1, 2018. It will be necessary to requalify each policy period.

As a reminder, a qualified health care provider shall post and keep posted in a suitable location where all patients may easily see it, a sign of the size and type prescribed by the Director stating they have qualified under the provisions of the Nebraska Hospital-Medical Liability Act 44-2821(4).


