WHEREAS, the parties hereby extend the Contract for an additional three (3) month term beginning June 25, 2017 through September 25, 2017; and

WHEREAS, the parties hereby amend the Contract to reflect a price increase per Attachment A; and

WHEREAS, the revised contract total with the price increase will remain the same at \$11,000.00; and

NOW, THEREFORE, IN CONSIDERATION of the mutual covenants contained in the Contract, under County Contract C-13-0273, and stated herein the parties agree as follows:

- 1) The parties hereby extend the Contract for an additional three (3) month term beginning June 25, 2017 through September 25, 2017.
- 2) The parties hereby amend the Contract to reflect a price increase per Attachment A.
- 3) The revised contract total with the price increase will remain the same at \$11,000.00.
- 4) All other terms of the Contract, not in conflict with this Amendment, shall remain in full force and effect.

The Parties do hereby agree to all the terms and conditions of this Amendment. This Amendment shall be binding upon the parties, their heirs, administrators, executors, legal and personal representatives, successors, and assigns.
