This Amendment is hereby entered into by and between Concrete Industries, Inc., 6300 Cornhusker Highway, Post Office Box 29529, Lincoln, NE 68529 (hereinafter "Contractor") and Lancaster County, (hereinafter "County"), for the purpose of amending the Contract dated July 29, 2014, under County Contract No. C-14-0377, for Annual Supply - Asphaltic Joint Sealant, Bid No. 14-153, which is made a part hereof by this reference.

WHEREAS, the original term of the Contract is July 29, 2014 through July 28, 2015, with the option to renew for three (3) additional one (1) year terms upon written mutual consent of both parties; and

WHEREAS, the Contract was amended by County Contract C-15-0372 executed by the County Board on July 28, 2015 to renew the contract for an additional one (1) year term from July 29, 2015 through July 28, 2016; and

WHEREAS, the Contract was amended by County Contract C-16-0290 executed by the County Board on June 21, 2016 to renew the contract for an additional one (1) year term from July 29, 2016 through July 28, 2017; and

WHEREAS, the parties hereby to renew the Contract for an additional one (1) year term beginning July 29, 2017 through July 28, 2018; and

WHEREAS, the expenditures for Lancaster County for the term of this renewal shall not exceed \$15,000.00 without approval by the Lancaster County Board of Commissioners; and

NOW, THEREFORE, IN CONSIDERATION of the mutual covenants contained in County Contract No. C-14-0377, and stated herein the parties agree as follows:

- 1) The parties hereby renew the Contract for an additional one (1) year term beginning July 29, 2017 through July 28, 2018.
- 2) The expenditures for Lancaster County for the term of this renewal shall not exceed \$15,000.00 without approval by the Lancaster County Board of Commissioners.
- 3) All other terms of the Contract, not in conflict with this Amendment, shall remain in full force and effect.

The Parties do hereby agree to all the terms and conditions of this Amendment. This Amendment shall be binding upon the parties, their heirs, administrators, executors, legal and personal representatives, successors, and assigns.


