This Amendment is hereby entered into by and between Murphy Tractor & Equipment Co., Inc., 6100 Arbor Road, Lincoln, NE 68517 (hereinafter "Owner") and Lancaster County (hereinafter "County"), for the purpose of amending the Contract dated January 31, 2017, executed under County Contract No. C-17-0033, for Skid Steer Loader Rentals, Bid No. 16-271, which is made a part hereof by this reference.

WHEREAS, on January 31, 2017, the County agreed to lease for the County Engineer one skid loader from the Owner pursuant to County Contract No. C-17-0033, for the period from February 1, 2017, through January 31, 2018;

WHEREAS, pursuant to County Contract No. C-17-0327 the parties amended Contract No. C-17-0033 on May 16, 2017, to lease a Skid Loader and Pallet for County Corrections through the remainder of the original lease period; and

WHEREAS, the parties hereby revise the contract period of the Skid Steer Loader and Pallet Fork for County Corrections from May 16, 2017 through January 31, 2018 to May 22, 2017 through May 21, 2018, as per Attachment A (there will be no change in pricing).

NOW, THEREFORE, IN CONSIDERATION of the mutual covenants contained in the County Contract No. C-17-0033 and stated herein the parties agree as follows:

- 1) The parties hereby revise the contract period of the Skid Steer Loader and Pallet Fork for County Corrections from May 16, 2017 through January 31, 2018 to May 22, 2017 through May 21, 2018, as per Attachment A (there will be no change in pricing).
- 2) All other terms of the Contract, not in conflict with this Amendment, shall remain in full force and effect.

The Parties do hereby agree to all the terms and conditions of this Amendment. This Amendment shall be binding upon the parties, their heirs, administrators, executors, legal and personal representatives, successors, and assigns.
