

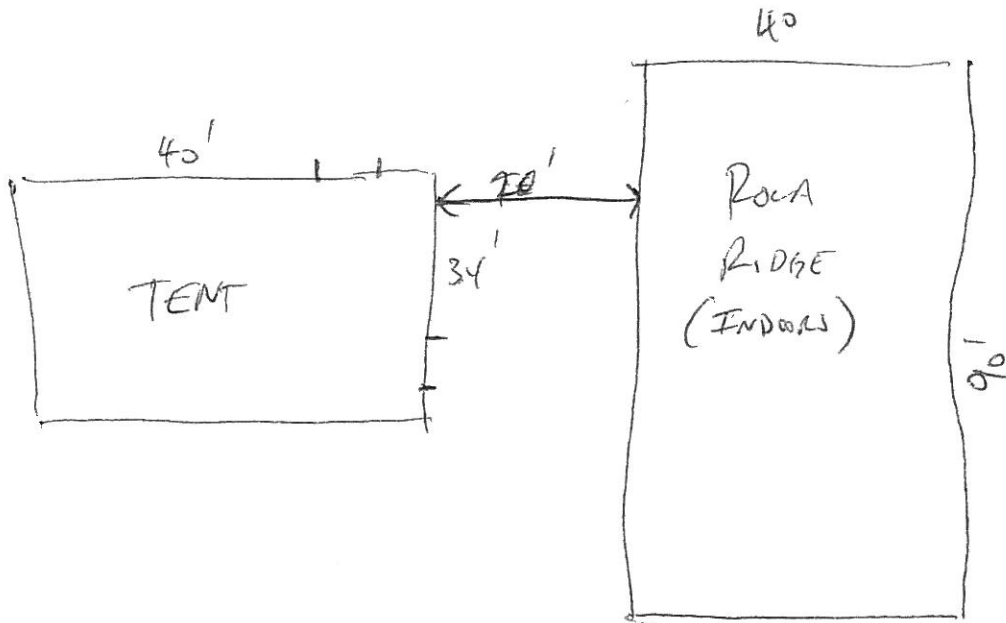


Dear Ms. Lundgren:
