This Amendment is hereby entered into by and between Fastenal Company, 500 W. South Street, Suite 11, Lincoln, NE 68521-1744 (hereinafter "Contractor") and the City of Lincoln and Lancaster County (hereinafter "Owners"), for the purpose of amending the Contract dated May 25, 2016 executed under City Executive Order No. 89460, and County Contract C-16-0265, dated June 7, 2016 for Annual Supply - Industrial Supplies, WSCA Master Price Agreement 1862, State of NE Contract No. 14284 OC, which is made a part of this amendment by this reference.

WHEREAS, the original term of the Contract is May 25, 2016 through February 28, 2017; and

WHEREAS, the Contract was amended by City Directorial Order No. 16828, executed by the City on April 5, 2017, and by County Contract No. C-17-0256, executed by the County Board on April 11, 2017 to extend the Contract for a four (4) month term, beginning March 1, 2017 through June 30, 2017; and

WHEREAS, the parties hereby renew the Contract for an additional one (1) year term beginning July 1, 2017 through June 30, 2018; and

WHEREAS, the expenditures for the City of Lincoln for the term of this renewal shall not exceed \$40,000.00 without approval by the City of Lincoln; and

WHEREAS, the expenditures for Lancaster County for the term of this renewal shall not exceed \$2,000.00 without approval by the Lancaster County Board; and

NOW, THEREFORE, IN CONSIDERATION of the mutual covenants contained in the Contract under City Executive Order No. 89460 and County Contract C-16-0265, all amendments thereto, and as stated herein, the parties agree as follows:

- 1) The parties hereby renew the Contract for an additional one (1) year term beginning July 1, 2017 through June 30, 2018.
- 2) The expenditures for the City of Lincoln for the term of this renewal shall not exceed \$40,000.00 without approval by the City of Lincoln.
- 3) The expenditures for Lancaster County for the term of this renewal shall not exceed \$2,000.00 without approval by the Lancaster County Board.
- 4) All other terms of the Contract, not in conflict with this Amendment, shall remain in force and effect.

The Parties do hereby agree to all the terms and conditions of this Amendment. This Amendment shall be binding upon the parties, their heirs, administrators, executors, legal and personal representatives, successors, and assigns.



(These modifications or additions apply only to actions and relationships within the executing Participating State.)



