This Amendment is hereby entered into by and between Nebraska Salt & Grain Co., 115 W. 16th St., PO Box 489, Gothenburg, NE 69138(hereinafter "Contractor") and the City of Lincoln and Lancaster County (hereinafter "Owners"), for the purpose of amending the Contract dated August 25, 2016, executed under City Executive Order No. 89746, and County Contract C-16-0472, dated August 23, 2016 for Annual Supply - Road Salt, Bid No. 16-173, which is made a part of this amendment by this reference.

WHEREAS, the original term of the Contract is September 13, 2016 through September 12, 2017, with the option to renew for three (3) additional one (1) year terms upon written mutual consent by all parties; and

WHEREAS, the parties hereby renew the Contract for an additional one (1) year term beginning September 13, 2017 through September 12, 2018; and

WHEREAS, the expenditures for the City of Lincoln, Public Works & Utilities Department for the term of this renewal shall not exceed \$250,000.00 without approval by the City of Lincoln; and

WHEREAS, the expenditures for Lancaster County, County Engineer Department for the term of this renewal shall not exceed \$45,230.00 without approval by the Lancaster County Board; and

NOW, THEREFORE, IN CONSIDERATION of the mutual covenants contained in the Contract under City Executive Order No. 89746 and County Contract C-16-0472, all amendments thereto, and as stated herein, the parties agree as follows:

- 1) The parties hereby renew the Contract for an additional one (1) year term beginning September 1, 2017 through August 31, 2018.
- 2) The expenditures for the City of Lincoln, Public Works & Utilities Department for the term of this renewal shall not exceed \$250,000.00 without approval by the City of Lincoln.
- 3) The expenditures for Lancaster County, County Engineer Department for the term of this renewal shall not exceed \$45,230.00 without approval by the Lancaster County Board.
- 4) All other terms of the Contract, not in conflict with this Amendment, shall remain in force and effect.

The Parties do hereby agree to all the terms and conditions of this Amendment. This Amendment shall be binding upon the parties, their heirs, administrators, executors, legal and personal representatives, successors, and assigns.
