AUTHORIZING TEMPORARY )  
INSTALLATION OF TRAFFIC CONTROL) RESOLUTION NO. R-17-0070  
DEVICES IN LANCASTER COUNTY )

WHEREAS, NEB. REV. STAT. § 60-6,121 provides that Lancaster County (“County”) shall place and maintain such traffic control devices upon highways within its jurisdiction to carry out the provisions of the Nebraska Rules of the Road or to regulate, warn, or guide traffic;

WHEREAS, NEB. REV. STAT. § 60-670 provides that traffic control devices include any sign, signal, marking, or other device not inconsistent with the Nebraska Rules of the Road placed or erected by authority of the County for the purpose of regulating, warning, or guiding traffic;

WHEREAS, the Lancaster County Engineer (“Engineer”) in the Engineer’s capacity as County Highway Superintendent, has control, government, and supervision of all the public roads and bridges in the County under the general supervision and control of the County Board of County Commissioners (“Board”) pursuant to Neb. Rev. Stat. § 39-1507; and

WHEREAS, due to the increased traffic on West Old Cheney Road resulting from the closure of West Denton Road for bridge repair to Structure N-138, the Engineer has informed the Board that it is in the best interest of the traveling public to take the following actions with respect to traffic control devices in the County, at the following more particularly described locations:

1. Install the following traffic control devices while West Denton Road remains closed for bridge repair to Structure N-138:
  - a. A 40 M.P.H. sign on West Old Cheney Road just east of State Spur 55-A for eastbound traffic; and

- b. A 40 M.P.H. sign on West Old Cheney Road just west of SW 56<sup>th</sup> Street for westbound traffic.
2. Upon completion of bridge repair to Structure N-138 and the reopening of West Denton Road, remove the following traffic control devices that had been installed pursuant to this Resolution:
- a. The 40 M.P.H. sign on West Old Cheney Road just east of State Spur 55-A for eastbound traffic; and
  - b. The 40 M.P.H. sign on West Old Cheney Road just west of SW 56<sup>th</sup> Street for westbound traffic.

NOW, THEREFORE, BE IT RESOLVED, by the Board of County Commissioners of Lancaster County, Nebraska, that authorization is hereby given to the Lancaster County Engineer to install the traffic control device at the location designated herein.
