This Amendment is hereby entered into by and between McKesson Medical-Surgical Minnesota Supply, Inc., 8121 10th Avenue North, Golden Valley, MN 55427 (hereinafter "Contractor") and the City of Lincoln and Lancaster County (hereinafter "Owners"), for the purpose of amending the Contract dated November 5, 2015 executed under City Directorial Order No. 14060, and County Contract C-15-0586, dated November 10, 2015 for Annual Requirements - Exam Gloves, Bid No. 15-131, which is made a part of this amendment by this reference.

WHEREAS, the original term of the Contract is November 10, 2015 through November 9, 2016, with the option to renew for three (3) additional one (1) year terms upon written mutual consent by all parties; and

WHEREAS, the Contract was amended by City Directorial Order No. 15813, executed by the City of October 3, 2016, and by County Contract C-16-0604 executed by the County Board on October 11, 2016 to renew the contact for an additional one (1) year term from November 10, 2016 Through November 9, 2017;

WHEREAS, the parties wish to renew the Contract for an additional one (1) year term beginning November 10, 2017 through November 9, 2018; and

WHEREAS, the estimated expenditures for the City of Lincoln for the term of this renewal shall not exceed \$2,000.00 without approval by the City of Lincoln; and

WHEREAS, the estimated expenditures for Lancaster County Corrections for the term of this renewal shall not exceed \$8,000.00 without approval by the Lancaster County Board; and

NOW, THEREFORE, IN CONSIDERATION of the mutual covenants contained in the Contract under City Directorial Order No. 14060 and County Contract C-15-0586, all amendments thereto, and as stated herein, the parties agree as follows:

- 1) The parties wish to renew the Contract for an additional one (1) year term beginning November 10, 2017 through November 9, 2018.
- 2) The estimated expenditures for the City of Lincoln for the term of this renewal shall not exceed \$2,000.00 without approval by the City of Lincoln.
- 3) The estimated expenditures for Lancaster County for the term of this renewal shall not exceed \$8,000.00 without approval by the Lancaster County Board.
- 4) All other terms of the Contract, not in conflict with this Amendment, shall remain in force and effect.

The Parties do hereby agree to all the terms and conditions of this Amendment. This Amendment shall be binding upon the parties, their heirs, administrators, executors, legal and personal representatives, successors, and assigns.
