

**AMENDMENT TO CONTRACT

This Amendment is hereby entered into by and between Company Care, 5000 N. 26th Street, Suite 200, Lincoln, NE 68521 (hereinafter "Contractor") and City of Lincoln and Lancaster County, (hereinafter "Owners"), for the purpose of amending the Contract dated October 21, 2013 executed under City Executive Order No. 86566, and County Contract C-13-0549, dated November 5, 2013 for RFP - Employee Medical Exams, Bid No. 13-197, which is made a part of this amendment by this reference.

WHEREAS, the original term of the Contract is November 5, 2013 through November 4, 2014, with the option to renew for three (3) additional one (1) year terms upon written mutual consent by all parties; and

WHEREAS, the Contract was amended by City Executive Order No. 87608, executed by the City on October 20, 2014, and by County Contract C-14-0564 executed by the County Board on October 28, 2014, to renew the contract for an additional one (1) year term from November 5, 2014 through November 4, 2015;

WHEREAS, the Contract was amended by City Executive Order No. 88738, executed by the City on October 20, 2015, and by County Contract C-15-0548 executed by the County Board on October 13, 2015, to renew the contract for an additional one (1) year term from November 5, 2015 through November 4, 2016;

WHEREAS, the Contract was amended by City Executive Order No. 89984, executed by the City on October 25, 2016, and by County Contract C-16-0619 executed by the County Board on October 18, 2016, to renew the contract for an additional one (1) year term from November 5, 2016 through November 4, 2017;

WHEREAS, the parties hereby extend the Contract from November 4, 2017 through February 3, 2018; and

WHEREAS the expenditures for the City of Lincoln for the term of this extension shall not exceed \$10,000.00 without prior approval by the City of Lincoln; and

WHEREAS the expenditures for Lancaster County for the term of this extension shall not exceed \$4,500.00 without prior approval by the Lancaster County Board of Commissioners; and

NOW, THEREFORE, IN CONSIDERATION of the mutual covenants contained in the Contract, under City Executive Order No. 86566 and County Contract No. C-13-0549, and stated herein the parties agree as follows:

- 1) The parties hereby extend the Contract from November 4, 2017 through February 3, 2018.
- 2) The expenditures for the City of Lincoln for the term of this extension shall not exceed \$10,000.00 without prior approval by the City of Lincoln.
- 3) The expenditures for Lancaster County for the term of this extension shall not exceed \$4,500.00 without prior approval by the Lancaster County Board of Commissioners

- 4) All other terms of the Contract, not in conflict with this Amendment, shall remain in full force and effect.

The Parties do hereby agree to all the terms and conditions of this Amendment. This Amendment shall be binding upon the parties, their heirs, administrators, executors, legal and personal representatives, successors, and assigns.
