

**MINUTES
LANCASTER COUNTY BOARD OF COMMISSIONERS
COUNTY-CITY BUILDING, ROOM 112
TUESDAY, NOVEMBER 7, 2017
7:00 P.M.**

Advance public notice of the Board of Commissioners meeting was posted on the County-City Building bulletin board and the Lancaster County, Nebraska, web site and emailed to the media on November 3, 2017.

Commissioners present: Todd Wiltgen, Chair; Bill Avery, Vice-Chair; Roma Amundson, Jennifer Brinkman and Deb Schorr

Others present: Pam Dingman, County Engineer; Dan Nolte, County Clerk; Cori Beattie, Deputy County Clerk; and Kelly Lundgren, County Clerk's Office

The Chair called the meeting to order at 7:00 p.m., the pledge of allegiance was recited and the location of the Nebraska Open Meetings Act was announced.

1) PUBLIC HEARING:

A. One and Six-Year Road and Bridge Improvement Program for July 1, 2018 through June 30, 2023.

The Chair opened the public hearing.

Wiltgen explained that the Board will not be taking action at this time and further discussion will take place at an upcoming staff meeting.

Amundson entered the meeting at 7:04 p.m.

Pam Dingman, County Engineer, was administered the oath. She began the public hearing by introducing the staff from the County Engineer's Office.

Dingman presented an overview of the completed and proposed projects (Exhibit A). She discussed the current paving needs, bridge conditions, combo structures and culvert conditions. Dingman provided various maps of the roads and bridges in the County. These maps are also available on the County Engineer's website.

Don Biggerstaff, 1909 N 98th Street, was administered the oath and expressed concerns with Holdrege & Adams due to the increased traffic, dust and visibility. He said with the continued growth of Lincoln the traffic will increase and he would like 98th Street paving to become a priority. A number of people present stood showing their support.

Wiltgen encouraged members of the public that did not wish to speak or could not attend the public hearing to contact the Commissioners.

Solo Mwanja, 7620 Stevens Ridge Road, was administered the oath. He stated he would like to see the one mile of gravel on S 1st Street between Old Cheney Road and Pioneers Boulevard paved. Mwanja said the Lincoln City Church continues to grow but limits activities as the street is a concern for safety reasons. There were a number of church members in attendance to show their support.

Kent Heidtbrink, 1601 N 98th Street, was administered the oath. He said the 98th Street traffic continues to increase with the dust causing visibility issues. Heidtbrink questioned if watering the road could be an option.

Dianne Heidtbrink, 1601 N 98th Street, was administered the oath. She shared concerns as well with 98th Street traffic and felt that a new traffic count needs to be conducted.

Brett Erlandson, 1740 SW 33rd Street, was administered the oath and stated the City has planned a major road construction project that affects the neighborhood in 2021. He said there will be a quarter mile that is still within the County's jurisdiction and according to the 1 & 6 year program's proposed projects it will not be completed until after 2023. Erlandson said he would like that taken into consideration as there is increased traffic from 36th and 40th Streets.

Sandy Smith, 18303 N 162nd Street, was administered the oath. She expressed concern with the number of heavy trucks traveling on 162nd Street and feels the condition of the road is not safe.

Mark Antonson, 1521 SW 30th Street, was administered the oath. He appeared on behalf of the West A Neighborhood Association (SW 40th Street to Salt Creek Road and Van Dorn Street to West O Street). There were members from the neighborhood in attendance. Antonson requested that the County work with the City on the West A Street to Folsom Street project.

Michael Werner, 10220 East Oak Lane Circle, Waverly, was administered the oath. He stated he appreciates the County road maintenance. Werner supported the N 162nd Street project, but would like it extended one mile to Bluff Road. He noted Amberly Road is a truck route and perhaps the County could explore an alternate truck route around Waverly as three schools are located on Amberly Road.

Ken Hiatt, 5200 Boeckner Avenue, was administered the oath. He noted he is responsible for outside maintenance for Lincoln City Church and he appreciated the quick response from County Road Maintenance when called upon. Hiatt said he would like to see South 1st Street pavement on the future 1 & 6 year program.

Jim Brown, 8757 Bennet Road, Roca, was administered the oath and requested a quarter mile of rock on Bennet Road near 87th Street. Dingman said she would evaluate that section of road to see if it would meet the current standards for rock placement.

Jason Babcock, 13411 Alvo Road, was administered the oath. He was concerned with the delay on completing construction on 148th Street and the amount of traffic thru the 134th Street intersection. Dingman said construction projects were delayed in October due to the weather and advance work could not be done due to the instability of the structures.

Vinny Boston, 10900 N 176th Street, was administered the oath. He questioned the weight rating on bridge H-119. Dingman said she was unsure of the weight rating. Boston expressed concerns with

emergency vehicles crossing the bridge to reach his property. Dingman said there is communication with the city and villages when structures are closed.

Doug Hansen, 905 Larkspur Drive, Hickman, was administered the oath. As Mayor of Hickman, he is in support of paving 54th Street and 68th Street from Roca Road to Hickman. Hansen said Hickman conducted a traffic count released in March of 2016 showing 7300 vehicles per day going north on 68th Street from Hickman Road and 7100 vehicles going south. He felt that S 68th Street needs to be on the County's radar.

Tim Sullivan, Meadowview Subdivision, was administered the oath. He represented the Meadowview Subdivision Homeowners Association (HOA) and supported the overlay project in the one-year plan for the subdivision, the culvert replacement along W Pioneers Road at 98th Street and paving of the quarter mile of SW 36th Street to SW 40th Street. Sullivan encouraged the Commissioners to increase the overall budget for roads and bridges.

Denise Arnold, 2951 N 51st Street, was administered the oath and appeared in support of paving the section of S 1st Street in the area of Lincoln City Church.

DaNay Kalkowski, 1128 Lincoln Mall, Suite 105, was administered the oath. She appeared on behalf of Firethorn property owners in support of the continued pavement of 98th Street.

Silas Clark, Hickman City Administrator, was administered the oath. He requested that the Commissioners consider increasing the County Engineer's budget. Wiltgen said the budget was increased \$4,000,000 over the last three years and the County is developing a task force to find ways to fund major infrastructure projects.

Dave Watts, 1701 N 112th Street, was administered the oath. He stated he would like to see 112th Street on the 1 & 6 year program. Watts said he hired Alfred Benesch and Company to perform a traffic count on 112th Street between Holdrege and Adams Streets (Exhibit B). He noted a new animal clinic will increase traffic beyond current counts.

Marlan Johnson, 4105 N 202nd Street, Eagle, was administered the oath. He commended the County Engineer's Office in working to give him access to his farmland, which is located between Bridges H-119 and H-120. As a member of the Eagle Alvo Fire District, he is concerned with the amount of time rural roads are closed for simple culverts. Dingman stated due to Federal Highway Administration regulations a bridge must be closed if it poses a clear and present danger to the public. In regard to culverts she noted Nebraska Emergency Management Agency funding and property line issues can delay construction.

Seth Rye (no address was provided) was administered the oath. He said he appreciated the work of the road maintenance crews and would like to see improvements to S 68th Street due to the amount of traffic.

Schorr read into the record the names of individuals who contacted her in writing to express their concerns with S 68th Street (Exhibit C). She said at Thursday's staff meeting she will be discussing with her fellow Commissioners a plan to set aside County emergency funds for a traffic study of the area. Dingman stated her goal is always to work toward zero road fatalities. She requested the study include Roca Road to Firth.

Lynn Lenhoff, 1900 N 98th Street, was administered the oath. He requested placement of a 45 MPH speed limit sign on 98th Street between Holdrege and Adams Streets. Dingman said a speed study can be done.

Dustin Sutter, 431 Driftwood Drive, was administered the oath. He appeared in support of paving S 1st Street between Old Cheney Road and Pioneers Boulevard.

Schorr entered two letters into the record from Matt Steinhausen regarding a quarter mile of Rokeby Road between S 14th Street and Highway 77 (Exhibit D); Craig Larmon regarding Bridge N-19 (Exhibit E); and Wayne, David and Travis Eggert, Lanyce Keel and Brian and Elaine Eltze regarding the closure of Bridge W-122 on Panama Road (Exhibit F).


Wiltgen announced that tonight's meeting would be available to view on YouTube.

Dignman said she received a letter from the Lower Platte South Natural Resources District (NRD) regarding SW 2nd Street realignment (Exhibit G). The NRD has agreed to pay the cost but requested it be placed on the 1 & 6 year program.

NOTE: The County Clerk's Office also received an email from Chad TerMaat regarding safety issues on Saltillo Road (Exhibit H).

2) ADJOURNMENT

MOTION: Avery moved and Amundson seconded to adjourn the public hearing at 9:18 p.m. Avery, Brinkman, Schorr, Amundson and Wiltgen voted yes. Motion carried 5-0.

drifts, which discourage winter motoring. With this comprehensive snow removal organization, the county is securing 100 per cent service from its system of concrete roads, and payers, both in city and country, enthusiastic in their approval of work in this direction.

Lancaster County, Nebraska, Inaugurates Snow Removal

UNDER the direction of the county commissioners and Arthur Edgren, County Engineer, Lancaster County, Neb., has this winter removed snow from the principal highways leading into Lincoln. In all, about 250 miles of roads have been kept free of snow, which has ranged from 12 to 20 inches deep. Work has been done with the regular county forces, using three Nash Quad trucks, which were part of the federal allotment of government trucks to various highway organizations. Each truck has pulled a highway maintainer and has been manned by a driver and operator. An average speed of about 5 1/2 miles per hour was made for the entire cleaning period. One trip in each direction resulted in cleaning a strip 2 1/2 feet wide. It has been found that the cost of this maintenance with motor trucks averages about 70 cents per mile per cleaning.

On November 30 and December 1 and 2, 1919, snow was general over the entire northwestern part of Nebraska and ranged from 4 to 8 inches deep. However, during these storms there was a high wind, which in many places caused large drifts. Train service was practically paralyzed, and such trains as did run were from 2 to 12 hours late. Highway travel on all but the hard surfaced roads was practically out of question, but because of the organized effort in snow removal in Lancaster County, entrances to Lincoln have so far been kept open.

Plans for future work of this kind in Lancaster County contemplate that the county road construction crews will remove all light snows with highway

Permanent Highway Markers of Concrete

WITH the increased number of automobiles and of motorists who are touring far afield, the demand for clearly and permanently marked highways has steadily grown.

The Engineering Department of Lancaster County, Nebraska, realized the need of permanent warning signs and markers about five or six years ago. After considerable experimenting, a type of sign which is both neat and durable was decided upon.

Reinforced concrete was chosen as the material. Various mixes were tried and a 1:3 mix of cement and Platte River gravel was finally adopted. Wooden forms are used for molding the signs and the depressed lettering is obtained by nailing iron form-letters to the inside of the wooden forms. To increase the effectiveness of the signs, they are painted white and the inlaid letters black. Some of the signs have been in service four years without needing repainting. The cost

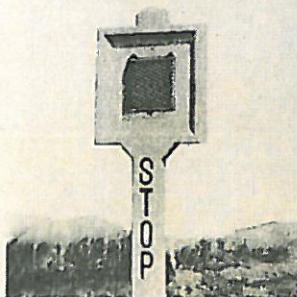


Typical concrete direction sign in Lancaster County, Nebraska.

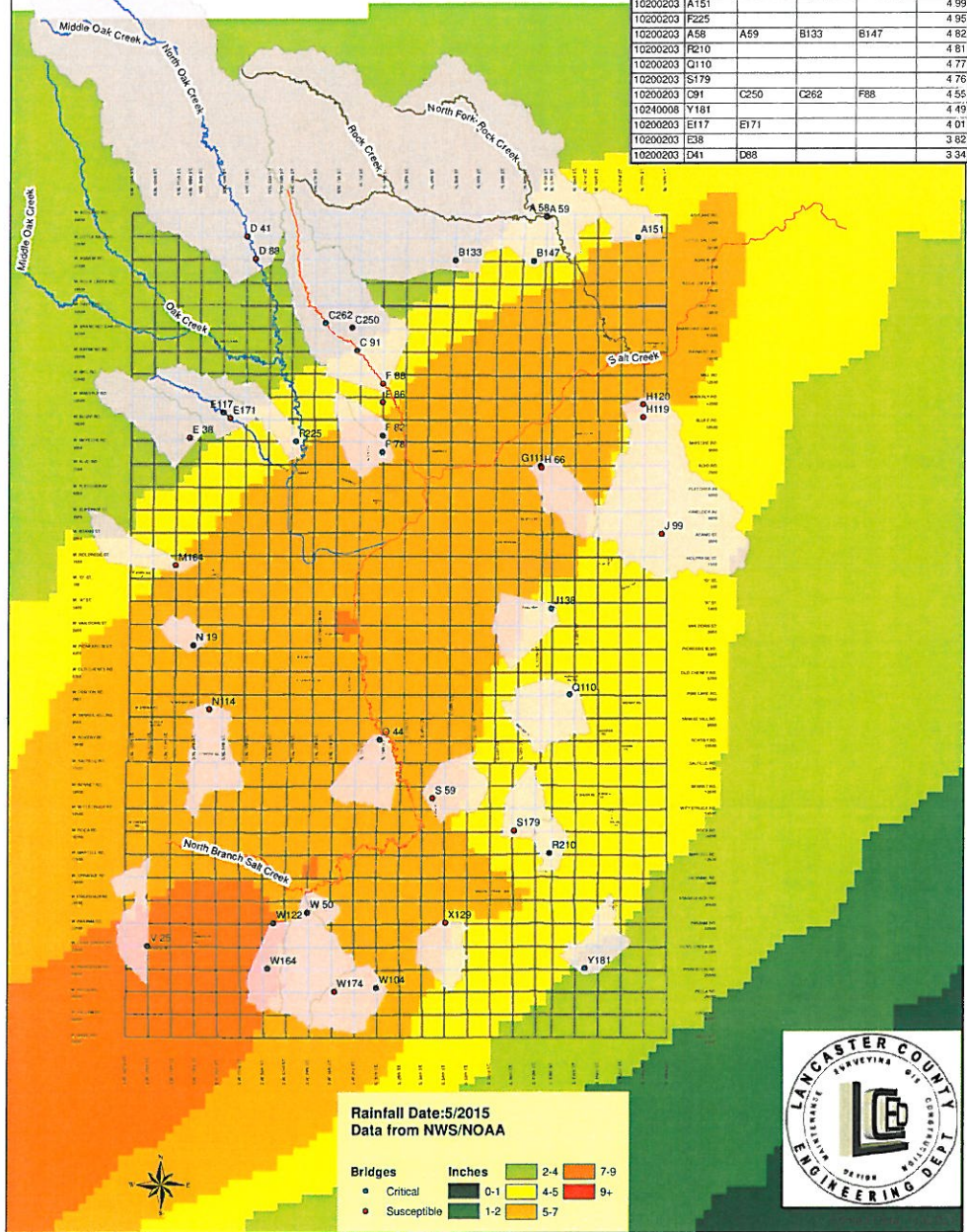
of these signs is small as they are a winter season product, manufactured during the four winter months by two concrete foremen whom the county keeps permanently employed. They are made at the county engineering equipment yard and cost about \$20.00 each in place.

The placing of signs is done during the summer. The posts are set in a concrete base 3 feet square. In addition to supporting the sign, the base serves as a Bench Mark for highway levels.

The County is also manufacturing con-

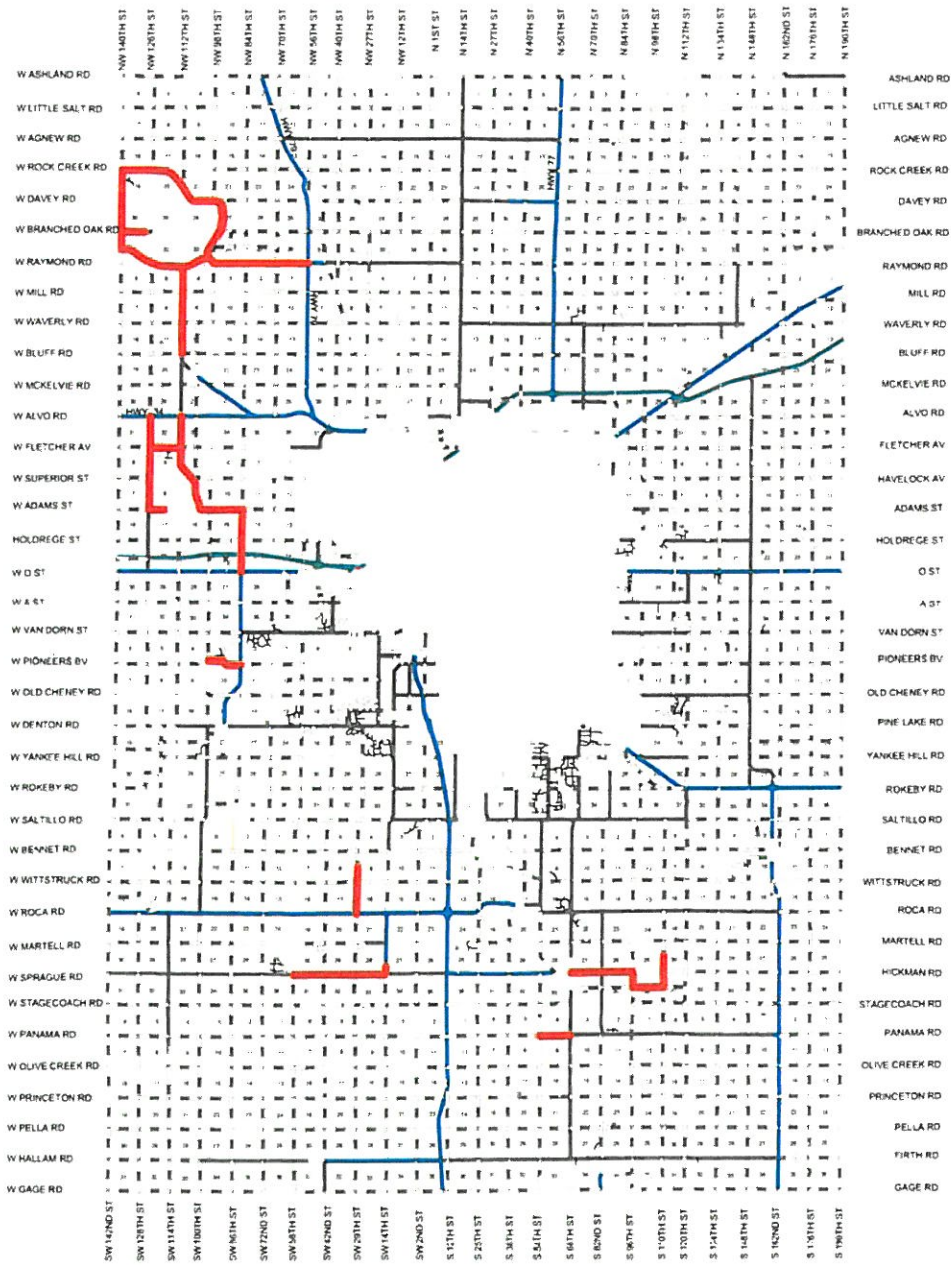

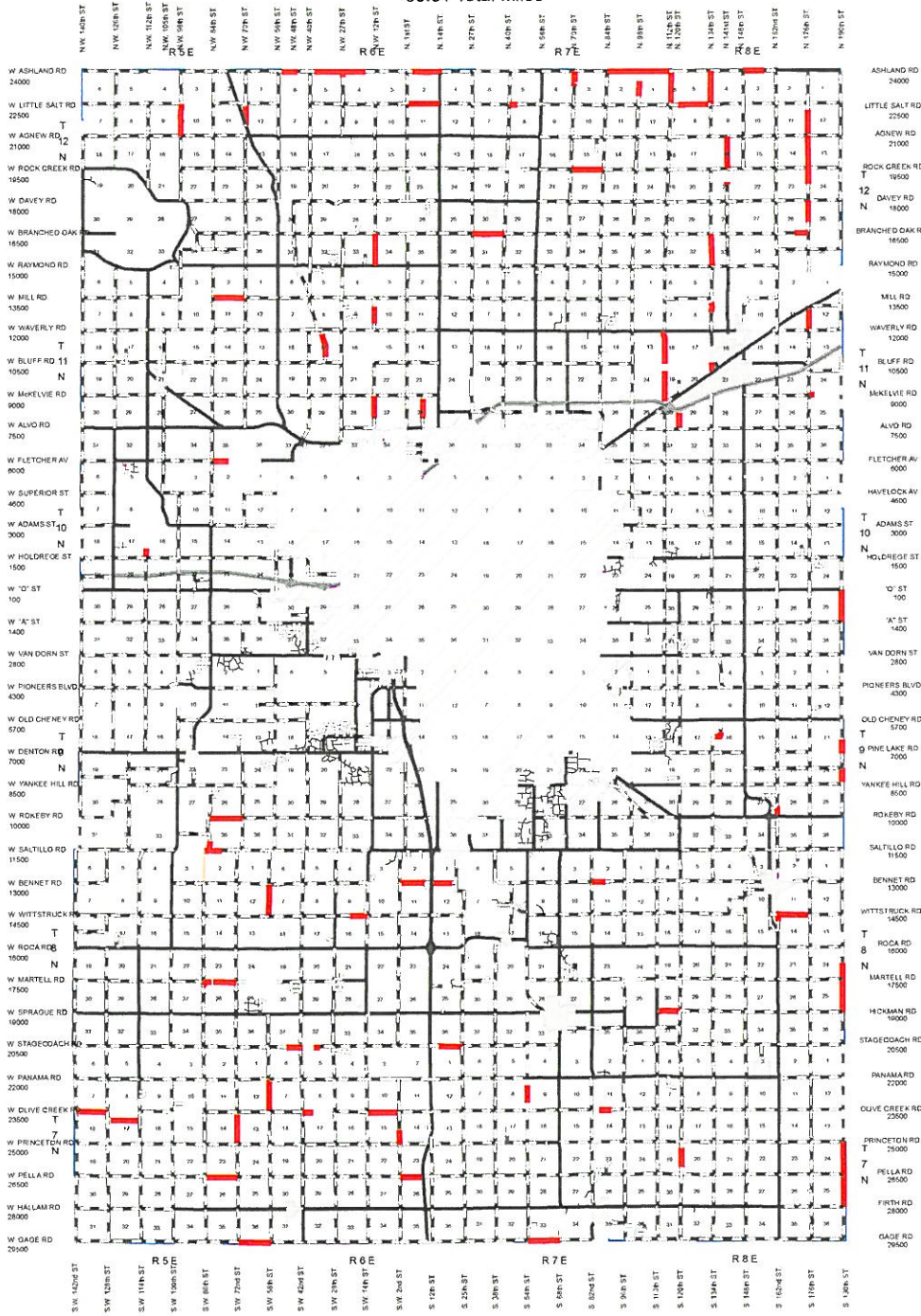

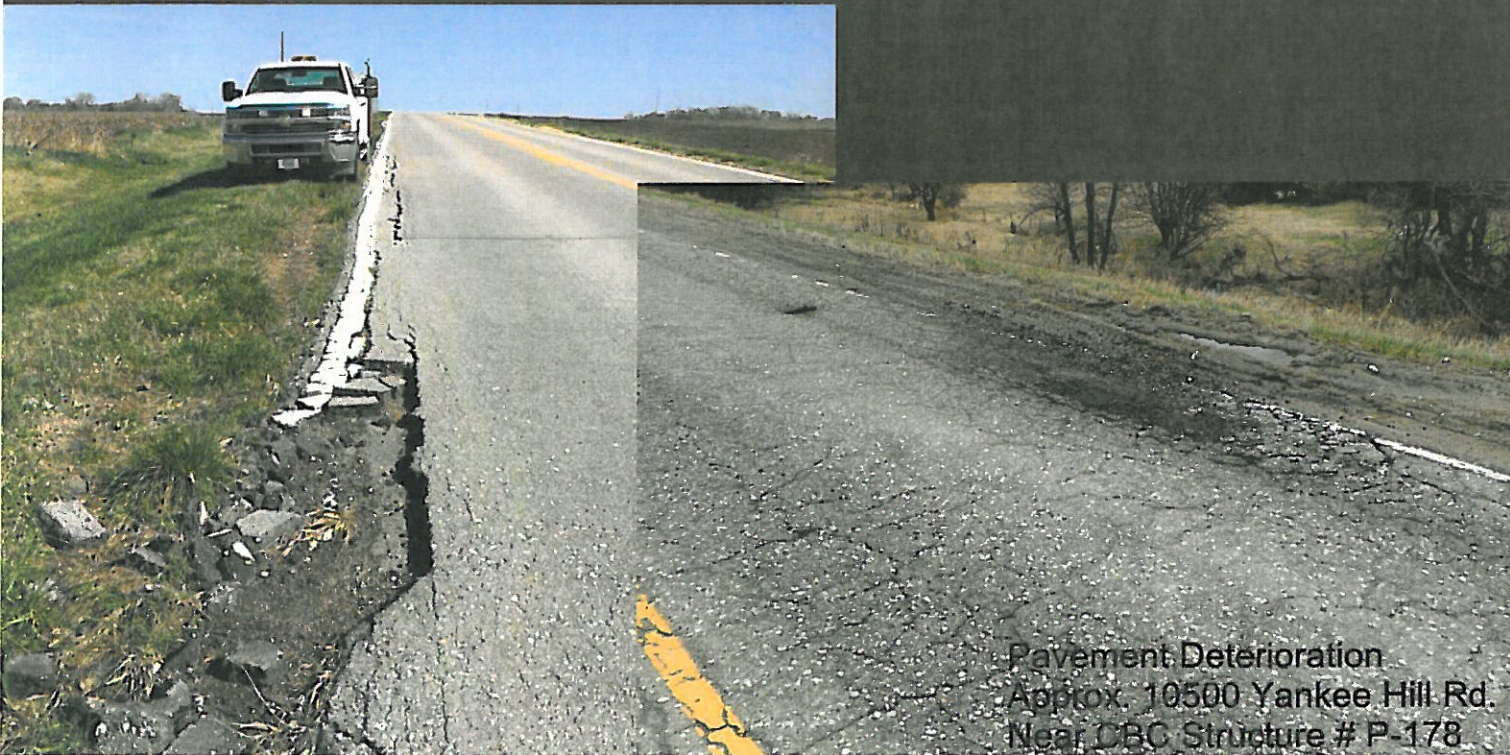

Dirt Roads 55.31 Total Miles



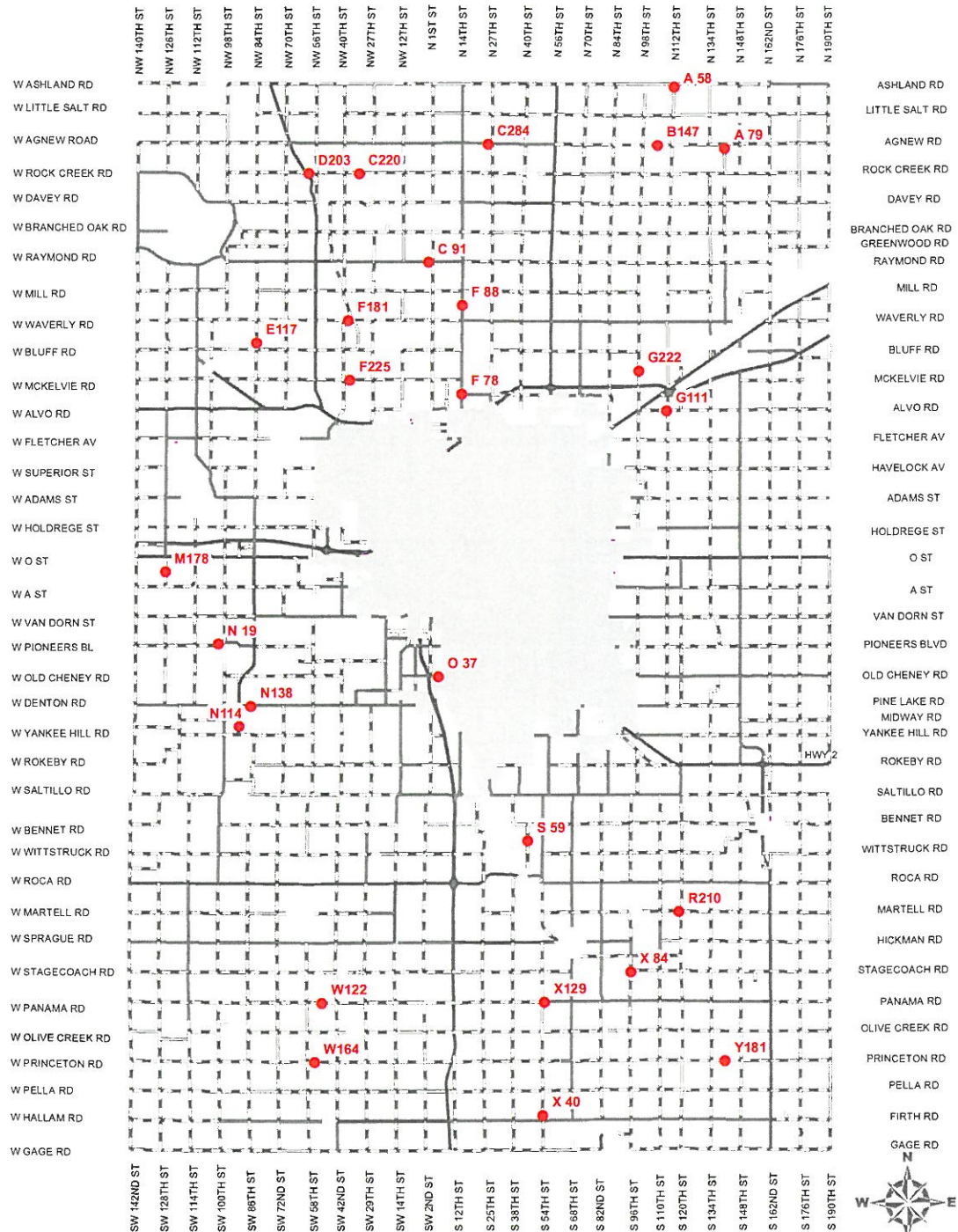

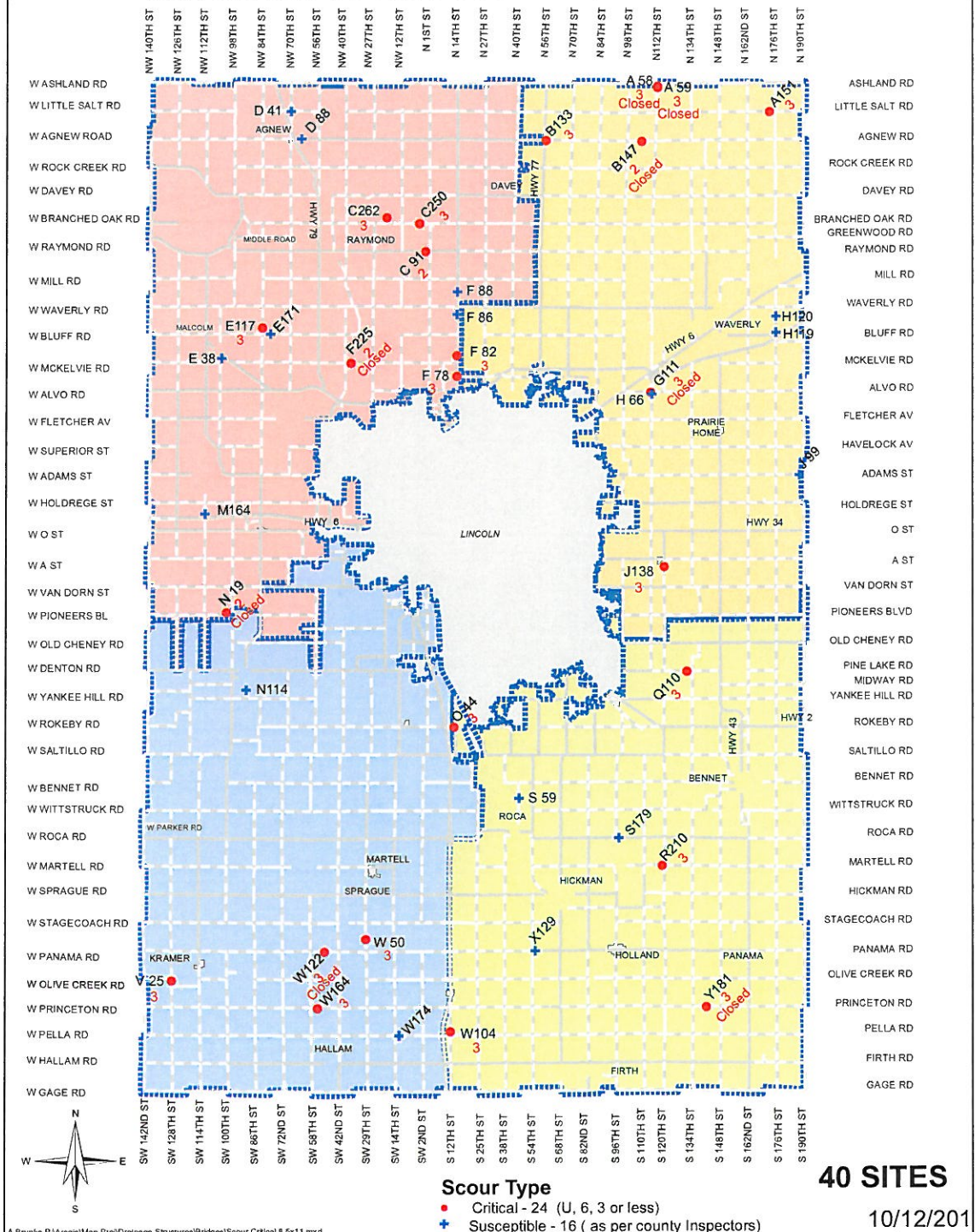

STRUCTURALLY DEFICIENT BRIDGES

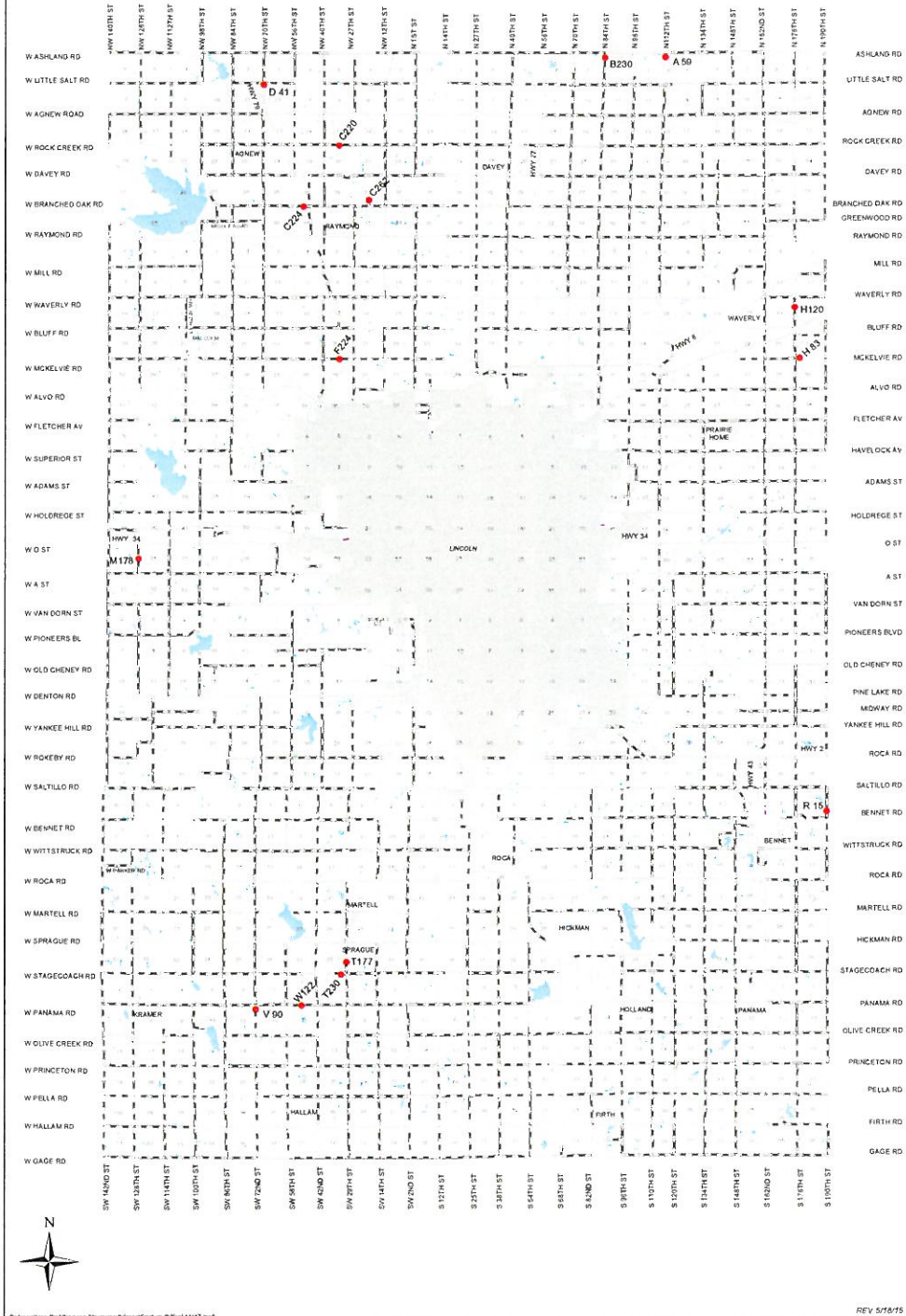


LANCASTER COUNTY SCOUR CRITICAL BRIDGES

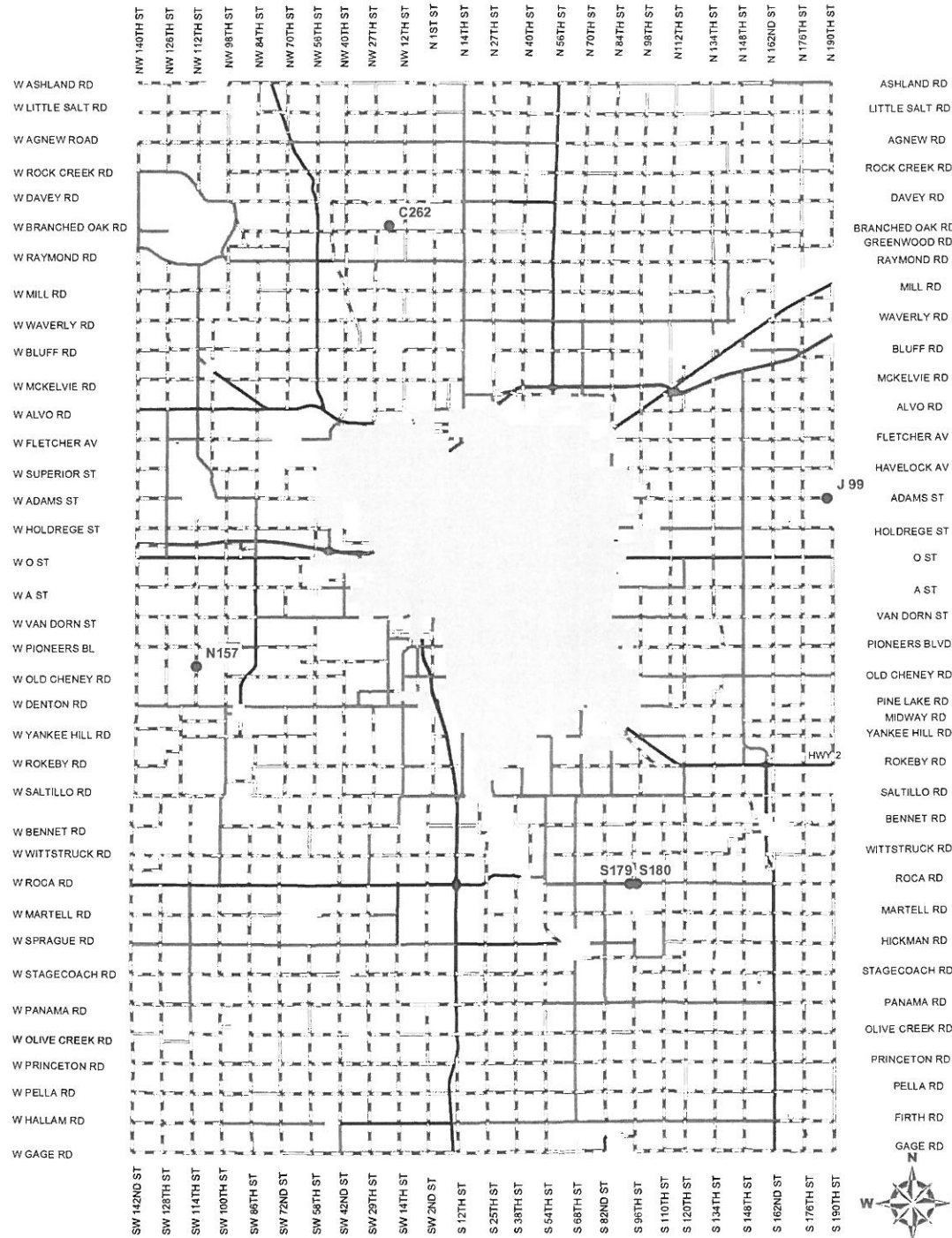

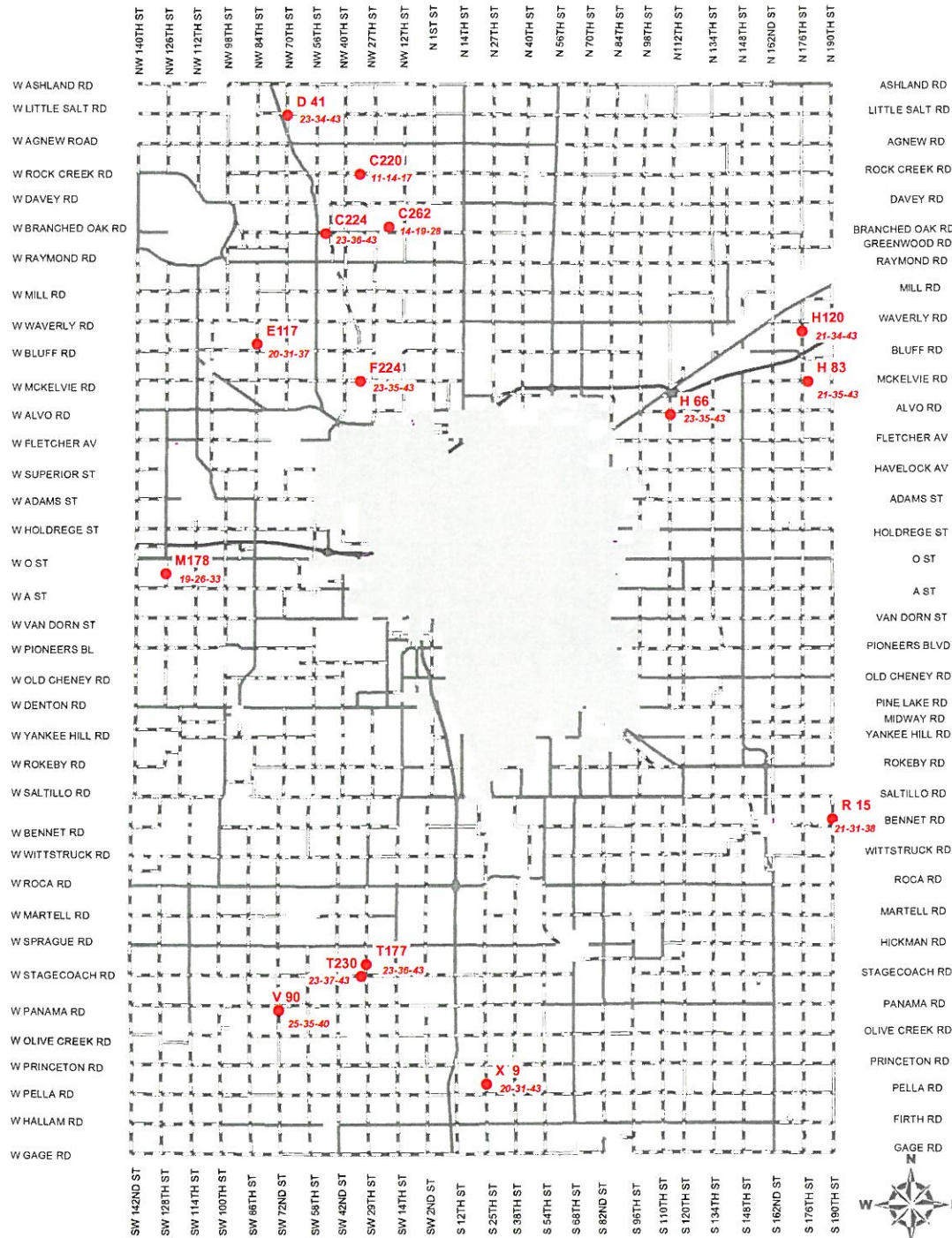
LANCASTER COUNTY FRACTURE CRITICAL BRIDGES



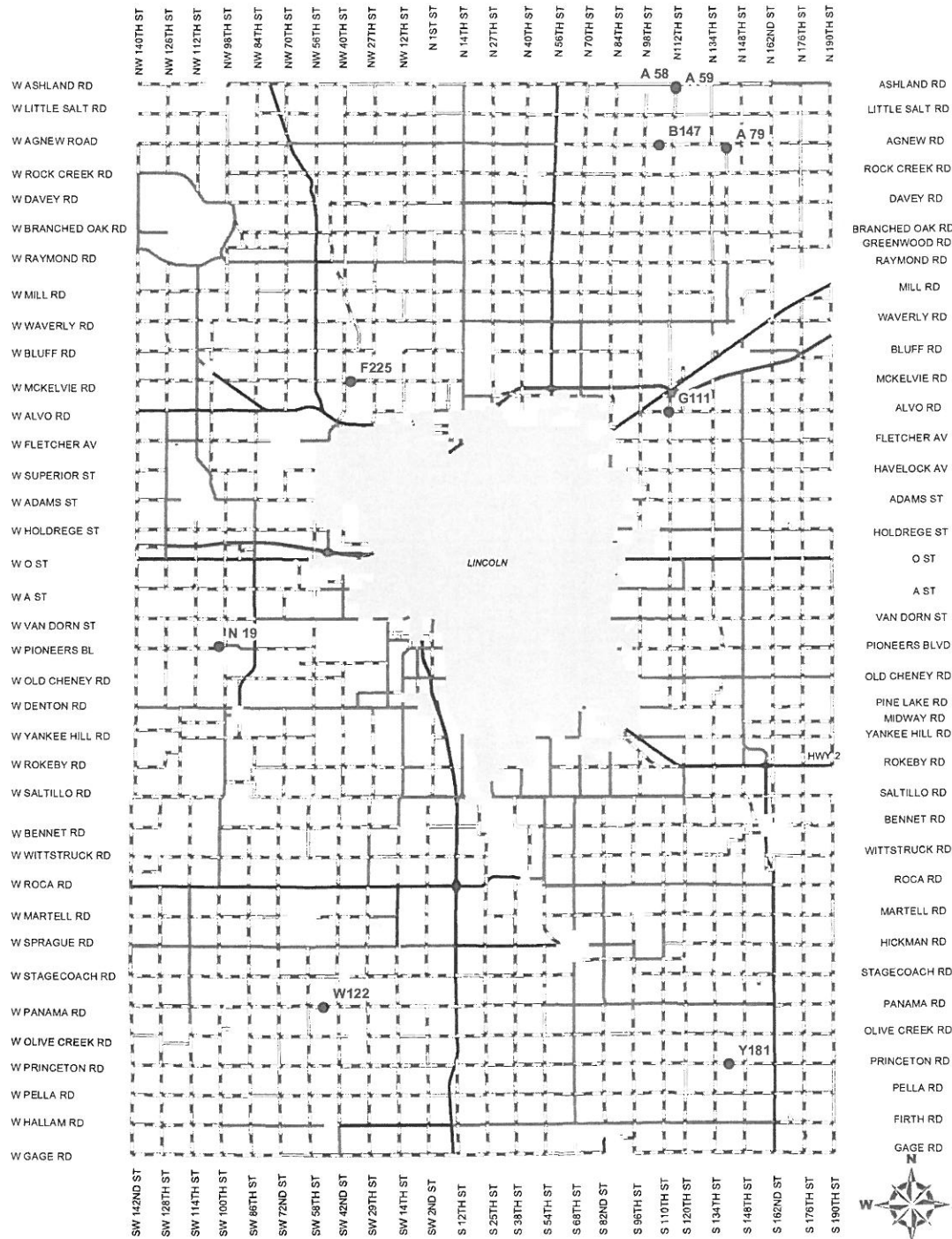

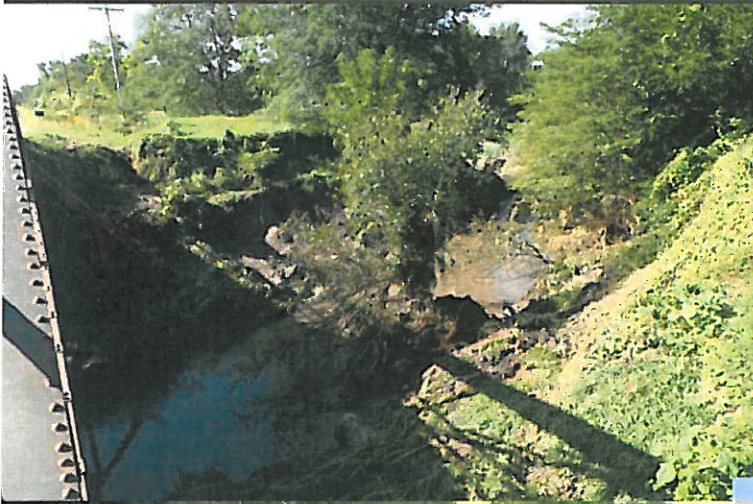

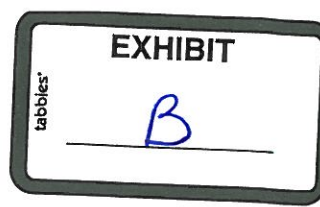

RE: Traffic Counts at N. 112th & Holdrege Streets

Dear Mr. Watts:

Benesch completed traffic counts along both Holdrege Street and N. 112th Street in March 2017. We performed daily traffic counts along Holdrege Street just east of N. 112th Street and along N. 112th Street just north of Holdrege Street. We did advise Lancaster County that we would be taking these counts prior to placing traffic counting equipment on the roadways. Based on the traffic counts completed during the week, Holdrege Street had a daily traffic count of 3,440 vehicles per day (vpd).

The N. 112th Street traffic count resulted in a daily traffic volume of 440 vpd. Beyond the current traffic on N. 112th Street, we anticipate that traffic volume will grow due to planned future development. One piece of that development includes the Bethany Animal Clinic. Bethany Animal Clinic is planning to relocate to 112th Street north of Holdrege Street. Based on the Institute of Traffic Engineers (ITE) Trip Generation Manual, a 5,000 square-foot animal clinic would be expected to generate about 220 vehicle trips per day.

Currently N. 112th Street is a gravel road. With traffic volumes increasing due to the animal clinic and traffic expected to increase with further subdivision development, it would be wise to discuss with the County the time frame for which Lancaster County plans to pave N. 112th Street.

Daily Volume Benesch Counted on 112th is 441 NB and SB

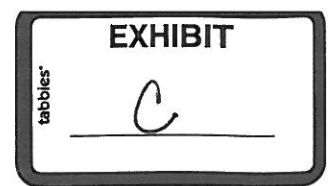
Total Daily Volume is 882 VPD

In the wake of the terrible events on Oct. 25, 2017 that led to the death of 13-year-old Ryan Post, I'm writing to voice my concern over the safety of S. 68th Street from Hickman to Firth Rd. S. 68th Street is the main thoroughfare used daily by thousands of Norris students, parents, families, and staff, including teen drivers.

The road is narrow and without shoulders. Additionally, there are some steep ditches, and a couple of nearly blind intersections, which likely contributed to the crash that took Ryan's life.

I believe it's imperative for the safety of the Norris community and our children to widen, and add improved shoulders to S. 68th Street from Hickman to Firth Rd.

Good morning Deb,

I will not be able to attend the meeting tonight regarding concerns about South 68th road. I would like to take a minute to voice my concerns. I have a 15 year old daughter that drives that road to school every day. She starts on 77, then to the very narrow Firth road, then 68th just like all of our Norris Students from Cortland. I have been on the Cortland fire department for 8 years and have worked an accident involving our oldest son. The steep embankment caused him to roll his vehicle into a ditch leaving him upside down in the ditch, stuck in his vehicle. Fortunately he was ok and no other oncoming traffic was coming when he over-corrected and went across Firth road into the ditch. It could have been much worse. That was several years ago and I remember thinking that I could not believe these roads don't kill more people. Well now they are. The Norris school district has grown considerably. The Norris school district has goals to grow even more. Yet the roads driven to get to the school have remained the same since the 70's. These roads clearly cannot handle all of this traffic. Our young drivers are distracted and inexperienced. Now students are dying. PLEASE do what you can to pull whoevers head out of their ass to start correcting this.

We have three voters in our household. All three voted "no" to Norris getting bigger. Only because we feel our students should be able to get to and from all Norris functions safely. Not just in front of the school or schools but the entire route there. From Hickman to Norris, From Panama to Norris, From Cortland to Norris, and even from Hallam to Norris.

I know many of the responders from Firth and Hickman. Going to car accidents on that road as often as they do is extremely hard on them. They know these kids they are working on, they shouldn't have to see another one lying in the street. They are too good of people for that. We are too good of people for that, we deserve safe roads.

Commissioners,

On October 26th, a string of accidents caused a young girl to die after leaving Norris School on a sunny afternoon. This is not the first time it has happened, and if something isn't done about South 68th St. from Panama Road to Firth Road, it will not be the last. Norris school is growing by leaps and bounds-- along with the communities surrounding it. Years ago, 68th St might have been able to handle the traffic, but it is no longer able to do that. In our rural district, it is legal for 14 year olds to get their School Permit and drive these roads at the busiest times of the day. From 7:30 to 8:30am, and again from 3:30-4:30pm, traffic is comprised mostly of inexperienced drivers, at 55-60 mph, on a narrow road with deep ditches on either side, and without shoulders. In bad weather, such as fog and ice, it is doubly dangerous. 68th St. is also a main thoroughway for buses, tractors and farm vehicles, as well as having many drives and opportunities for kids to turn onto gravel roads just to get home. Not to mention the *animals*, such as deer, coyotes, opossums, skunks, raccoons, rabbits, squirrels, etc that are crossing 68th St all the time-- inexperienced drivers are more likely to brake hard or swerve to miss and they have NOWHERE to go. How many more children have to die before the road is widened and a center turn lane is put in?

Ryan Post may have been another "Nebraska Road Death" (as is advertised on the electronic signs) to most, but to our Norris family, she was a *child*. A child with promise and dreams. A child that shouldn't have had to die. Do you have any idea the long-lasting effects that this accident will have on the 2 *other* children-- her big sister, who was driving, and the 17 year old Senior who hit them? I cannot begin to imagine the pain every time they are forced back behind the wheel to drive the same, dangerous stretch of road just to attend school. This accident has affected so many more people in a permanent, serious, traumatic way than just Ryan's family.

As a constituent, a resident, a voter and a MOM, I am begging you, please **PLEASE widen 68th St and put in a center turn lane from Firth Road to Panama Road**. Give our kids someplace to go should an unexpected event occur. **Make the stretch in front of the schools a School Zone** and have extra Sheriffs available for the busiest times of day to patrol it & slow traffic down. It is absolutely *imperative* that while the communities and the Norris schools grow, that the roads are SAFE for our kids.

I just read about a meeting this evening concerning Lancaster County roads, which I will be unable to attend.

Our children attended school at Norris in the 1980s and early 1990s; now our grandchildren attend there. That road was dangerous when our children went to school there...and their graduating classes were under 100 students! Imagine how much more dangerous it is now with the number of students doubled-plus! They are young, inexperienced drivers (some as young as 14 and 15 on school permits). Add in cell phones, and you have a disastrous situation.

Several years ago, shoulders were added to 68th north of Hickman, but the project was halted at Roca Road, which made no sense at the time, and still makes no sense. We urge you to consider adding shoulders all the way to Firth Road. This should be a priority! The lives of our children are worth the cost of improving 68th!

Saltillo Road remains extremely dangerous as well - semi-trucks, cement trucks and rock trucks are using it as a shortcut between Hwy. 77 and Hwy. 2. The volume of traffic has increased not only because of that but also because of the high density of acreage homes.

While my husband and I recently moved to Otoe County, we still own and pay taxes on a commercial building in Lincoln and a house in Hickman.

If possible, please share my concerns at your meeting this evening. Thank you for your time and your service.

Subject: My daughter Ryan Post

My daughter Ryan was 13 years old. She was a dedicated cheerleader, sister, niece, granddaughter, cousin and friend. Ryan took on the world with wide eyes and a big smile. There was nothing that could stand in her way or deter her from something new and challenging. She was a leader among her peers and welcomed any new face with open arms, becoming a friend to anyone she encountered. Ryan excelled at cheering and was always there for her teammates. More than that she was an amazing girl who loved life. She was bubbly, fun and smart with a bright future. Her laugh was so contagious and those dimples would melt your heart! All of that ended on October 26, 2017 as she was tragically killed in an auto accident on 68th road south of Hickman on her way home from school. On that day there were multiple accidents which led to the series of unfortunate events. 68th road that stretches from Saltillo is made up of multiple hills. The maximum speed limit is 55mph and is a path way for thousands drivers from Firth, Panama, Holland, Hickman, Lincoln and Roca to go to and from work and to take their children to school. At the intersection of 68th and Roca road traveling south there are NO shoulders. This includes paved and dirt. As soon as your lane ends to the right it is a straight drop off in to a ditch and sometimes even deeper and straight in to wooded areas or fields. On October 25, 2017 a car accident happened a few miles south of Hickman on 68th. There is no shoulder in this area and the accident could not be moved off the road. This caused hundreds of cars to slow down and even stop to wait their turn to drive in the opposite lane around the accident causing a very long back up of cars. My daughter Riley Post (16) came up over a steep hill and was immediately met with a line of cars. She slammed on her brakes skidding in to a white Toyota. Shortly after she hit the vehicle Emily Harms came up over the hill and hit Riley's car. Because the cars were up over a hill Emily was unable to slow down to not hit the car at a high rate of speed. Ryan was crushed in the back seat. She received fractured right eye socket, fractured right jaw, brain hemorrhaging, a broken left femur, collapsed lungs, she went in to cardiac arrest and had a crushed spinal cord which stopped her from getting fluid to her brain which ultimately led to her death. There are many factors I blame for the accident. One is the inexperienced driving of both my daughter Riley and Emily. Teenage drivers lack the quick response to issues that adults are programmed for. They look at whats directly in front of them instead of looking down the road and to the sides to anticipate any issues that might arise such as slowed traffic or deer. With the majority of the drivers during the times school starts and gets out this is already creating such a volatile situation. Paired with other factors of young driving such as speeding, texting, and messing with radio it was just a pressure cooker ready to explode. But putting all this on a road with no shoulders is a death trap! Where are the cars supposed to go as not to cause accidents? Down a 20 foot drop? In to oncoming traffic? Just let go of the wheel and pray to Jesus you survive? This isn't just with 68th road. This summer on Hickman road Riley was driving home from her dad's house in Beatrice. She was heading East in to Hickman when a driver was texting and driving was not paying attention and crossed in to Riley's lane. She was able to get the car in to the ditch to not get hit but could not stable the car enough to get back on the road and spun it 20 yards in to a cornfield. The person did not even look back or get out to make sure Riley was ok and not injured. I raised my children to not

text and drive and to always wear their seat belts. Go the speed limit and take their time getting places. All my parenting did me no good when it came to all the other drivers on the road and all the other conditions. Hickman road is 60 mph and is a lot deeper on both sides but does not get as much traffic as 68th. There are so many accidents on all the roads in Lancaster County. This area is busting at the seams with new residents and no one is improving the area to accommodate. With new technology there are more and more hazards for drivers. Speed limits need to be dropped, street lights and turning lanes need to be put in at busy intersections, and shoulders need to be put on all major roads. I do not want one more family getting the news that their child did not make it because of something that could have been controlled or should have never have happened in the first place. Please fix the roads are children travel on daily to make them more safe. NOT ONE MORE CHILD OR PERSON SHOULD DIE IF WE HAVE THE MEANS TO STOP IT!!!

Dear Deb,

I don't normally start an email to anyone so casually, but I need to express this as one person, one human, one woman, one mother to another. You see we moved to the Hickman area back in 2008, from another county. While searching through Lancaster county and Lincoln itself, we had long decided when we moved we wanted to remain in a smaller community, but needed to be closer to Lincoln. Driving 110 miles a day to drive to work, gets exhausting. With that said, when we landed in the Hickman area we were very pleased for many reasons. We always knew this would grow, and we long knew that there would be pains along the way. What I hadn't banked on, is the life and death situation that these roads cause each.and.every.time. you're on them. There will be more deaths. There will be more heartache. There will be more phone calls.

This rather insignificant road, especially compared to say I-80, Hwy 77, and Hwy 2 makes this some tertiary road in the hierarchy. But the amount of traffic here, rivals anything in south Lincoln, Hwy 2 and 77 during rush hour.

The ditches aren't an option to take, head on traffic only slightly worse, and the gamble is always high. Even if we can't come up with adequate money to actually work on correctly fixing the problems, at least slow the entire thing down to 40-45 mph. These few miles of road here are God awful. It only adds to the difficulties because of slower farm traffic, a great many inexperienced drivers, and to many people in general. 1000's more than were ever imagined. I drive this road between 2-6 times a day. I've started to take alternate routes. They aren't particularly good, but it is an option. (sort of) Drive down to see the flood of kids leave the campus, it looks nothing short of any Lincoln High School. But if you want to park in front of the school you must arrive between 2:45 and 3:00 at the very latest. There will be no room after that time.

I'll show you my corner. Because it's so horrific, I have to drive an extra mile south, to drive an extra mile west, to drive an extra mile north to get my kids to school. I'll show you in quick reference of exactly what the day Ryan died looked like. The orange spray paint is still all there, the skid marks are all still there. How upon that fateful day, there was no way for the last girl in the truck to avoid hitting the other car.

I know all these kids. I know how hard it is for the last girl right now, a senior, a cautious gal, not someone who messes around behind the wheel. How she, her brother, and parents are all trying to deal with the aftermath of this mess. She's a gal that has the most beautiful smile that makes everyone feel accepted when they're around her. It wasn't her fault. But there was no way to see, no way to stop, and no where to go. If I'd have been on that stretch of road right at that moment, I'd have been the one to hit Ryan's car. Any of us could have so easily have been the one.

Until you see this road with the mass of traffic, no amount of statistics, no studies, no diagrams do this justice. I live 1.5 miles east of the school. (I even know Roma lol) I truly ask you to see this. To bring whoever you need to bring. I can't make it to your meeting tonight. I have an obligation which was set months ago, and I'm in charge of it, so I have to be

there. (actually most of these kids that were in these wrecks, I'll see tonight at the function) But I will be at the next meeting, and I will continue to keep very sharp tabs on this. If nothing else comes of this (for the immediate needs) slow these roads down. 68th, and Saltillo as well. Have the patrols give warnings first to get people thinking, and then rather honestly ticket as needed. But without some very serious help, this won't be the last death. I could only hope we might make it another year. But I won't give it marks much higher than that. It isn't a possibility, it's a probability. We will lose more. Please help.

My name is David Dorn I am a assistant chief with Firth Rural Fire District. I have been on the this department going on ten years now. Over this time I myself have responded to 7 auto accidents on 68th street between Firth Rd and were our district ends at Olive Creek Rd. Some have been bad and some were not. All of these calls happen before school, after school and after a school function at Norris. Just in the last 3 months I have gone to 4 auto accidents. All keep getting worse, the last ended in a death of a 14 year old girl sitting in the back seat (usually the safest place to be). This is just in our district I know Hickman has responded to many auto accidents in there district also. When Norris is in session its current enrolment is 2,378 all grades. Now between young drivers, parents and busses this is a extremely mass amount of traffic at one time. I hope you can imagine the chances of a accident happing if just one of those drivers makes one mistake. From Firth Rd to Roca Rd there is not a shoulder to pull of to like Roca Rd going north. Also most of the road side has very steep ditches. All of the auto accidents were because the drivers had no were to go when everything stops at once. Just the hills of the terrain make it difficult to stop if you just pop over a hill and some one is stopped. I know its hard with funding and not raising taxes to justify which roads need the most care. I feel like this stretch of road is starting to need some serious help. Shoulders would be great but that's probably the most expensive. Maybe stop lights in certain areas might help. I don't know enough to give you the answer but hopefully the county or state can seriously take a hard look into what to do to make that stretch of road safer. As a first responder its in my nature to care for others and I hope I in some can affect the decision on what can happen with 68th street.

While you are doing so remind yourself that 75% of those cars you come upon probably have 13-16 year old drivers in them and the rest have parents with little children and large busses full of numerous other students. Then look at the population growth of Hickman in the last 10 years and our history as the fastest growing town in Nebraska.

This road is not designed wrong nor do I blame anyone for the many accidents that have occurred on this road. The road in fact is doing what it was designed for many years ago when Norris was a smaller school. We now have 2400 students parents teachers and workers going to that location every school day..

The road is unsafe for many reasons:

- 1) young inexperienced drivers
- 2) drivers on phones not paying attention (as you drive this look at how many are looking down while you pass)
- 3) no shoulders with large drop offs
- 4) large hills that reduce visibility
- 5) large deer population near the road that run across all hours of the day

Thanks Deb for the opportunity to provide input.

The 1/3 mile of Rokeby Road between South 14th and Hwy 77 is dangerous. The road is heavily traveled, it's rough, often so dusty that one can't see more than 100', and turning on / off South 14th Street at Rokeby can be harrowing because of the high speeds, heavy traffic, lack of turn lanes, dust, and huge holes where pavement meets the unpaved road. This road is also subject to flooding because of its elevation and drainage problems. I understand this road will probably close in the future through the course of building the South Lincoln Bypass, however traffic on Rokeby Road has and will continue to increase with construction projects taking place at South 14th and Old Cheney, which will lead to an increase in accidents, some of which will be serious - and preventable.

Lancaster County should work in tandem with the Nebraska Department of Roads to improve safety and reduce congestion at Rokeby Road between Hwy 77 and South 14th Street. This should've been done years ago in anticipation of the increased traffic that's inevitable while south Lincoln roadways are being modified, but as the Nebraska Department of Roads informed me after I shared the same concerns with them, they're not required to consider the alternative routes people take to avoid detours in their construction planning, in essence ignoring the hazards their projects create on county and municipal roads that aren't specified detour routes.

1. The turn lanes off Hwy 77 onto Rokeby Road are short, and when the turn lane gets filled there is stand-still traffic on the passing lane of Hwy 77 that's traveling at 65 mph. The southbound left turn lane onto Rokeby Road needs to be extended.
2. Rokeby Road should be raised between Hwy 77 and South 14th to prevent the flooding problems.
3. Modification to existing bridges or culverts is required. The existing bridge at Rokeby Road near 14th Street is dangerous (siderail is broken now) and there are not sufficient culverts under Rokeby Road to alleviate the problems with water crossing the road even after insignificant rains.
4. Rokeby Road should be paved if possible to eliminate dust problems and reduce the navigation hazards such as washboards that are prevalent along the entire stretch of the roadway and remove the large potholes that exist where Rokeby Road adjoins S 14th Street.

Also, please consider creating a turn lane at eastbound Saltillo Road where it connects with South 14th Street, and examine what options exist with an alternative entrance into the gas station / truck stop if possible at this intersection. The congestion created by the convergence of roads at Saltillo, South 14th Street and Hwy 77 is unsafe, and the lack of turn lanes at both the entrance to the truck stop and where 14th intersects with Saltillo create traffic backups that are dangerous because of the volume of traffic and the speeds on Saltillo.

I have had the Annual Lancaster County Road and Bridge Hearing on November 7, 2017 circled on my calendar since you informed me of the meeting several months ago. However, I will be out of town on November 7th and unable to attend this meeting. Thank you for accepting written testimony to be read into the formal record.

My wife Julie and I have lived at 12233 W Pioneers Boulevard in Lancaster County since 1975. Our address is 1 1/2 miles west of the bridge located just west of SW 98th Street and West Pioneers Blvd which has been closed since the fall of 2015. West Pioneers Blvd is paved east of SW 98th Street. Thus, prior to the bridge closing, we had just 1 3/4 miles of lightly traveled gravel road before reaching pavement.

With the bridge closed, to travel east towards Lincoln we now have 3 3/4 miles of gravel road via SW 112th and West Van Dorn. Acreage development in our area has increased significantly in recent years and traffic on West Van Dorn has increased accordingly. The bridge out at SW 98th and West Pioneers Blvd has added to increased traffic on West Van Dorn from SW 84th Street west to SW 140th Street. During commuting hours, West Van Dorn west of SW 84th Street is a dusty, unpleasant, and occasionally hazardous road to travel.

Quite a few years ago, West Van Dorn west of SW 84th was widened and I believe the crown of the road flattened. I believe this work was to prepare the road for paving. Paving has not taken place, and the road while wide, has very poor drainage when it rains. To summarize road conditions on West Van Dorn west of SW 84th street: When dry, excessive dust from traffic with often poor visibility; and when it rains, standing water, mud and pot holes.

Replacement of the bridge at 98th and West Pioneers Blvd would reduce traffic on West Van Dorn, thus providing some immediate improvement to conditions on West Van Dorn west of 84th Street. In the long run, West Van Dorn from SW 84th street to SW 140th street needs to be paved.



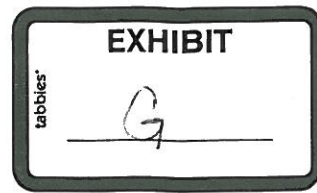
