It was resolved, by the Lancaster County Board of Commissioners that the property generally located at SW 114th Street and West Meinke Street, Lincoln, Lancaster County, Nebraska, legally described as:

A portion of vacated West Meinke Street adjacent to Block 3, in Unincorporated Village of Kramer, lying east of SW 114th Street to the northerly extension of the west line of lots 1-6 in said Block 3 all located in the NW ¼ of Section 9, T-7-N, R-5-E of the 6th Principal meridian, Lancaster County, Nebraska.

On the 30th day of March, 2016 at 2'oclock p.m., sale was held in the exit foyer of the Lancaster County Hall of Justice at 575 South 10th Street, Lincoln, Nebraska, conducted by Lancaster County Sheriff Deputy Sergeant Michael Novacek.
