

# Community Service




#### Community Service

In 2016-17 total <u>number of hours</u> of Community Service Ordered: Closed Successful 53,593 Closed Unsuccessful 45,229 Those that remain open 13,450

With the passage of LB259, Community Corrections will be addressing questions surrounding community service in lieu of fines. In particular, increasing the dollar amount credited for each hour of service. Currently the agency credits 10\$ per hour. However, other jurisdictions will allow up to 20\$ per hour. Our current rate of 10\$ per hour was set in 2003 and should be revisited to adjust for cost of living changes.

### Pretrial Release



We have worked closely with a local substance abuse evaluator to coordinate Region V funded substance use evaluations in the jail. In doing so, we are able to have the most bondable defendants utilizing this very limited resource (3 funded evaluations per week). This also allows the screening specialist to coordinate with the local tx providers in placements in an effort be the most efficient in accessing their resources. We currently have 53 open Pretrial Release files.

#### House Arrest



House arrest continues to be highly utilized. This may change if DUI statutes are addressed in the next legislative session.

The Smart Reentry grant will target the District Court population serving a sentence of at least 9-12 months.

Misdemeanor & Felony




#### **General Diversion**

Diversion cases consist of both misdemeanors and low level (first time) felony offenders. Since the transfer of General Diversion into Community Corrections, diversion programming has expanded and is being utilized for mental health cases, Military Veterans and most recently Intensive Supervision Diversion.

# Intensive Supervision Diversion




#### Intensive Supervision Diversion

#### Mental Health & Vets Diversion




In addition to supervising and managing the Mental Health Diversion Cases, the Mental Health Specialist works with all Pretrial Release participants with a major mental health diagnosis. There are currently 12 active Mental Health Diversion cases.

Vets Diversion cases are supervised by Pretrial/House Arrest caseworkers. We currently have two open Vets Diversion case open and one pending.

# Total Number of Participants in Programming FY2016-2017



### 2016-17 Department Accomplishments

Submitted grant application to the Bureau of Justice Assistance

Awarded 2 million dollar grant funded to develop a sentence conversion reentry program.

Relocated two office spaces into the 605 Building without closing the office.

Planned and implemented Intensive Supervision Diversion (ISD).

Completed the Planning for 24/7.

Collected 1.7 million dollars in reimbursements and fees.
