This Amendment is hereby entered into by and between Graybar Electric Company, 1370 Valley Vista Drive Suite, Diamondbar, CA 91765 (hereinafter "Contractor") and the City of Lincoln and Lancaster County (hereinafter "Owners"), for the purpose of amending the Contract dated June 19, 2015 executed under City Executive Order No. 88357, and County Contract C-15-0228, dated May 26, 2016 for Telecommunications Supplies and Accessories, County of Los Angeles, California, Master Agreement No. MA-IS-1540125, which is made a part of this amendment by this reference.

WHEREAS, the original term of the Contract is June 19, 2015 through December 31, 2015, with the option to renew for four (4) additional one (1) year terms upon written mutual consent by all parties; and

WHEREAS, the Contract was amended by City Executive Order No. 88957, executed by the City on January 7, 2016, and by County Contract C-16-0013 executed by the County Board on January 5, 2016, to renew the Contract for an additional one (1) year term from January 1, 2016 through December 31, 2016; and

WHEREAS, the Contract was amended by City Executive Order No. 90327, executed by the City on February 2, 2017, and by County Contract C-17-0031 executed by the County Board on January 31, 2017, to renew the Contract for an additional one (1) year term from January 1, 2017 through December 31, 2017; and

WHEREAS, the parties hereby renew the Contract for an additional one (1) year term beginning January 1, 2018 through December 31, 2019; and

WHEREAS, the expenditures for the City of Lincoln for the term of this renewal shall not exceed \$120,000.00 without approval by the City of Lincoln; and

WHEREAS, the expenditures for Lancaster County for the term of this renewal shall not exceed \$20,000.00 without approval by the Lancaster County Board; and

NOW, THEREFORE, IN CONSIDERATION of the mutual covenants contained in the Contract under City Executive Order No. 88357 and County Contract C-15-0228, all amendments thereto, and as stated herein, the parties agree as follows:

- 1) The parties hereby renew the Contract for an additional one (1) year term beginning January 1, 2018 through December 31, 2019.
- 2) The expenditures for the City of Lincoln for the term of this renewal shall not exceed \$120,000.00 without approval by the City of Lincoln.
- 3) The expenditures for Lancaster County for the term of this renewal shall not exceed \$20,000.00 without approval by the Lancaster County Board.
- 4) All other terms of the Contract, not in conflict with this Amendment, shall remain in force and effect.

The Parties do hereby agree to all the terms and conditions of this Amendment. This Amendment shall be binding upon the parties, their heirs, administrators, executors, legal and personal representatives, successors, and assigns.
