Box 24148, Omaha, NE 68124 (hereinafter "Contractor") and Lancaster County, (hereinafter "County"), for the purpose of amending the Contract dated May 24, 2016, under County Contract No. C-16-0238, for Annual Requirements for Employment and Volunteer Background Investigation Services, Bid No. 13-260, which is made a part hereof by this reference.

WHEREAS, the original term of the Contract is May 24, 2016 through October 17, 2016, with the option to renew for one (1) additional one (1) year renewal, upon written mutual consent of both parties; and

WHEREAS, the Contract was approved by County Contract No. C-16-0576 on October 4, 2016 for an additional one (1) year term beginning October 18, 2016 through October 17, 2017; and

WHEREAS, the Contract was approved by County Contract No. C-17-0800 on October 10, 2017 to extend the contract for an additional three (3) month period beginning October 18, 2017 through January 17, 2018; and

WHEREAS, the parties hereby extend the Contract from January 18, 2018 through April 17, 2018; and

WHEREAS, the estimated expenditures for Lancaster County, Budget & Fiscal for the term of this renewal shall not exceed \$1,100.00 without approval by the Lancaster County Board of Commissioners; and

NOW, THEREFORE, IN CONSIDERATION of the mutual covenants contained in County Contract No. C-16-0238, and stated herein the parties agree as follows:

- 1) The parties hereby extend the Contract from January 18, 2018 through April 17, 2018.
- 2) The estimated expenditures for Lancaster County, Budget & Fiscal for the term of this renewal shall not exceed \$1,100.00 without approval by the Lancaster County Board of Commissioners.
- 3) All other terms of the Contract, not in conflict with this Amendment, shall remain in full force and effect.

The Parties do hereby agree to all the terms and conditions of this Amendment. This Amendment shall be binding upon the parties, their heirs, administrators, executors, legal and personal representatives, successors, and assigns.
