WHEREAS, the parties hereby amend the Contract to increase the County's maximum expenditures by \$18,900.00 for the remainder of the current term; and

WHEREAS, the revised contract total with the expenditure increase for Lancaster County is estimated to be \$26,500.00 and

NOW, THEREFORE, IN CONSIDERATION of the mutual covenants contained in County Contract C-14-0328 and stated herein the parties agree as follows:

- 1) The parties hereby amend the Contract to increase Lancaster County's maximum expenditures by \$18,900.00 for the remainder of the current term.
- 2) The revised contract total with the expenditure increase for Lancaster County is estimated to be \$26,500.00
- 3) All other terms of the Contract, not in conflict with this Amendment, shall remain in full force and effect.

The Parties do hereby agree to all the terms and conditions of this Amendment. This Amendment shall be binding upon the parties, their heirs, administrators, executors, legal and personal representatives, successors, and assigns.


