Lancaster County Election Commissioner Canvassing Board Minutes Norris School District Special Bond Election November 14, 2017

The Canvassing Board for the November 14, 2014, Norris School Bond Special Bond Election convened in the conference room of the Lancaster County Election Commissioner's Office on Wednesday, November 15, 2017 at 1:00 p.m. Members serving on the board are Nancy Noren and Judy Garlock.

Election Commissioner David Shively called the Board to order, welcomed the members, and thanked them for serving. Mr. Shively also recognized Chief Deputy Election Commissioner Maura Kelly.

The Commissioner commented that per state law, this election was conducted entirely by mail. He stated that it was a smooth process. The turnout for the election was 45.38%

Shively then reviewed with the board a report of the election. (Attachment "B").

A total of 6,646 ballots were mailed to voters of the Norris School District. A total of 3,164 were returned for counting. A total of 10 ballots were rejected. Therefore, a total of 3,154 ballots were eligible to be counted for this election.

Commissioner Shively also shared with the Board the report of the Lancaster County Counting Board for this election provided by Chief Deputy Kelly (Attachment "C").

The Election Commissioner presented the Final Results document (Attachment "A") to the board.

Judy Garlock moved to certify the results of the November 15, 2017 Norris School District 160 Special Bond Election based on the Final Results document (Attachment "A"). Nancy Noren seconded the motion. The motion passed unanimously.

Nancy Noren moved to adjourn the Canvassing Board at 1:10 p.m. on November 15, 2017. Judy Garlock seconded the motion. The motion passed unanimously.
