This Amendment is hereby entered into by and between Blackburn Manufacturing Company, PO Box 86, 908 West Hwy 275, Neligh, NE 68756 (hereinafter "Contractor") and the City of Lincoln and Lancaster County (hereinafter "Owners"), for the purpose of amending the Contract dated April 17, 2017 executed under City Directorial Order No. 16910, and County Contract C-17-0260, dated April 11, 2017 for Annual Supply - Vinyl Locator Flags, Quote No. 5562, which is made a part of this amendment by this reference.

WHEREAS, the original term of the Contract is April 17, 2017 through April 16, 2018, with the option to renew for three (3) additional one (1) year terms upon written mutual consent by all parties; and

WHEREAS, the parties hereby renew the Contract for an additional one (1) year term beginning April 17, 2018 through April 16, 2019; and

WHEREAS, the expenditures for the City of Lincoln for the term of this renewal shall not exceed \$14,800.00 without approval by the City of Lincoln; and

WHEREAS, the expenditures for Lancaster County for the term of this renewal shall not exceed \$500.00 without approval by the Lancaster County Board; and

NOW, THEREFORE, IN CONSIDERATION of the mutual covenants contained in the Contract under City Directorial Order No. 16910 and County Contract C-17-0260, all amendments thereto, and as stated herein, the parties agree as follows:

- 1) The parties hereby renew the Contract for an additional one (1) year term beginning April 17, 2018 through April 16, 2019.
- 2) The expenditures for the City of Lincoln for the term of this renewal shall not exceed \$14,800.00 without approval by the City of Lincoln.
- 3) The expenditures for Lancaster County for the term of this renewal shall not exceed \$500.00 without approval by the Lancaster County Board.
- 4) All other terms of the Contract, not in conflict with this Amendment, shall remain in force and effect.

The Parties do hereby agree to all the terms and conditions of this Amendment. This Amendment shall be binding upon the parties, their heirs, administrators, executors, legal and personal representatives, successors, and assigns.
