Bryn Mawr Ave., Suite 900, Chicago, IL 60631 (hereinafter "Contractor") and Lancaster County and the City of Lincoln-Lancaster County Public Building Commission, (hereinafter "Owners"), for the purpose of amending the Contract dated September 22, 2015, executed under County Contract C-15-0500, and executed by the City of Lincoln-Lancaster County Public Building Commission, on September 22, 2015, for Maintenance, Repair and Operations (MRO) Supplies & Related Services, Region 4 and TCPN (National IPA) Solicitation No. 14-21/Contract No. R142103, which is made a part hereof by this reference.

WHEREAS, the original term of the Contract is September 22, 2015 through March 31, 2018, with the option to renew for an additional two (2) year term upon written mutual consent of both parties; and

WHEREAS, the Lead Contract will expire in March 31, 2019, completing the fourth year of a five-year term Contract; and

WHEREAS, the parties hereby renew the Contract for an additional one (1) year term beginning April 1, 2018 through March 31, 2019; and

WHEREAS, the expenditures for Lancaster County for the term of this renewal shall not exceed \$25,000.00 without approval by the Lancaster County Board of Commissioners; and

WHEREAS, the expenditures for the City of Lincoln-Lancaster County Public Building Commission for the term of this renewal shall not exceed \$2,000.00 without approval by the Public Building Commission; and

NOW, THEREFORE, IN CONSIDERATION of the mutual covenants contained in the Contract, under County Contract C-15-0500, and the City of Lincoln-Lancaster County Public Building Commission Contract dated September 22, 2015, and stated herein the parties agree as follows:

- 1) The Lead Contract will expire in March 31, 2019, completing the fourth year of a five-year term Contract
- 2) The parties hereby renew the Contract for an additional one (1) year term beginning April 1, 2018 through March 31, 2019.
- 3) The expenditures for Lancaster County for the term of this renewal shall not exceed \$25,000.00 without approval by the Lancaster County Board of Commissioners.
- 4) The expenditures for the City of Lincoln-Lancaster County Public Building Commission for the term of this renewal shall not exceed \$2,000.00 without approval by the Public Building Commission.

5) All other terms of the Contract, not in conflict with this Amendment, shall remain in full force and effect.

The Parties do hereby agree to all the terms and conditions of this Amendment. This Amendment shall be binding upon the parties, their heirs, administrators, executors, legal and personal representatives, successors, and assigns.


