

RELEASE IN FULL OF ALL CLAIMS

FOR AND IN CONSIDERATION of the payment of \$1,015.77, Kenneth C. Cook and Kathy L. Havlicek-Cook, (together, "Releasors"), do forever hereby release, acquit and discharge fully and forever the County of Lancaster, a political subdivision of the State of Nebraska and self-insurer, and its officers, agents, employees, successors and assigns, and all persons, firms and corporations ("Releasees") of and from any and all actions, causes of action, claims, demands, damages, costs, loss of service, loss of contribution, expenses and compensation now arising or which, whether known or unknown, hereafter may arise in its favor on account of any and all injuries incurred by said Releasors for the following incident:

1. An incident resulting in damage to property located generally at 1634 Prospect Street, Lincoln, Nebraska, 68506, and legally described as, BURRS (C C) SUBDIVISION, BLOCK 7, Lot 13, Lincoln, Nebraska, that occurred on November 8, 2017, a claim regarding which incident was submitted to the County of Lancaster by Kenneth Cook by a letter dated December 23, 2017, and received by the Clerk of the County of Lancaster on December 28, 2017.

Releasors hereby agree that they will reimburse any applicable insurance companies for any and all claims, demands, and expenses arising out of the incidents described above unless negotiated otherwise.

The Releasors further hereby agree to hold harmless the County of Lancaster, its officers, agents, employees, successors and assigns, for any and all insurance claims hereafter that may arise.

The Releasors do hereby declare and represent that in making this Release it is understood and agreed that they rely wholly upon their knowledge of the nature, extent and duration of said injuries and damages and the amount of the expenses and losses arising on account thereof and incident thereto; that they have not been influenced to any extent whatsoever

in making this Release and settlement hereby set forth or by any representations regarding any other matter, made by the persons, firms, or corporations who hereby are released or by any person or persons representing them or any of them.

The Releasors further state and agree:

1. That the settlement set forth in these presents is the compromise of a disputed claim and the payments made do not constitute and are not to be construed as an admission of liability on the part of any of the Releasees by whom liability, if any, is and has been expressly denied.
2. That this Release contains the entire agreement between the parties hereto and the terms hereof are contractual and not a mere recital and all representations set forth in the Release are relied upon by the Releasors and the Releasees.
3. That the Releasors are now and continuously since a date prior to November 8, 2017, have been more than 19 years of age.

The Releasors further state that they have read carefully the foregoing Release and know the contents thereof and the execution and delivery of the same is their own free act and deed.


