



This letter is regarding a request for a Special Events Permit from Scott Ash with the Nebraska Sports Council to hold a "Comhusker State Games Gravel Grinder" on roads maintained by Lancaster County. The race will take place on July 28, 2018, between the hours of 5:00 am and 4:00 pm and will include approximately 90 participants. The event will start and finish at the Backswing Brewing Company located at 500 W. South Street #8 in Lincoln. Participants will use the Jamaica North and Homestead Trail first before exiting onto roads maintained by Lancaster County. The Gravel Grinder has three different courses with various lengths. Participants will be instructed to obey all traffic laws

In examining the application for the "Cornhusker State Games Gravel Grinder" we recommend the following:

- 1) Prior to the event, the organizer must review the course to determine potential problems that could endanger runners and equipment. The organizer is responsible for noting these problems to the participants, and if severe enough, shall cancel the race.
- 2) Crowd control and spectator parking must be addressed. Adequate parking, restrooms, and spectator space must be provided to avoid parking and spectator spill over onto the road and assure safe conditions. Parking and other associated facilities shall be located off highway right of way, unless established vehicle parking areas, such as park and ride lots, are available.
- 3) Event organizers are responsible for clean-up of the race course after the event. This includes removal of water bottles, food bags, and other race litter along the course.

The Lancaster County Sheriff's Office has no objections to this permit if Mr. Ash follows the listed suggestions.

- 3. It appears that there are areas of event route which require traveling along several dirt roads. To protect these dirt roads from excessive rutting damage due to rainfall, motorized vehicles will not be allowed on the dirt roads if they become muddy.
- 4. The following roadway and/or drainage projects may have an impact on event routes:
 - a. There are drainage pipe replacement projects scheduled to be under construction this summer along event routes which will require road closings (closing dates not yet determined). The culvert project locations are as follows:
 - Culvert O-46, on West Rokeby Road just east of South 1st Street; and Culvert O-205, on South 1st Street approximately 50 feet north of West Rokeby Road.
 - Culvert T-155, on SW 2nd Street just north of West Wittstruck Road.
 - b. Pavement striping is scheduled on South Folsom Street from West Old Cheney Road north to West Pioneers Boulevard; the estimated completion date for this work is June 30th.
 - c. Pavement striping is scheduled on SW 100th Street from West Roca Road north to West Denton Road; the estimated completion date for this work is June 30th.
 - d. Crack sealing is scheduled on SW 100th Street from West Roca Road north to West Denton Road; this work is not scheduled to begin until October 1, 2018.

- e. Resurfacing is scheduled on W Old Cheney Road from SW 12th Street east to Highway 77; the estimated completion date for this work is July 9th.
- f. Resurfacing is scheduled on West Saltillo Road from SW 12th Street east to Highway 77; the estimated dates for work on this project are July 16 through August 6.
- g. Resurfacing is scheduled on West Sprague Road from SW 14th Street east to Highway 77; the estimated dates for work on this project are July 30 through August 20.
- 5. Permits and other regulations and/or permissions of use may be required for areas of this event within the jurisdiction of the Nebraska Department of Transportation, City of Lincoln Public Works Department, Village of Roca, State Lakes Area Authorities and/or Parks Department and neighboring Counties and Villages.
- 6. Suggest this application be reviewed by applicable law enforcement agencies for safety precautions and reviewed by applicable Attorney's offices for insurance compliance.
