SUPPLEMENTING APPROPRIATIONS )  
FOR PREVIOUSLY ADOPTED BUDGET ) RESOLUTION NO. R-18-0031  
FOR THE WORKERS COMPENSATION )  
LOSS FUND, MENTAL HEALTH FUND )  
AND PROPERTY MANAGEMENT FUND)

WHEREAS, Neb. Rev. Stat. §13-511 (2016 Cum. Supp.) provides that:

Unless otherwise provided by law, whenever during the current fiscal year or biennial period it becomes apparent to a governing body that (a) there are circumstances which could not reasonably have been anticipated at the time the budget for the current year or biennial period was adopted, (b) the budget adopted violated sections 13-518 to 13-522, such that the revenue of the current fiscal year or biennial period for any fund thereof will be insufficient, additional expenses will be necessarily incurred, or there is a need to reduce the budget requirements to comply with sections 13-518 to 13-522, or (c) the governing body has been notified by the auditor of a mathematical or accounting error or noncompliance with the Nebraska Budget Act, such governing body may propose to revise the previously adopted budget statement and shall conduct a public hearing on such proposal. The public hearing requirement shall not apply to emergency expenditures pursuant to section 81-829.51.

WHEREAS, during the current fiscal year circumstances have arisen which could not reasonably have been anticipated at the time the budget was adopted;

WHEREAS, said circumstances include a settlement in the Workers Compensation Loss Fund, a new electronic health records system (Credible software), an increase in employee health insurance and an increase in psychologist and psychiatrist costs in the Mental Health Fund, and increased utility costs at Trabert Hall due to timing of the sale of the building in the Property Management Fund;

WHEREAS, careful study has been made of appropriations needed for necessary expenditures for the remainder of the fiscal year;

WHEREAS, notice of the place and time of a public hearing regarding increasing the appropriations to the Workers Compensation Loss Fund in the amount of \$150,000, to the Mental Health Fund in the amount of \$175,951 and to the Property Management Fund in the

amount of \$60,000 was published according to Neb. Rev. Stat. §13-511(2); and

WHEREAS, on May ~~2222~~, 2018, at 9:00 a.m. in the Commissioners Hearing Room, First Floor, County-City Building, a public hearing regarding the additional appropriations was held in conformance with said notice requirements;

NOW, THEREFORE, BE IT RESOLVED, by the Board of County Commissioners of Lancaster County, Nebraska, that additional appropriations of \$150,000 for the Workers Compensation Fund, \$175,951 for the Mental Health Fund, and \$60,000 for the Property Management Fund are hereby granted.
