

**AMENDMENT TO CONTRACT

This Amendment is hereby entered into by and between Nebraska Department of Administrative Services, (hereinafter "Contractor") and the City of Lincoln and Lancaster County (hereinafter "Owners"), for the purpose of amending the Contract dated July 16, 2014 executed under City Resolution No. A-88373, and County Contract C-14-0385, dated July 29, 2014 for Printing and Mailing Services and Quick Copy Services, Interlocal Agreement, which is made a part of this amendment by this reference.

WHEREAS, the original term of the Contract is July 16, 2014 through July 15, 2018, with the option to renew for one (1) additional four (4) year term upon written mutual consent by all parties; and

WHEREAS, the parties hereby renew the Contract for an additional four (4) year term beginning July 16, 2018 through July 15, 2022; and

WHEREAS, the expenditures for the City of Lincoln Departments for the term of this renewal shall not exceed \$22,000.00 without approval by the City of Lincoln; and

WHEREAS, the expenditures for Lancaster County Departments for the term of this renewal shall not exceed \$22,000.00 without approval by the Lancaster County Board; and

NOW, THEREFORE, IN CONSIDERATION of the mutual covenants contained in the Contract under City Resolution No. A-88373 and County Contract C-14-0385, all amendments thereto, and as stated herein, the parties agree as follows:

- 1) The parties hereby renew the Contract for an additional four (4) year term beginning July 16, 2018 through July 15, 2022.
- 2) The expenditures for the City of Lincoln Departments for the term of this renewal shall not exceed \$22,000.00 without approval by the City of Lincoln.
- 3) The expenditures for Lancaster County Departments for the term of this renewal shall not exceed \$22,000.00 without approval by the Lancaster County Board.
- 4) All other terms of the Contract, not in conflict with this Amendment, shall remain in force and effect.

The Parties do hereby agree to all the terms and conditions of this Amendment. This Amendment shall be binding upon the parties, their heirs, administrators, executors, legal and personal representatives, successors, and assigns.


