This Amendment is hereby entered into by and between TCA Outdoor Power, 6220 S. 57th St., Lincoln, NE 68516 (hereinafter "Contractor") and the City of Lincoln and Lancaster County (hereinafter "Owners"), for the purpose of amending the Contract dated September 23, 2015 executed under City Executive Order No. 88653, and County Contract C-15-0465, dated September 8, 2015 for Annual Supply - Lubricants, Bid No. 15-133, which is made a part of this amendment by this reference.

WHEREAS, the original term of the Contract is September 1, 2015 through August 31, 2016, with the option to renew for three (3) additional one (1) year terms upon written mutual consent by all parties; and

WHEREAS, the Contract was amended by City Executive Order No. 89731, executed by the City on August 23, 2016, and by County Contact No. C-16-0521, executed by the County Board on September 6, 2016, to renew the Contract for an additional one (1) year term from September 1, 2016 through August 31, 2017; and

WHEREAS, the Contract was amended by City Executive Order No. 91034, executed by the City on September 7, 2017, and by County Contact No. C-17-0704, executed by the County Board on August 29, 2017, to renew the Contract for an additional one (1) year term from September 1, 2017 through August 31, 2018; and

WHEREAS, the parties hereby renew the Contract for an additional one (1) year term beginning September 1, 2018 through August 31, 2019; and

WHEREAS, the expenditures for the City of Lincoln for the term of this renewal shall not exceed \$20,000.00 without approval by the City of Lincoln; and

WHEREAS, the expenditures for Lancaster County for the term of this renewal shall not exceed \$1,000.00 without approval by the Lancaster County Board; and

NOW, THEREFORE, IN CONSIDERATION of the mutual covenants contained in the Contract under City Executive Order No. 88653 and County Contract C-15-0465, all amendments thereto, and as stated herein, the parties agree as follows:

- 1) The parties hereby renew the Contract for an additional one (1) year term beginning September 1, 2018 through August 31, 2019.
- 2) The expenditures for the City of Lincoln for the term of this renewal shall not exceed \$20,000.00 without approval by the City of Lincoln.

- 4) The expenditures for Lancaster County for the term of this renewal shall not exceed \$1,000.00 without approval by the Lancaster County Board.
- 5) All other terms of the Contract, not in conflict with this Amendment, shall remain in force and effect.

The Parties do hereby agree to all the terms and conditions of this Amendment. This Amendment shall be binding upon the parties, their heirs, administrators, executors, legal and personal representatives, successors, and assigns.


