This Amendment is hereby entered into by and between NMC, Inc., 401 NW 56th Street, Lincoln, NE 68528 (hereinafter "Contractor") and the City of Lincoln and Lancaster County (hereinafter "Owners"), for the purpose of amending the Contract dated August 28, 2015 executed under City Directorial Order No. 13697, and County Contract C-15-0407, dated August 25, 2015 for Annual Supply - Caterpillar Filters, SS-24, which is made a part of this amendment by this reference.

WHEREAS, the original term of the Contract is August 28, 2015 through August 27, 2016, with the option to renew for three (3) additional one (1) year terms upon written mutual consent by all parties; and

WHEREAS, the Contract was amended by City Directorial Order No. 15643, executed by the City on September 2, 2016, and by County Contract C-16-0501 executed by the County Board on August 30, 2016, to renew the contract for an additional one (1) year term from August 28, 2016 through August 27, 2017;

WHEREAS, the Contract was amended by City Directorial Order No. 17641, executed by the City on August 15, 2017, and by County Contract C-17-0632 executed by the County Board on August 15, 2017, to renew the contract for an additional one (1) year term from August 28, 2017 through August 27, 2018;

WHEREAS, the parties hereby renew the Contract for an additional one (1) year term beginning August 28, 2018 through August 27, 2019; and

WHEREAS, the parties hereby amend the contract to include a Price Discount of 20% on all genuine CAT filters, per Attachment A; and

WHEREAS, the expenditures for the City of Lincoln Public Works and Utilities Department for the term of this renewal shall not exceed \$8,500.00 without approval by the City of Lincoln; and

WHEREAS, the expenditures for Lancaster County Engineering Department for the term of this renewal shall not exceed \$23,200.00 without approval by the Lancaster County Board; and

NOW, THEREFORE, IN CONSIDERATION of the mutual covenants contained in the Contract under City D.O. 13697 and County Contract C-15-0407, all amendments thereto, and as stated herein, the parties agree as follows:

- 1) The parties hereby renew the Contract for an additional one (1) year term beginning August 28, 2018 through August 27, 2019.
- 2) The parties hereby amend the contract to include a Price Discount of 20% on all genuine CAT filters, per Attachment A.
- 3) The expenditures for the City of Lincoln Public Works and Utilities Department for the term of this renewal shall not exceed \$8,500.00 without approval by the City of Lincoln.
- 4) The expenditures for Lancaster County Engineering Department for the term of this renewal shall not exceed \$23,200.00 without approval by the Lancaster County Board.
- 5) All other terms of the Contract, not in conflict with this Amendment, shall remain in force and effect.

The Parties do hereby agree to all the terms and conditions of this Amendment. This Amendment shall be binding upon the parties, their heirs, administrators, executors, legal and personal representatives, successors, and assigns.
