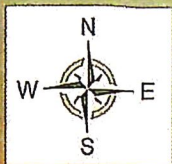

Under conditional uses Section 27.62.120 b it states that an Amusement license is permitted on a premises for no more than one event per calendar year. An event can be multiple days or weeks. And it should not be by number of events but a max number of days. Unless something has changed can you check into this.
